Counsel for the appellant contended that the appellant has not been treated in accordance with law/rules. The appellant has impugned notification dated 07.11.2013 against which he filed departmental appeal on $\frac{25.09.2013}{25.09.2013}$ which has not been responded within the statutory period of 90 days, hence the present appeal on 13.02.2014.

The learned Government Pleader while assisting the tribunal was of the view that the instant appeal is against notification dated 07.11.2013, though name of the appellant has not been included in the SET General seniority list against which departmental appeal has been filed by the appellant but there is no prayer for promotion in that departmental appeal. So the Departmental appeal is not inline with instant appeal. He further stated that this tribunal has got no jurisdiction to issue direction for promotion of the appellant. He requested that the instant appeal may kindly be dismissed.

Points raised at the Bar need consideration. The appeal is admitted for regular hearing subject to all legal objections. The appellant is directed to deposit the security amount and process fee within 10 days. Thereafter, Notice be issued to the respondents for submission of written reply.
