APPEAL UNDER SECTION 4 OF SERVICE TRIBUNAL ACT, 1974, AGAINST THE ORDER 11/01/2022 BEARING NO. 552/EC, PASSED BY RESPONDENT NO.2 BY WHICH THE REPRESENTATION TO WORTHY RESPONDENT NO. 01 FILED BY THE APPELLANT FOR CONFIRMATION AND PROMOTION TO LIST "E" WAS NOT CONSIDERED AND THE APPELLANTS WERE DEPRIVED FROM DUE CONFIRMATION FROM THE DATE OF APPOINTMENT AND PROMOTION ACCORDING TO THE PRESCRIBED RULES WITHOUT ANY LAWFUL JUSTIFICATION.

PRAYER:

On accepting this service appeal, the impugned order dated 11/01/2022 bearing no. 552/EC, may graciously be set aside by declaring it illegal, unlawful, without authority, based on mala fide, discriminatory, void ab-initio and thus not sustainable in the eyes of law and appellants may please be confirmed/regularized from the date of appointment and be promoted to list "E" also be adjusted in seniority with his colleagues/batch mates.

Respectfully Sheweth;

FACTS:-

1. That the appellants were appointed as ASI in police department against "SHUHADA" quota vide appointment order dated: 20/01/2016.
(APPOINTMENT ORDER IS ATTACHED AS ANNEXURE- A).
2. That The appellants had qualified the basic training of directly recruited ASI and had also successfully completed A,B,C, and D courses and had also fulfilled the criteria envisaged in standing order No. 10/2014.
3. That the appellants after successful completion of probation period were due for confirmation as ASI, with effect from date of appointment i.e. 20/01/2016 and promotion to list "E" with effect from 30/11/2020 from the date of completion of probation period, but respondent reluctant to pass proper order, hence appellants filed an application to high-ups on 17/09/2021 for the same, which was not considered.

4. That being ignored by the worthy respondent No.2 the appellant had filed an appeal/ application to worthy respondent no.1 on dated 29/12/2021 through proper channel which was declined by the worthy respondent No.2 vide order dated 11/01/2022 bearing no. 552/EC, but not properly communicated to appellant and they came to know regarding the same on 25/01/2022.

5. That the appellants feeling aggrieved from the impugned order having no alternate remedy except the instant appeal on the following grounds inter-alia.

GROUND:-

- A. That the appellants after successful completion of probation period are eligible for confirmation as ASI, with effect from date of appointment i.e. 20/01/2016 and promotion to list "E" with effect from 30/11/2020 from the date of completion of probation period as per law.
- B. That similarly recruited ASIs on SHUHADA quota in other regions like Mardan and D I Khan region have been confirmed from the date of appointment and promoted to list 'E' from the date of completion of probation period vide notification No(s). 7057-60/ES dated 13/11/2020 and 128/ES dated 07/01/2021 respectively.

- C. That the order dated 11/01/2022, is discriminatory in nature as all the similarly recruited ASIs are being confirmed and promoted to list "E", similarly the order dated 11/01/2022 is clearly the violative of the article 27 of the constitution of Islamic republic of Pakistan which safeguard against discrimination in services.
- D. That the only ground for not considering the application dated 17/09/2021 and appeal/ application dated 29/12/2021 is that the appellants are not regularized which is the duty of the respondents after completion of probation period hence the order dated 11/01/2022 is liable to be set aside and appellants are entitled for the benefits which they are legally entitled.
- E. That while passing impugned order the respondents had not taken into consideration the guidelines issued by the regional police officer D I Khan whereby all the similarly recruited ASIs are considered as regular as well as all the similarly recruited ASIs are brought on list "E", however, the Regional Police Officer totally ignored those instructions and passed the impugned order which is against the law and facts thus not sustainable in the eyes of law hence liable to be dismissed.

- F. That the impugned order was passed by the respondent No. 2, Kohatal though the appeal was submitted before the respondent No. 1, which is without jurisdiction and authority which clearly shows the malafide of respondent No. 2, thus the same is liable to be set aside.


- G. That as per Constitution of the Islamic Republic of Pakistan, 1973, it is very much transparent, no order shall be passed which is against the rules and prohibits the arbitrary discretion as is evidenced by the impugned order passed by the Regional Police Officer, Kohat in the appeal before Inspector General of Police Khyber Pakhtunkhwa. Also, the law provides protection for violation of fundamental rights particularly in service matter but both these aspects has been ignored while passing the impugned order.
- H. That an unjust has been done with the appellant by not giving ample opportunity to be heard in person nor properly enquired by following the prescribed rules as per **Police Rules 1975 (amended 2014)** in application/ appeal/ representation filed by the appellants to worthy respondents.
- I. That fact of being denied from due regularization and promotion has miserably impacted the appellants overall professional career.
- J. That the impugned order is being not in accordance with law and the principles of justice, thus liable to be set aside to be set aside.
- K. That appellants are waiting for regularization and promotion to list "E" amongst officers placed on List 'D'.
- L. That the colleagues of appellants are presently serving in the police department as confirm ASIs from the date of their appointment and had promoted to list E.

M. That the regularization and promotion of officials/officers is an inherent right which comes to end only on his death and/or attainment of superannuation. Hence, this right appellants cannot be taken away or suppressed.


PRAYER:

On accepting this service appeal, the impugned order dated 11/01/2022 bearing no. 552/EC, may graciously be set aside by declaring it illegal, unlawful, without authority, based on mala fide, discriminatory, void ab-initio and thus not sustainable in the eyes of law and appellants may please be confirmed/regularized from the date of appointment and be promoted to list "E" also be adjusted in seniority with his colleagues/batch mats.


Any other relief not specifically prayed for but deems appropriate in the circumstances of the case may also be granted.

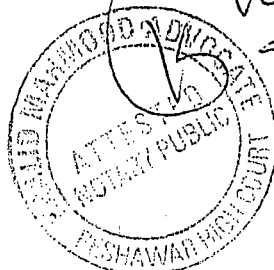





1. GUIDELINES SOUGHT BY REGIONAL POLICE OFFICER DIKHAN REGION

The Regional Police Officer, D.I.Khan Region has intimated that on the creation of supernumerary post of ASIs vide Finance Department letter No. BO-III/FD/7-1/2015-16 dated 26.08.2015 and approval of CPO letter No. 4016-22/II-III, dated 31.12.2015, the wards of Shuhada have been appointed/absorbed as PASIs subject to the condition that with gradual retirement of ASIs having permanent/regular post, the senior most of the supernumerary post will be adjusted against the post falling vacant. He has requested that his office may be granted on the following points, so that, to avoid any legal complication in future:-

- i. As to whether their names be placed at non List "E" or otherwise.
- ii. If an ASI of regular posts is not retired on pension during not three years, whether they still will be on non List "E" or otherwise!
- iii. Whether their names will be considered from the date of appointment for confirmation or otherwise.
- iv. Their probation period will be considered from the date of appointment or from the date of adjustment on regular post.

DECISION

The committee declared that these posts will be considered as regular posts. The names of PASIs recruited against these posts will be brought on List "E" according to standard procedure in vogue.

II. APPLICATION OF SUB-INSPECTOR EBAD WAZIR NO. 89/D

He stated that he was charged in case FIR No. 594, dated 10.09.2013 u/s 506/186 PPC PS Hangu city, he was tried by the Court of Senior Civil Judge acquitted him after trial when no proof was found against him. Departmental enquiry was initiated against him wherein he was exonerated and nothing was proved against him. He has completed his physical Upper Course training and has passed Drill and Fire exam. After being bailed out from Central Jail by the Honorable Court he was allowed by the Worthy Cominandant PTC Hangu to appear in the remaining examination and he took examination from 14th September 2013 to 16th September 2013. Later-on, in another session of Upper Course he gave an application for permission in taking exam of remaining papers missed due to absence because of arrest. He was allowed conditionally for appearing in the Upper College Course. He took his examination, he passed his examination and exonerated from the enquiry and acquitted by the Honorable Court of Senior Civil Judge Hangu. He has requested that his Upper Course may kindly be considered and he has completed the course physically of long six months. His result may kindly be announced.

DECISION

The committee decided that when the applicant has been cleared from charges and acquitted during departmental proceedings he was allowed conditionally to sit in the exams.
