



Counsel for the appellant present. Preliminary arguments heard.

Appellant in the matter of appeal No. 606/15 earlier filed by him, was credited with judgment dated 16.01.2020. Accordingly his appeal was disposed of in the terms that departmental authority was directed to decide the departmental appeal within a period of three months and also to communicate him the order. It was observed that if the appellant was aggrieved then he will be at liberty to approach this Tribunal. This appeal has been instituted to get the benefits of the said liberty given to the appellant by earlier judgment referred above. The appellant has impugned the order of his compulsory retirement from service in BPS-12 instead of BPS-15 and also on the count of not taking action on his departmental appeal within the stipulated period of ninety days, therefore, the appeal is admitted to regular hearing, subject to all just and legal objections including limitation. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, the office shall submit the file with a report of non-compliance. File to come up for arguments on 16.11.2021 before the D.B.




