- 3. That respondent No. 03 issued final seniority list of DM dated 31.10.2019 and astonishingly placed the appellant junior to the respondent No. 04 which action is against the fact and law. (Copy of Seniority list of DM dated 31.10.2019 is attached as annexure.



PRELIMINARY OBJECTIONS.

- 1. That the appellant did not file any departmental appeal against the impugned promotion order and final Seniority List about correction. Hence the service appeal is not maintainable.
- 2. That the appellant has already been promoted to the post of SDM BPS-16 and took over charge happily without any hesitation. Hence the service appeal is not maintainable.
- 3. That the service appeal is wholly incompetent, misconceived and untenable.
- 4. That the service appeal is wrong, baseless and not maintainable, it shows no strong cause to be taken for adjudication, therefore, the same service appeal is liable to be rejected/dismissed.
- 5. That the service appeal is unjustifiable, baseless, false, frivolous and vexations. Hence the same is liable to be dismissed with the order of special compensatory cost in favour of respondents.
- 6. That no constitutional or legal right of the appellant has been violated, therefore, the appellant is not entitled to invoke the constitutional jurisdiction of this honourable Service Tribunal under Article 212 of the constitution of Pakistan.
- That the appellant has not come to the Court/Tribunal with clean hands. 7.
- 8. That the appellant has concealed the material facts from this Honourable Tribunal.
- That the appeal is bad for misjoinder and non-joinder of the necessary party. 9.
- That the appellant has filed the instant appeal just to pressurize the respondents. 10
- That the appellant has no cause of action to file the instant appeal. 11.
- That the appellant has been estopped by his own conduct to file the instant appeal. 12.
- That the instant appeal is not maintainable in the present form and also in the 13. present circumstances of the issue.

Facts:

- 1. That the para relates to the initial appointment of the appellant against the Primary school teacher (PST) post.
- 2. That the para relates to the promotion from DM (BPS-15) to SDM (BPS-16) of the appellant and private respondent No.4.
- 3. That the respondent No.3 issued tentative seniority list for inviting attention for seeking correction. The appellant did not file any appeal for correction of his seniority. Thus the final seniority was issued in April 2015, wherein the private respondent, named Inam Ullah was placed at S.No.123 while the present petitioner named Anwar Zeb was placed at S.No. 124. This final seniority list gained finality. Wherein the petitioner is admittedly junior to the private respondent No. 4. Then the respondent No.3 issued tentative seniority list in 2019 for inviting attention for seeking correction. This time the appellant also remained silent. Thus the undisputed final seniority list of DM was issued by respondent No.3, dated 31/10/2019. The seniority remained undisputed for about seven years. Thus it has gained finality. It is admitted fact that the petitioner is junior to the private respondent No.4. Final seniority list 2015 annexed as A.
- 4. That on the basis of this undisputed final seniority list, the respondent No.1 being competent authority has legally promoted the senior candidate, Private respondent No.4 vide order Endst: No.2741-47/File No.1 dated Peshawar the 25/02/2020. He was adjusted vide order EndstNo.1876-81 dated 27/02/2020 by District Education Officer (Male) Swabi. That the appellant has neither made any departmental appeal to the appellate authority against the impugned promotion order nor the final seniority list dated 31/10/2019. He directly filed the instant service appeal dated 21/07/2020, which is not maintainable. He has committed concealment of facts.
- 5. That the appellant did not submit/file any departmental appeal before respondent No.2. The document annexed as F at page 18 with the memo of appeal is without any diary and registry number. The signature of the appellant marked on memo of appeal and departmental appeal does not tally/match. It is a self planted document just for creation of his right illegally. It has been done just for fulfillment of formalities, which has no legal effect. Departmental appeal was not availed, so the appeal in the tribunal not maintainable Reliance is placed on PLJ 1991 Tr.c (Service) 153, 1992 PLC (C.S) 666, 1994 PLC (C.S) 1262 and 1994 PLC (C.S) 606. Thus the service appeal is not maintainable. Furthermore the respondent No.1 promoted appellant on his turn to the post of SDM BPS-16 vide order Endst: No.2619-24/File No.1/Promotion senior teachers (BPS-16) dated Peshawar the 08/12/2020. He was adjusted vide order Endst:No. 9444-49 dated 17/12/2020 by District Education Officer (Male) Swabi. The appellant has taken over charge happily without any hesitation. Thus admittedly, the appellant has not come to the Tribunal with clean hands. Notification dated 08/12/2020 and adjustment order dated 17/12/2020 are annexed as B &C.
- 6. That the appellant is not an aggrieved person at all, because he has been promoted to the post of SDM(BPS-16) and took over charge happily without any hesitation. The appellant has been estopped by his own conduct to file the instant appeal, thus has no cause of action to file the instant appeal and the appeal in hand is liable to be dismissed inter alia amongst the following grounds.

Grounds:

A. Incorrect, hence denied. The impugned order dated 25/02/2020 and 27/02/2020 of promoting the private respondent No.4, who is senior to the appellant is according the law, rules, facts, norms of natural justice and materials on record, hence

tenable in law. The appellant has been promoted to the post of SDM (BPS-16) and took over charge happily without any hesitation.

- B. Incorrect, hence denied. The appellant has been promoted to SDM (BPS-16) and took over charge happily without any hesitation. Thus the appellant has been treated by respondent department in accordance with law, rules, facts, policy on the subject noted above and Articles 4, 25 & 38 of the constitution Islamic Republic of Pakistan 1973.
- Let appellant has neither impugned the final seniority list nor DM to SDM promotion order anywhere. He did not file any departmental appeal. Thus the stance/plea of the appellant," that no chance of personal hearing was provided to the appellant while issuing the impugned order," is quite conjectural, contemptuous and ludicrous.
 - D. Incorrect, hence denied. The impugned order is legal because the senior colleague, private respondent No.4 was promoted to the post of SDM (BP16). The appellant has also been promoted to the post of SDM (BPS-16) and took over charge happily without any hesitation. Thus the appellant has estopped by his own conduct to file the instant appeal.
 - E. That the respondents seek permission to advance other grounds and proofs at the time of hearing the case.

In view of the above stated submissions, it is earnestly requested that the instant appeal may very graciously be dismissed with order of special compensatory cost in favour of department.
