PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL THE INACTION /OMISSION OF THE RESPONDENTS IN PROMOTING THE APPELLANT AS PSHT (BPS-15) FROM HER DUE DATE MAY BE DELCARE AS ILLEGAL, UNLAWFUL, AGAINST THE PROMOTION RULES AND NORMS OF JUSTICE AND THE RESPONDENTS MAY PLEASE BE DIRECTED TO CONSIDER THE APPELLANT FOR PROMOTION TO THE POST OF PSHT (BPS-15) FROM HER DUE DATE (MAY, 2013) BEING ELIGIBLE WITH ALL BACK AND CONSEQUENTIAL BENEFITS. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

**RESPECTFULLY SHEWETH:**

**FACTS:**


1. That the appellant was appointed as Trained PTC on 23.04.1998 by the competent authority. The appellant is a qualified teacher and performed his duties assigned to him with zeal and devotion and up to entire satisfaction of his superiors. All the entries made in the service book of the appellant. **Copy of Appointment order and Service Book, are attached as Annexure-A & B.**
2. That the department conducted DPC and the junior to the appellant was promoted to the post of BPS-14 and appellant was ignored, and then further conducted DPC for the promotion to the post PSHT BPS-15 but the appellant was not consider despite that the appellant is at the top of the Seniority list and the junior to the appellant was promoted vide order dated 13.05.2013 to the post of PSHT (BPS-15). The appellant then agitate matter, but no response was given to him by the department. **Copy of the promotion orders is attached as Annexure-C & D.**
3. That the appellant submitted his bio data in time for consideration for promotion being eligible and senior most and sent working paper to the respondent but astonishingly the appellant was not promoted by giving reasons that your record was damaged in flood of 2010 is ~~is~~ evident from the notification dated 31.12.2012. **Copy of the notification is attached as Annexure-E.**
4. That the appellant filed application time to time, thereafter, the appellant was promoted to the post SPST (BPS-14) vide order dated 26.08.2015 and some other colleagues of the appellant which are junior to the appellant were promoted to the PSHT (BPS-15) vide order dated 23.05.2015. **Copy of the orders are attached as Annexure-F & G.**
5. That thereafter, another promotion notification dated 1.02.2018 for promotion to the post of PSHT (BPS-15) was issued but the same was not available with the appellant may be requisition from the department, but again the appellant was deprived from promotion. Thereafter, the appellant filed departmental appeal against the illegal, inaction and omission of the respondents on 06.02.18 which was not responded within statutory period of 90 days. **Copy department appeal is attached as Annexure-H.**
6. That now the appellant comes to this august Tribunal on the following grounds amongst the others.

## GROUND:

- A. That not considering the appellant for promotion to the post PSHT despite having seniority/eligibility, qualification and not taking action is against the law, facts, norms of justice and material on record, therefore, not tenable in the eye of law.
- B. That the post of promotion for the appellant is availability since May, 2013 therefore, the appellant is legally entitled to be considered for promotion from his due date.
- C. That inaction and omission of respondent department, not to consider the appellant for promotion is against the spirit of section-9 of Civil Servants Act, 1973 and service rights duly protected under the Civil Servants laws.
- D. That the apex Court has already clearly held in case of Anita Turab (PLD-2013 Supreme Court Page No. 195) that matter of tenure, appointment, posting, transfer and promotion, of service could not be dealt with in an arbitrary manner but could only be sustained if it was in accordance with law. Whenever there was statutory provision or rules or regulation of government the matter of appointment of Civil Servants that must be followed honestly and scrupulously and discretionary must be exercised and structured, transparent and reasonable manner, thus the verdict of the Honorable Supreme Court fully favours the appellant's case.
- E. That as there is no any order regarding the stoppage of promotion of appellant, therefore, the appellant has legal vested rights to be considered for promotion from the date when post is available for him in his quota. (97-SCMR-1997-515).
- F. That the Honorable Apex Court is also given the verdict that every civil servant is the legal right to be dealt with in accordance with the law and rules under the which is legal service rights are protected. Thus the appellant has legal and genuine claim.
- G. that the appellant not granting promotion due to reason that the the record of the appellant is ruin in flood is lame excuse on the part of the department and it is not fault of the appellant.
- H. That the appellant was not treated according to law and rules.
- I. That the appellant has not been treated and accordance with the law and has been discriminated because his other colleagues and juniors to the appellant have been promoted on may, 2013, 15 and ignored the appellant despite of having seniority eligibility and post of availability.

- J. That according to fresh amendment the appellant has the right to promoted with his due date i.e when the junior to the appellant was promoted.
- K. That the appellant seeks permission to advance the other ground and proof at the time of hearing.

It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.

TERMS AND CONDITIONS

1. They will be govern by such rules and regulations as may be prescribed by the Government from time to time for the category of the Government Servant which they belong.
2. Their services will be liable to termination on one Month notice from either side. In case of resignation without notice one Month's Pay will be forfeited in lieu thereof.
3. They should join the post within one month of the issue of this notification.
4. Their inter seniority will be determined in accordance with the merit of Departmental Selection Committee.
5. Charge Report should be submitted to all concerned.
6. They shall be on probation for a period of two years and will have to pass Departmental Examination. In case a candidate fails to qualify the Departmental Examination she will be given one more chance. If she fail again, then her services will be terminated. On arrival/availability of trained teachers the services of Un-trd teachers occupies the post will be terminated.

8. Service Books of the teachers must be prepared complete in all respect before handing over charge.
9. The declaration of Assets should be obtained from them immediately and placed on record.
10. They are required to produce Health and Age Certificate from Medical Authorities concerned before taking over charge.
11. Charge should not be given to the overage candidates. Her case for age relaxation be sent to concern quarter.
12. Efforts for transfer before the completion of tenure will disqualify her from the service.
13. No T.A./D.A. is allowed.
