Learned counsel for the appellant argued that the appellant is aggrieved from the adverse remarks in his annual confidential report for the period 01.01.2020 to 27.08.2020 communicated to the appellant on 16.03.2021. He preferred departmental representation for expunction of adverse remarks. His departmental representation was, however, rejected vide order dated 13.07.2021, hence, the instant service appeal before the Service Tribunal was filed on 29.07.2021.


