PARTIAL SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE ORDER NO. 11778/E DATED 22-10-2022 WHEREBY THE PENALTY OF FORFEITURE OF THREE YEARS OF APPROVE D SERVICE WAS IMPOSED UPON THE APPELLANT AGAINST THE LAW, RULES AND FACTS AND IS LIABLE TO BE SET ASIDE.

<u>PRAYER:</u>

That on acceptance of this service appeal the order impugned may very kindly be set aside being void and against the law and rules and the service of the

Appellant be counted and all the consequential benefits also granted.

Respectfully Sheweth:

Facts:

- i. That the Appellant joined the Police Department back in the year 2009 and since then is regularly performing his duties to the best of his abilities with great zeal, honestly, efficiently and with punctuality.
- ii. That the Appellant has performed his duties to the utter satisfaction of the authorities and till date no complaint has ever been received against the Appellant.
- iii. That all of a sudden the Appellant was issued and Charge Sheet coupled with Statement of Allegations, wherein the allegation of absence was levelled against the Appellant, although the Appellant has never absented himself willfully and for every single absence a proper application was timely submitted. The Appellant submitted a proper reply the same and denied the allegations. Copies of the Charge Sheet and Statement of Allegations are enclosed as Annexure "A" and that of the reply is enclosed as Annexure "B", respectively.
- iv. That the Appellant submitted the relevant documents regarding his absence, which include

the medical certificates and an application regarding the issue of his biometric attendance, as the bio metric scanner would not recognize the thumb impression of the Appellant. Copies of the medical certificates and that of the application are enclosed as Annexure "C".

That to the utter surprise of the Appellant neither the reply was considered nor the relevant documents were paid any heed to the utter detriment of the Appellant and a farce inquiry was initiated against the Appellant.

- vi. That the inquiry was conducted with the predecided result and finding and the Appellant was never properly associated with the inquiry throughout.
- vii. That neither was Appellant afforded any opportunity to defend himself nor was any chance of personal hearing ever afforded to the Appellant. Flabbergasting enough the Appellant was not even issued a Show Cause Notice, which reflects clearly the intentions of the inquiry committee.
- viii. That the inquiry committee submitted its findings which are faulty, tainted with mala fide and lacunas and are not worth consideration at all. Copy of the finding report is enclosed as Annexure "D".

ix. That the again very strange enough without issuing any Show Cause Notice to the Appellant major penalty of Dismissal from service imposed upon the Appellant vide order O.B. No. 126 dated 13-09-2022. Copy of the order dated 13-09-2022 is enclosed as Annexure "E".

That the Appellant feeling aggrieved submitted a departmental appeal for the redressal of his grievances. Copy of the departmental appeal is enclosed as Annexure "F".

That the appeal of the Appellant was considered partially to the extent that the penalty of dismissal from service was converted into forfeiture of three years of approved service and the period out of service was converted into leave without pay vide order No. 11778/E dated 22-10-2022. Copy of the order dated 22-10-2022 is enclosed as Annexure "G".





ORDER

This order will dispose of appeal of Ex-Computer Operator Muhammad Ali (BPS-16) of Swat District in connection with major punishment awarded by the District Police Officer, Swat vide OB No.126, dated 13-09-2022, i.e. dismissal from service.

Brief facts of the case are that Ex-Computer Operator Muhammad All of Swat District while posted as incharge OO/PO and Missing Persons Branch remained absent for 91 days i.e on 05/04/2022, 07/04/2022, from 11/04/2022 to 13/04/2022, 15/04/2022, from 19/04/2022 to 09/05/2022 and w.e.f. 11/05/2022 up dismissal from service which warrant strict departmental action against him. Consequently, he was issued charge sheet coupled with statement of allegations and Additional SP Lower Swat, DSP Legal Swat and Office Superintendent were appointed as Enquiry Officers to conduct proper Departmental Enquiry against him. The Enquiry Officers conduct proper Departmental Enquiry against the above named delinquent Computer Operator, and recorded statements of all concerned. The Enquiry Officers have provided ample opportunity to the delinquent Computer Operator to defend the charges leveled against him. After conducting proper departmental enquiry, the Enquiry Officers submitted their findings report wherein they intimated that having gone through the available record of biometric system and after personnel heating of Computer Operator Muhammad Ali, the enquiry committee reached to the conclusion that he was posted as incharge OG/PG and missing person Branch on dated 14/10/2021 and remained absent for 91 days as proved and available record. It reflects that the delinquent Computer Operator Muhammad All is a habitual absenter, and did not take keen interest in the performance of his lawful duty. The allegations leveled against him were proved during course of enquiry in light of available record.
