



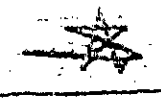

FACTS:-

1. That the petitioner was appointed as CT Teacher at GGMS BATAMORI, BATTAGRAM in the year 2013. (Copy of appointment letter as annexure "A").

2. That vide order Number 4550-52 dated 28/03/2014 she was transferred and adjusted at GGHS BANIAN, BATTAGRAM. (Copy of letter No. 4550-52 is annexure "B").

3. That service book of the petitioner was also prepared with relevant entries and service verified till 30/06/2015. (Copy of the relevant page of service book is annexure "C").

4. That the petitioner regularly maintained her salary account as MCB, OGHI. (Copy of salary account statement is annexure "D").

5. That thereafter NAB started some inquiry and the pay / service of the petitioner was stopped without any Notice / inquiry or investigation.

6. That the respondent No. 2 was also moved by way of departmental appeal with no response till now. (Copy of departmental appeal is annexure "E").

7. That the petitioner time and again visited the concerned offices of respondents with no positive reply and the rights of the petitioner were at stake when she was obliged to send a legal notice to respondent No. 2 which was also not replied. (Copy of legal notice is annexure "F").

8. That inaction of respondents on the representation made to them has forced the petitioner to invoke the jurisdiction of this Honourable court inter alia on the following grounds:-

GROUNDS: -

a. That stoppage of the pay and service of the petitioner is illegal, without any justification and having no legal effects on the rights of the petitioner.

b. That no disciplinary matter is or has been pending before the respondents' department, therefore, the action of stoppage of pay and service of petitioner was not only against the settled norms of justice but also p-

against the disciplinary rules applicable on the government servants.

c. That non-reply to the appeal submitted to the respondent No. 2 is also illegal as he was legally bound to decide the same within the stipulated period which inaction on the part of respondents smacks mala fide intention which is apparent from the conduct of the respondents.

d. That even no response has been given to the notice issued to respondents to decide the departmental appeal / representation but has not been taken in to consideration.

e. That under the E & ND rules KPK, 2011, no public servant can be deprived of his / her service without conducting any inquiry and in the present case no such inquiry has been conducted, which is against the settled norms of justice.

f. That in absence of any other equally efficacious alternative remedy, the petitioner is constrained to seek relief by way of the instant constitutional writ petition.

g. That some other grounds would be urged at the time of hearing with due leave from the bench.

was asked if prior to said posting he was ever posted at said police station, he remained evasive by stating "I do not know". He also evaded to give reply of the question, "if he ever had arrested the petitioner's mother from her house". He also showed his ignorance that at the occasion of arrest of the petitioner's mother, the petitioner was also present there. He admitted that he had conducted the raids at the house of the petitioner so many times. He showed his ignorance if the petitioner was present outside the Central Jail, Mianwali, where he had gone to see his brothers along with his mother three days prior to the occurrence and was apprehended there by the guard of Central Jail. He specifically stated that S.H.O. did not summon any private person to associate him in recovery proceedings. Likewise, Muhammad Rafique A.S.-I. on material question remained evasive in his cross-examination.

9. It is evident that no private person was associated in recovery proceedings, although so could be done very easily. The evidence of both above named police officials does not inspire confidence and is tainted with doubts. A Police Officer is supposed to give entire facts and not to conceal them. The reply of material questions in the words "I do not know", in fact, tantamounts to conceal the facts deliberately. It is very hard to believe that so many times the raids were made at the house of the petitioner, yet, he was not known to the police officials, especially when his brothers and mother were well known to them. Recovery of above articles has not been proved satisfactorily.

10. Accordingly, the petition is converted into appeal and the same is allowed. The judgments of trial Court and High Court are set aside. The petitioner/appellant shall be released forthwith, if not required in any other case.

ORDER

JAVED IQBAL, J. — These petitions for leave to appeal are directed against judgment dated 10-7-2002 passed by learned Punjab Service Tribunal, Lahore, whereby the appeals preferred on behalf of petitioners have been dismissed. In view of common questions of law and facts, the above captioned petitions are being disposed of by this order.

Briefly stated the facts of the case are that the petitioners were appointed as P.T.C. Teachers in 1996 who were served with show-cause notices in 1998 to the effect that as to why their service being fake may not be terminated. After completion of codal formalities and affording proper opportunity of hearing they were removed from service by means of order, dated 31-3-2001. The departmental appeals could not be decided within statutory period and resultantly the Punjab Service Tribunal was approached by whom all the appeals were dismissed, hence these petitions.

It is mainly contended by Mr. Ahmad Awais, learned Advocate Supreme Court on behalf of petitioners that the appointments were made in accordance with law by following the prescribed Procedure which cannot be held "fake appointments" without having a thorough and comprehensive inquiry. It is next contended that the appointments were made as P.T.C. Teachers in 1996 and show-cause notices were issued in 1998 and they were removed from service in the year 2001 without affording proper opportunity of hearing and ignoring the fact that appointments were made by the competent authority. In order to substantiate his version reliance has been placed on *Zahoor Ahmad Awais v. The State* 1997 SCMR 1543.

We have carefully examined the above mentioned contentions in the light of relevant provisions of law and record of the case. We have minutely perused the judgment impugned. After having gone through the entire record we are of the considered opinion that the petitioners manoeuvred their fake appointments with connivance of the functionaries of Education Department and in fact they have never been recruited by the District Recruitment Committee, and moreover, the selection list concerning the said period is silent regarding their names. The recommendations of District Recruitment Committee, Kasur, 49 teachers were recruited on merit and admittedly the petitioners were not included in those 49 teachers. We are conscious of the fact that a copy of list was produced before the Punjab Service Tribunal containing the names of petitioners which hardly renders any assistance to their case as it was not

legal sanctity can be attached to it. The petitioners were removed from service after having an in-depth scrutiny of entire record and affording proper opportunity of hearing to all petitioners. The genuineness of the appointments could not be substantiated by adducing any cogent and concrete documentary evidence and thus, it could safely be inferred that petitioners had manoeuvred their bogus appointments. The learned Punjab Service Tribunal after having gone through the entire material has concluded as follows:—

"(4) We have considered the arguments from both sides and also gone through the relevant record. We find force in the contention of the respondents that the appointments of the appellants as P.T.C. teachers were never recommended by the District Recruitment Committee headed by the Deputy Commissioner. The learned counsel for the appellant has been unable to show any record to establish the genuineness of the appointment orders or the selection of the appellants on merit. From documentary evidence as produced by the respondents it is crystal clear that the appellants managed bogus appointment orders in collusion with dishonest elements in the department which are not entered in the Register of Appointments. As held by the Honourable Supreme Court of Pakistan in their judgment reported as 2000 SCMR 907 when the orders were illegal, then no perpetual rights could be gained on the basis of such illegal orders and therefore, the principle of *locus poenitentiae* was also not applicable. We are convinced that no miscarriage of justice has taken place in the case of the appellants who managed entry as P.T.C. teachers through back door on the basis of bogus appointment orders. We also find that sufficient opportunity was given to the appellants to defend their cause.

A bare perusal would reveal that all the contentions agitated on behalf of the petitioners before the Punjab Service Tribunal have been stated upon and dealt with in a comprehensive manner. The conclusion arrived at by the learned Punjab Service Tribunal being well based and unexceptionable does not warrant any interference. Besides that no question of law of public importance is involved on the basis whereof leave could be granted. There is absolutely no misconstruction of law in fact.

It is, however, to be noted that the penalty of removal has been imposed by ignoring the fact that the petitioners do not fall within the definition of civil servants *stricto sensu* as they were never appointed in accordance with law but manoeuvred their fake appointments and thus, it is not understandable as to how the major penalty of removal was

called upon to address the Court on the said issue who frankly conceded and rightly so that no penalty of removal could have been imposed under the prevalent circumstances.

7. We are accordingly inclined to partly accept these petitions which are converted into appeals and the judgment dated 10-7-2001 passed by the learned Punjab Service Tribunal, Lahore, is modified to the extent that the removal from service is converted to that of termination from service.

ORDER

FAQIR MUHAMMAD KHOKHAR, J.--- This petition for leave to appeal is directed against the judgment, dated 28-6-1999 passed by the Lahore High Court, Multan Bench, in F.A.O. No.60 of 1999.

2. The respondent filed, before the Civil Judge, Mian Channu, District Khanewal, a suit for specific performance of agreement, dated 12-1-1999 for the sale of the suit property. The trial Court, by order, dated 2-12-1998, struck off the defence of the petitioners for failure to file an amended written statement in the civil suit. The petitioners filed F.A.O. No.60 of 1999 which was dismissed by the Lahore High Court, Multan Bench, by the impugned order, dated 28-6-1999. Hence this petition for leave to appeal.

3. The learned counsel for the petitioners argued that the judgment granted by the trial Court for filing the written statement could not be treated to be the last one. The trial Court had not made it clear that no further opportunity would be granted. It was further submitted that it was not a case where the filing of a written statement had been required by the trial Court in terms of Order VIII, rules, 1, 9 and 10 of the Civil Procedure Code, 1908. The learned counsel lastly contended that the impugned judgment was not sustainable in view of the law laid down by this Court in the case of Col. (Retd.) Ayub Ali Rana v. Carlite S. Pune and another PLD 2002 SC 630.

4. On the other hand the learned counsel for the respondent submitted that on 21-10-1998 the trial Court had directed the petitioners to file a written statement on 25-11-1998 but they failed to do so. The case was adjourned for the purpose and was fixed for hearing on 2-2-1998. Since the petitioners failed to comply with the order of the Court, therefore, their defence was rightly struck off under Order VIII, rule 10, C.P.C.

5. We have heard the learned counsel for the parties at length. In view of the law laid down by this Court in the case of Col. (Retd.) Ayub Ali Rana v. Carlite S. Pune and another PLD 2002 SC 630, we are directing the petitioners to file an amended written statement as if a written statement had already been filed. Even otherwise the orders dated 2-12-1998 and 28-6-1999 are in conformity with the law laid down by this Court in the case of Col. (Retd.) Ayub Ali Rana v. Carlite S. Pune and another PLD 2002 SC 630.



JUDGEMENT:



MUHAMMAD JAMAL KHAN, MEMBER:-

Through the instant Service appeal submitted under Section-4 of the Khyber Pakhtunkhwa Services Tribunal Act, 1974, the order of stoppage of salary since March 2015 till date has been called in question.

2. According to the appellant being civil servant, he was inducted into service on 16.04.2013 as Drawing Master (BPS-15) at Government High School Asharband, Allai District Battagram. Appellant was transferred from the aforesaid school to Kayan, District Mansehra, on 06.08.2014, in consequence thereof he submitted his charge.

relinquishment report on 07.08.2014 and as such reported to GMS Kayan. He rendered his duties efficiently and honestly in a manner becoming of a civil servant and for this reason no adverse remarks were recorded or action was taken, during the course of rendition of services at GMS Kayan he received regular salaries till February 2015 whereafter his salaries were unceremoniously stopped/blocked without tendering any explanation or notice to appellant. It was during this period that he made strenuous efforts to unblock his salaries or to ascertain the reason for its stoppage but did not succeed. After putting in immense efforts he was able to get an un-served show-cause notice in which he has been tentatively imposed major penalty of removal from service for the reason of absence from duty. No statement of allegations was served on appellant nor any inquiry was conducted nor allegiance to the provision of Rule 5, 7 & 9 of Government of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules was made nor he has been handed over any manuscript as to the status of employment of appellant eliciting mala-fide on the part of respondents thus violating the Fundamental Rights of appellant, he made recourse to the Hon'ble Peshawar High Court, Peshawar, through Writ Petition No. 478-P/2017 which was ultimately withdrawn with the direction to make recourse to the proper forum. He made efforts to procure the copies of the relevant documents from the office of District Education Officer concerned through the good offices of RTI but no response was received by him vide his application dated 14.07.2017. The departmental appeal dated 29.06.2017 moved for the purpose proved unsuccessful vide order dated 07.12.2017 followed by the instant service appeal.

3. It is worth to be mentioned that earlier the Hon'ble Members of this Tribunal in their respective judgments differed essentially on the point as to the legal status of appellant one Member declared him as Civil Servant while the other subjected his opinion in this regard to the outcome of the inquiry to be conducted against appellant although both of them respectively concurred on the point of holding of inquiry in the matter thus due to this tie the appeal was referred to the Larger Bench for adjudication.

4. Respondents were summoned in response thereof they attended the Tribunal through their legally authorized representative, vehemently

controverting the claim of appellant by submitting comments/reply wherein certain legal and factual objections were raised, inter-alia, that appellant is not aggrieved person, appellant is estopped by his own conduct, appellant has not come to this Tribunal with clean hand, appellant has no cause of action/locus standi, appeal is against the prevalence law and rules and appellant has concealed the material facts etc.

5. We have heard arguments of the learned counsel representing appellant as well as learned Additional Advocate General representing respondents and were able to go through the record with their assistance.

6. While initiating arguments the learned counsel representing appellant submitted that the moot question for resolution before this bench relates to the release of salary of appellant. While making reference to the split judgment passed earlier by the Hon'ble Members of this Tribunal he submitted that there was complete unanimity regarding conducting of inquiry for ascertainment of the facts. The point at which the worthy Members were at variance was with regard to fact that as to whether appellant is a civil servant or else otherwise. The learned counsel submitted that in case appellant was not a civil servant in that eventuality this Tribunal was divested of jurisdiction and this Tribunal would have returned the very appeal at the very outset. The learned counsel declared that appellant is a civil servant and he has to be dealt with in accordance with the Khyber Pakhtunkhwa Government Servants Efficiency & Discipline) Rules, 2011.

7. On the contrary, the learned Additional Advocate General submitted that there is no order either original or appellate before this Tribunal for adjudication. He referred to the Writ Petition filed in the Hon'ble Peshawar High Court which was withdrawn on 01.06.2017 wherein the learned counsel representing appellant submitted that appellant has been removed from service and he want to approach proper forum, appellant has concealed material facts from this Tribunal. He further contended that no order regarding the release of salary of appellant has been passed which fact was not entertained by the Tribunal rather dismissed the very plea in the judgements pronounced, the appointment of appellant is fake and fabricated the case of

appellant cannot be reckoned to be included in the category of civil servant. He has been removed from service rightly. The appointing authority has not been made party hence, the appeal is bad due to non-joinder of necessary party.


8. The perusal of record would reveal that while conducting post audit process certain irregularities were noticed in the payment of salary made to the appellant upon which his salary was stopped. For ascertainment of the facts the District Education Office (Male) Mansehra, dispatched a letter regarding the veracity of appointment order of appellant to District Education Officer (Male) Battagram, who reportedly was the authority vide letter bearing no. 6851 dated 19.04.2018. In response thereof the District Education Office (Male) Battagram, by virtue of letter dated 03.09.2018 submitted that appellant has not been appointed by his office nor he performed duty at GHS Asharband and it was concluded that the appointment order of appellant was fake and fabricated. Accordingly, his salary was stopped with effect from March 2015, it is worth to be mentioned that appellant did receive his salaries till February 2015 regularly however, he was proceeded against on account of absence from duty. The record on file nowhere mentions that appellant has been proceeded in accordance with the cannon of rules as visualized by the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011, nor the matter has been inquired to ascertain as to how the appointment of the appellant was made to the post of Drawing Master (BPS-15) and how he managed to be transferred from the District Cadre post which he held at District Battagram to District Mansehra, how he received salary at the last mentioned place of posting? Appellant claimed to be a civil servant if this plea of appellant is taken into consideration it was incumbent upon the authority at the helm of affairs to have properly initiated departmental proceedings as mandated by the law and as such initiating the same by issuance of show-cause notice alongwith statement of allegations followed by conducting of regular inquiry so that the grain should have been sifted from the chafe. Whatever may be the allegations against the appellant conformity with the rules and following the law in this regard was the only course open for the authorities to have been adopted before initiation of proceedings or making any order adversely affecting his case. The authenticity and


credulity of appointment order could have been established only when full-fledged inquiry in the matter was made as regard the position held by the appellant it has to be ascertained vis-à-vis his appointment order. If it is established that he held the post by a valid appointment order an order with regard to release of salary could be made and the case would be otherwise if the appointment order is invalidated.


9. There could be no second opinion as regard the factum that when no final order is challenged before this Services Tribunal as enunciated by the Hon'ble Supreme Court of Pakistan in its judgement reported as 2006 SCMR 1630 and the unreported judgement of this Tribunal in Service Appeal No. 19/2011 Captioned Mr. Abdul Waheed SET Versus Executive District Officer E&SE Education Department decided on 15.12.2017 however, at the moment the question for determination is the establishment of the veracity and genuineness of appointment order of appellant, the resolution of which is not possible unless and until it is ascertained through a regular inquiry.

10. Resultantly, the appeal is remitted back to the respondents for conducting of regular inquiry in the process of which the appellant has to be associated by providing him fair opportunity of defending himself within a period of 90 days from the date of receipt of copy of this judgement. Keeping in view the circumstances of the instant case no order of reinstatement or release of pay could be passed at this stage which of course would be subject to outcome of de-novo inquiry. Parties are left to bear their own costs. File be consigned to the record room.
