APPEAL U/S 4 OF THE SERVICES TRIBUNAL ACT, 1974 AGAINST THE TRANSFER/POSTING ORDER DATED 27.05.2021 AT SR.NO.3 IN RESPECT OF RESPONDENT NO.4 PASSED BY RESPONDENT NO.2, WHEREBY RESPONDENT NO.4 WAS POSTED AT GCMHS ALPURI, AGAINST A VACANT POST OF BS-19 AT HIS OWN PAY AND SCALE AND THE APPLICATIONS OF APPELLANT WERE NOT CONSIDERED AS THE APPELLANT WAS FULLY ELIGIBLE AND ENTITLED FOR THE SAID POST.

PRAYER:

On acceptance of this appeal, order dated 27.05.2021 of the respondent No.2 in respect of transfer/posting of respondent No.4 may kindly be set aside and the application Endst.No.519 dated 13.05.2020 and application Endst.No.2039 dated 07.06.2021 may kindly be allowed and the appellant may graciously be posted as Principal (BS-19), GCMHS Alpuri, District Shangla, as per merit and policy.

Respectfully Sheweth:

- That appellant is a law abiding, peaceful and highly qualified citizen of Islamic Republic of Pakistan, presently posted as Principal, GHSS, Shahpur, District Shangla in BS-19.
- 2. That the appellant is the senior most Principal in BS-19 in the entire District Shangla, moreover, the appellant has been working as Principal (BS-19), GHSS Shahpur, District Shangla, since September, 1st 2012 and have spent 09 years at the same station, which is very far from the native residence/village of the appellant.
- 3. That the present duty station of the appellant is laying at a distance of about 35km from the residence of the appellant, whereas GCMHS Alpuri,

is situated at a walking distance from the home residence of the appellant and keeping in view the above facts, the appellant filed an application vide Endst. No.519 on 13.05.2020 for transfer and posting to GCMHS Alpuri from GHSS Shahpur, Shangla. It is pertinent to mention here that at the time of filing application for transfer/posting, the post of Principal (BS-19) at GCMHS was laying vacant and the appellant was fully eligible and entitled for the said position, but the respondent No.2 without any plausible reason did not consider the application of the appellant. (Copies of the Applications are attached).

- 4. That on 27.05.2021, the respondent No.2 passed transfer/posting order in which he posted respondent No.4 as Principal (BS-18) in his own pay and scale to the utter surprise of the appellant, because respondent No.4 was not at all eligible and entitled for the said position, the post at GCMHS is of BS-19 and respondent No.4 is working in BPS-18, which is against the law and the policy on the subject. (Copy of Order dated 27.05.2021 is attached).
- 5. That it is pertinent to mention here that respondent No.4 has been appointed on 06.08.2020 in BS-18 and his initial posting as Principal was at Kotkay

and transferred and posted to GCMHS during probation period on a wrong post of BS-19, which is against the law, rules and policy on the subject. (Copies of Appointment and Transfer/ Posting Orders are attached).

- 6. That on 07.06.2021, the appellant filed a departmental appeal/representation before the good office of respondent No.2, but till then respondent No.2 did not consider the same by either allowing it or declining the same. (Copy of Departmental Appeal is attached).
- 7. That the departmental appeal of appellant was within time and he was also eligible for the same position as the appellant is serving in BS-19, but respondent No.2 did not consider the appeal of the appellant without any lawful reason.
- 8. That the appellant is the most senior Principal in the entire District Shangla and respondent No.4 is much junior than the appellant, his transfer/posting at a senior and wrong position is nothing but a sheer violation of law, rules and the policy.
- 9. That the appellant feeling aggrieved from the order dated 27.05.2021 and finding no other adequate, alternate and efficacious remedy, approaches this

Hon'ble Tribunal within the statutory period, inter alia, on the following grounds:-

GROUNDS:

- A. That the order dated 27.05.2021 passed by respondent No.2 is against the Rules, law and against the fundamental rights guaranteed under the constitution, thus be declared as null and void.
- B. That the order dated 27.05.2021 is against principle of seniority, because the appellant is much senior to respondent No.4 and was fully entitled and the respondent No.4 is much junior and the post at GCMHS is of BS-19 and respondent No.4 is working in BS-18, thus the order dated 27.05.2021 is liable to be set aside on this score alone.
- the own pay scale policy has sternly C. That discouraged by superior courts in its judgments cases. in various time to time passed No.2 bypassed and ignored respondent judgments of the superior courts by placing respondent No.4 at a post of BS-19 (wrong post) at his own pay and scale, instead of placing the appellant, who is in BS-19, hence the same is also liable to be turned down, keeping in view the guidelines of the superior courts.

That the order dated 27.05.2021 is based on D. malafide as it has been passed by bypassing the mandatory provisions of law, hence the order is liable to be struck down and the appellant is entitled to be posted as Principal (BS-19) GCMHS Alpuri, as per law.

That the order dated 27.05.2021 in respect of E. respondent No.4 is against the reported judgment, which is reported as PLC (CS) 1045, in which the superior court has laid down a principle that the authority is bound to explain the reason for passing an order, which is not mandated by law.

It is, therefore, most humbly prayed that on acceptance of this appeal, order dated 27.05.2021 of the respondent No.2 in respect of transfer/posting of respondent No.4 may kindly be set aside and the application Endst.No.519 dated 13.05.2020 and application Endst.No.2039 dated 07.06.2021 may kindly be allowed and the appellant may graciously be posted as Principal (BS-19), GCMHS Alpuri, District Shangla, as per merit and policy.
