1. That the Appellant is naturally born bona-fide citizen of Islamic Republic of Pakistan & hails from respectable family.
2. That after going through the mandatorily required criteria & after being envisaged

with the ordeals & inquisitions of selection process, the Appellant got appointed vide Office Notification NO.SO(S)3-1/2006/Head Master (Male) dated 24-09-2007 of the office of the then Secretary Schools & Literacy Department, Government of N.W.F.P, and was accordingly posted at different schools across Khyber Pakhtunkhwa (**Copy of Office Notification NO.SO(S)3-1/2006/HeadMaster (Male) dated 24-09-2007 is Annexed herewith as Annexure "A"**).

3. That before coming onto the main crux of the instant case, it would be appropriate to mention here that the Government of Khyber Pakhtunkhwa, Finance Department introduced and promulgated vide its Notification No.BOV/FD/2-112/2011/04-Tier Formula Dated 28-02-2012 introduced a 04 Tier Formula for Up-gradation of Teaching Cadre Posts in BPS-20, BPS-19, BPS-18 & BPS-17 at Elementary & Secondary Education Department in two phases. Moreover, equal number of Post in BPS-17 at the respondent Elementary & Secondary Education Department were abolished and were upgraded to BPS-18, BPS-19 & BPS-20 respectively. (**Copy of Notification No.BOV/FD/2-112/2011/04-Tier Formula Dated 28-02-2012 is Annexed herewith as Annexure "B"**).
4. That accordingly, as per the 4 tier formula of up-gradation, the employees serving in BPS-17 were upgraded phase wise to BPS-18, and in the same scenario, the Appellant were also upgraded to BPS-18 vide Notification No.SO(S/M)E&SED/1-3/2016/Promotion BS-17 to BS-18 Dated 01-

12-2016 of the Office of Elementary & Secondary Education Department in third phase. (Copy of Notification No.SO(S/M)E&SED/1-3/2016/Promotion BS-17 to BS-18 Dated 01-12-2016 is annexed herewith as Annexure "C").

5. That now coming onto the main epitome of the instant case; the Respondent Elementary & Secondary Education advertised certain posts of Head Masters (BPS-18) to be filled-in departmentally through Khyber Pakhtunkhwa Public Service Commission, and in accordance of the same, 63 posts of Principals (BPS-18) were filled by the Respondent E&SE Department on recommendations of KPPSC vide Notification No.SO(S/M)E&SED/3-2/2014/Recruitment of Principal (BS-18) (Male) dated 25-08-2015. (Copy of Notification No.SO (S/M) E & SED /3-2/2014/Recruitment of Principal (BS-18) (Male) dated 25-08-2015 is annexed herewith as Annexure "D").
6. That the Respondent E&SE Department issued an Inter-se Seniority list for the year 2019, vide Notification NO.SO(SM) E & SED /2-2/ 2020 /Final Seniority Principals/V.P/SSS Dated 01-10-2020 for teaching Cadre Posts, wherein the Head Masters recruited/appointed on 25-08-2015 has been placed ahead of the Appellant and his colleagues. (Copy of the Impugned Seniority List is annexed herewith as Annexure "E").
7. That before going to went out spleen upon the unfettered discrimination meted out to

the Appellant, it would be appropriate to mention here that the respondent department has introduced a new formula of 8-20, whereby, 80% of post of Teaching Cadre at Respondent E & SE department has been upgraded & remaining 20% fresh appointments have been illegally made by KPPSC. It is pertinent to mention here that the 80-20 formula was introduced in the 3rd Phase of up-gradation, whereby the Appellant have been made juniors than that of the freshly appointed ones & above all the subject posts are up-graded posts & not newly created posted where the alleged quota can be reserved. And above all the Appellant are to be brought at par with their colleagues, who got up-graded in initial two phases and the certainty is to be brought in lieu with Rule 17 of the Appointment, Promotion & Transfer Rules 1989 & Rule 17 of the FR & SR & in no canon of law than direct recruitees can be placed ahead of promotees.

8. That as per the supra mentioned certainties, coupled with the vivid fact of up-gradation formula, it would be of equal importance to mention here that those appointed back in the year 2015 are made senior in ranks in the impugned inter-se seniority list and have been placed in BPS-18, ahead of the Appellant & his colleagues, wherein, the Appellant are holding the very same position years back and that too from 2007. Now by virtue of what has been discussed above, how is it even possible to place juniors above in the seniority list and place them in BPS-18 (2015)?

9. That feeling aggrieved from the above staged drama, the Appellant moved an application to the Secretary Elementary & Secondary Education Department, but the same was turned down with the observation that the seniority list is correct and no change in the seniority list can be made. (Copy of Application is annexed herewith as Annexure "F").
10. That feeling aggrieved, the Appellant & others filed a Writ Petition No:4803-P/2020, which was disposed off with direction to approach this Hon'ble Service Tribunal. (Copies of W.P No: 4803-P/2020 and Order & judgment dated: 16/12/2020 is annexed herewith as Annexure "G & H" respectively).
11. That the Appellant preferred the instant Appeal upon the following grounds inter-alia:-

GROUND:-

- A. That the Appellant is a naturally born bona-fide citizen of the Islamic Republic of Pakistan and is fully and equally, on equality basis, entitled to all basic and fundamental rights as enshrined in the fundamental law of the land, interpreted, guaranteed and enforced by the laws of the land and discrimination, particularly unfettered exercise of the discretionary powers vested in Public Functionaries are always deplored, discouraged and deprecated by the laws and law courts of the land.

- B. That where the Appellant was already in-line for his up-gradation as per the Notification No.BOV/FD/2-112/2011/04-Tier Formula Dated 28-02-2012 of the Finance Department, then how can fresh recruitments can be made to the posts of Head Masters and that too even before the up-gradation of the Appellant.
- C. That the impugned seniority list is illegal and unlawful hence liable to be set-aside.
- D. That the impugned seniority list is against the principles of natural justice and against the supreme law of the land.
- E. That even if any notification or policy contradicts to the mother law, then the same has to be declared as illegal and illogical and unconstitutional.
- F. That the respondent Elementary & Secondary Education Department has done utter violation of law and thus has made the newly appointed ones ahead of the Appellant in the impugned seniority list, which is not tenable in the eyes of law.
- G. That the law & law courts of the land have always preferred and encouraged that law has to be followed and have always discouraged, deplored and depreciated any variation from the rules or its violation etc.

H. That under the mandate of Article 4 of the Constitution, no one can be treated otherwise than in accordance with law, whereas Article 25 postulated that alike are to be treated alike, but here the case is volta-facie and totally different yardstick has been used to treat the petitioner.

I. That such reckless demeanor of the Respondents is an unreasonable departure from the Principles of Policy contained within the Constitution requiring them to secure well-being of the Appellant by ensuring equitable adjustment of rights between the employer - Respondents and employee - Appellant.

J. That as per the dictum and law governing the land, it is a prima-facie fact that where a law requires the thing to be done, that must be done in a particular manner and not otherwise.

K. That from every angle, the impugned Seniority List is wrong, illegal, void, against the rights of the Appellant and is liable to be set aside, and by doing so, the Appellant be placed in the seniority list in accordance the law.

L. That the Appellant seeks permission of this Hon'ble Tribunal to advance other relevant grounds at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal, Respondents be directed to place the Appellant at his due place and ahead of the direct recruitees under the mandate of Rule

8

17 of FR & SR and Rule 17 of Appointment, Promotion & Transfer Rules 1989.

Any other relief not specifically asked for may also graciously be extended in favor of the Appellant in the circumstances of the case.

Interim Relief:

By the way of Interim Relief, the Respondents be restrained from carrying any promotion to BPS-19 till the final disposal of the instant Service Appeal.

2. In essence, the petitioners have called in question the final seniority list of Principals/Vice Principals/SSS BPS-18 (Male) Khyber Pakhtunkhwa (Teaching Cadre) as it stood on 31.12.2019.
3. Arguments heard and record perused.
4. The main grievance of petitioners is that they are claiming seniority over the direct recommendees of the Public Service Commission on the ground that their delayed upgradation would not be affected and that they will maintain their seniority alongwith their batch who were earlier upgraded.
5. We have examined the case and find that on the one hand, petitioners are claiming seniority over the direct recruits, albeit none of the persons are impleaded as party who are going to be

Besides, seniority is one of the terms and conditions of service as provided under section 8 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule-17 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 and the instant matter can better be agitated before the Service Tribunal in accordance with law. On the one hand, there is bar of Article 212 of the Constitution of Islamic Republic of Pakistan for entertaining matters pertaining to the terms and conditions of service and on the other hand, in view of Article 199 of the Constitution of Islamic Republic of Pakistan, 1973, petitioners have alternate remedy available in the shape of submitting service appeal before the Tribunal constituted under the Service Tribunal Act, 1974.
