WHEREBY APPELLANT'S DEPARTMENTAL APPEAL HAS BEEN FILED.**

**PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL BOTH
THE IMPUGNED ORDERS DATED 24-04-2019 AND 27-11-2020 OF
THE RESPONDENTS MAY GRACIOUSLY BE SET ASIDE AND
APPELLANT BE RESTORED ONE YEAR FORFEITED SERVICE WITH ALL
CONSEQUENTIAL SERVICE BACK BENEFITS.**

I

Respectfully Sheweth:

1. That appellant while posted as Investigation Officer at Police Station Nawansher, he was entrusted the Investigation of Case FIR No. 664 dated 06-10-2018 U/S-506/427/34 PPC registered with PS Nawansher, wherein 04 accused were charged. All the 04 charged accused had obtained Bail Before Arrest. The bail application was under process in the Court of Session Judge Abbottabad for confirmation. Before the fate of BBA application could be decided, the appellant was transferred from Police Station Nawansher to Police Station Bakote Abbottabad

and the Investigation was handed over to his successor Zubair Khan ASI, who investigated the case. Appellant is innocent in this case as he could not investigate this case due to his transfer. Therefore, the punishment awarded to him by DPO Abbottabad vide order dated 24-04-2019 is illegal and against the fact and circumstances of the case. **(Copy of order dated 24-04-2019 is attached as Annexure-"A")**.

2. That appellant aggrieved of the above order filed a departmental appeal dated 07-05-2019 before the Regional Police Officer Hazara Region Abbottabad. **(Copy of departmental appeal dated 07-05-2019 is attached as Annexure-"B")**.
3. That the Regional Police Hazara Region Abbottabad without taking into consideration the stance and grounds taken by appellant in memo of departmental appeal, filed the same vide order dated 27-11-2020. **(Copy of appeal's rejection order dated 27-11-2020 is attached as Annexure-"C")**.
4. That though the appellant's departmental appeal was filed/rejected but its copy was not supplied to him and he obtained the same by filing application dated 21-12-2020 before the District Police Officer Haripur where upon the said order was given to the appellant. **(Copy of application dated 21-12-2020 is attached as Annexure-"D")**. Hence this service appeals, inter alia, on the following:-

• GROUNDS:

3

- a) That orders dated 24-04-2019 and 27-11-2020 of respondents are illegal, unlawful, against the departmental rules & regulation, issued in a cursory, whimsical and arbitrary manner, hence are liable to be set aside.
- b) That no proper departmental inquiry was conducted. Copy of inquiry report, if any, was also not provided to him. Even opportunity of personal hearing was not afforded to the appellant and he was condemned unheard.
- c) That the appellate authority has also failed to abide by the law and even did not take into consideration the grounds taken by appellant in his memo of appeal. Thus the impugned order of appellate authority is contrary to the law as laid down in Police Rules read with section 24-A of General Clause Act 1897 and Article 10A of the Constitution of Islamic Republic of Pakistan 1973.
- d) That though the appellant has not conducted any investigation in the case in question as the charged accused were on Bail Before Arrest and before deciding the fate of their BBA application the appellant was transferred from PS Nawansher to Bakote and the investigation was carried by a successor of appellant namely ASI Zubair Khan, but the appellant has wrongly been awarded the penalty of forfeiture of one year service without any fault on his part.

- e) That instant service appeal is well within time and this honorable Service Tribunal has got every jurisdiction to entertain & adjudicate upon the lis.

PRAYER:

It is, therefore, humbly prayed that on acceptance of instant Service appeal order dated 24-04-2019 and 27-11-2020 of respondents may graciously be set aside and the appellant be restored his "forfeited one year approved service" with all consequential service back benefits. Any other relief which this Honorable Tribunal deems fit and proper in circumstances of the case may also be granted.

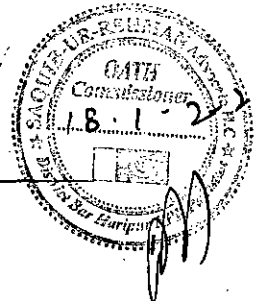

Annex - A

This office order will dispose of the departmental enquiry against ASI Riaz Khan the then PS Nawanshehr. According to enquiry report of Addl: SP Abbottabad he while IO in case FIR No. 664 dated 06-10-2018 u/s 506/427/34 PPC PS Nawanshehr following deficiencies were left in investigation of the said case:-

- i. He being IO failed to confirm ownership of land transfer deeds from the Revenue department.
- ii. He failed to incorporate locations of charged persons separately, on case file which could be cleared through CDR.
- iii. Complainant of FIR charged four accused, whereas statement of eye-witness in affidavit shows that 02 unknown accused were present on the spot which indicates contradiction.
- iv. Statement of witnesses were annexed only with case file but not clearly incorporated in the case diaries.

His this inefficiency and unprofessional attitude earned bad name for police department in the eyes of general public

He was issued Charge Sheet along with statement of allegations. Mr. Abdul Aziz Khan Afridi SP Investigation Abbottabad was appointed as Enquiry Officer. He conducted proper departmental enquiry against the delinquent officer and recorded statements of all concerned. After conducting proper departmental enquiry, the Enquiry Officer submitted his findings, wherein allegations have been proved against him. Consequently he was issued Final Show Cause Notice. He was summoned to appear in Orderly Room on 18-04-2019. He was given a patient hearing but he had nothing plausible to state in his defence.

Therefore, in exercise of the powers vested in the undersigned under Police Disciplinary Rules-1975 (amended 2014), I, Abbas Majeed Khan Marwat PSP, District Police Officer, Abbottabad as a competent authority, am constrained to award him the punishment of Forfeiture of one year approved service with immediate effect

ORDER

This order will dispose off departmental appeal under Rule 11-A of Khyber Pakhtunkhwa Police Rules, 1975 submitted by ASI Riaz Khan of District Abbottabad against the punishment order i.e. *Forfeiture of one year approved service* awarded by DPO Abbottabad vide OB No.93 dated 24.04.2019.

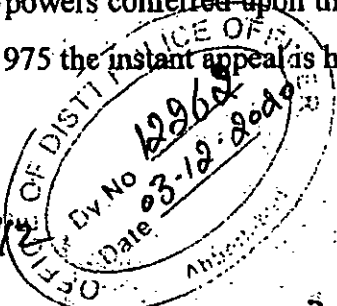
Brief facts leading to the punishment are that the appellant while posted at Police Station Nawansher being I.O in case FIR No.664 dated 06.10.2018 u/s 506/427/34 PPC PS Nawansher left following deficiencies during investigation of the case.

1. The appellant failed to confirm ownership of land transfer deeds from the Revenue department.
2. Failed to incorporate locations of charged persons separately, on case file which could be cleared through CDR.
3. Complainant of FIR charged four accused, whereas statement of eye witness in affidavit shows that 02 unknown accused were present on the spot which indicates contradiction.
4. Statements of witnesses were annexed only with case file but not clearly incorporated in the case diaries.

The appellant was issued charge sheet alongwith summary of allegations and SP Investigation, Abbottabad was deputed to conduct departmental enquiry. The EO held the appellant responsible of misconduct and recommended him for minor punishment. The appellant was issued final show cause notice and heard in person, however he failed to advance any cogent reason in his defence. Consequently, DPO Abbottabad awarded him minor punishment of forfeiture of one year approved service. Hence, the appellant submitted this present appeal.

After receiving his appeal, comments of DPO Abbottabad were sought and examined/perused. The undersigned called the appellant in OR. However, he failed to appear before the undersigned. It has been presumed that the appellant has nothing to advance in his defence. Moreover, the misconduct on the part of the appellant has been proved during enquiry proceedings. Therefore, in exercise of the powers conferred upon the undersigned under Rule 11-4 (a) of Khyber Pakhtunkhwa Police Rules, 1975 the instant appeal is hereby *filed* with immediate effect.
