Brief facts to the instant appeal are also arrayed as under -

- 1) That, the appellant is serving devotedly and utmost endeavors and to the best of her ability for the date of appointment and appellant is presently working as SST (B)-17 GGHS Behali Mansehra.

- 2) That, the appellant is serving in the department with complete devotion dedication, to entire satisfaction of his superior and earns good result by dint of hard work and merit.

- 3) That, the appellant has possessed MSC Chemistry as per Seniority list of SST Female of E&SE Department KPK, vide dated 10.10.2016 appellant was placed on said No. 1715 whereupon appellant submitted all relevant documents i-e PER/ACR, Bio Data and non involvement certificate and all other relevant documents of Respondent No.3 through respondent No.4 promotion of SST (Science) BS-17 to subject specialist (SS) BS-17 as per seniority list.

(Copy of letter vide dated 28.11.2016 and 12.08.2017 attached at "A & B").

- 4) That, Respondent No.4 also issued a letter vide No. 16251-97 dated

28.11.2016 for submission of PERS to concerned Principal, whereupon appellant also submitted are PERs and relevant documents a well with time in the office of Respondent No.4

(Copy of letter vide dated 28.11.2016 are annexed as annexure "C")

- 5) That, the appellant is eligible SST (Science) BS-17 to SS Chemistry BS-17 alongwith B.Ed besides another factor of seniority cam fitness also taken into account for promotion for SST to SS.
- 6) That, as per seniority list of SST appellant was placed at Serial No. 1715 whereas Respondent No.5 was placed at Serial No. 1820 is below the Seniority and it is junior to the appellant.

- 7) That, respondent No.2 with malafide intention and by passing the relevant record and seniority list, was promoted Respondent No.5 but did not promote the appellant as SST to SS (Chemistry) which amount to discriminatory attitude of Respondent department toward the appellant vide impugned notification vide dated 15.03.2018, and thereafter adjustment order notification vide dated 13.04.2018.

- 8) That, appellant filed a departmental appeal against impugned notification vide dated 15.03.2018 before appellate authority Respondent on 21.02.2021 and waited for 90 days but no reply has been received by respondent to the appellant so far.

- 9) That feeling aggrieved from the impugned notification dated 15.03.2018 passed by respondent No.2 appellant having no other remedy accept to file the present appeal before this worthy regular for notification inter-alia on the following grounds.

GROUND: -

- A) That, the impugned notification from SST to SS Chemistry of Respondent No.5 is illegal, discriminatory, unlawful, without lawful authority, perverse, arbitrary against the norms of justice and null and void upon the right of appellant.

B) That, the appellant completed all requirements, formalities which are sine quo non for the promotion of appellant for SST (Science) BS-17 to Subject Specialist SS BS-17 (Chemistry) well before time and all the requisite documents as required were deposited in the office of Respondent No.4 for the purpose of promotion against the said post but the appellant being senior to respondent No.5 had not been promoted due to the reasons best known to the respondent Department.

C) That, it is settled principle of law that promotion to the next higher scale is granted to those employees having qualified for promotion and on the basis of seniority deem fitness but the appellant has not been promoted and no reason of the same has been furnished to the appellant so far that respondent No.5 is influential as well as blue eye chaps, therefore she has been promoted by respondents hence the department has violated the principle of law which envisages that when something is not to be done in a particular manner that must be done and that matter and not otherwise.

- D)** That, it is very sorrow state of affairs that right of the promotion of the appellant has been curtailed arbitrary which is against the purpose of good administration as well good governance besides the appellant is shuttling between the office of Respondent department for the redress of their grievances and still crying at the top of his voice but of no avail.
- E)** That, court should not fold up its hands while granting promotion to the appellant as SS chemistry on the Principle of qualification as well seniority came fitness. The service carrier due to the promotion of juniors from SST BS-16 - SS BS-17 as subject specialist chemistry.
- F)** That, this facts may not be left to fade oblivion that the appellant being senior and qualified had professional rights of promotion over respondent No.5 and is eligible to be promoted from SST to SS in subject of chemistry in all respect.
- G)** That, this facts may also not be left the fade in oblivion that the appellant has illegally been disconnected by the respondent/

department and no stretch of the imagination/disentitle the appellant from promotion SST BS-16 to SS Chemistry -BS -17.

H) That, the other grounds would be urged with the part of strained at the time of arguments.
