



APPEAL UNDER SECTION 4 OF KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST IMPUGNED PROMOTION NOTIFICATIONS /ORDERS FROM SCT TO SST (BPS-16) ISSUED BY RESPONDENT NO. 2 IN WHICH THE APPELLANT WAS ILLEGALLY IGNORED FROM PROMOTION OF SCT TO SST POST, THE SAID ORDERS ARE TOTALLY AGAINST THE LAW, WITHOUT JURISDICTION, MALAFIDY AND ISSUED ON BASELESS FACTS AGAINST WHICH APPELLANT FILED A DEPARTMENTAL APPEAL BEFORE RESPONDENT NO.1 ON 07/01/2021 WHICH WAS NOT HONORED HENCE, THE APPELLANT IS FILING THE INSTANT SERVICE APPEAL BEFORE THIS HONBLE TRIBUNAL WITHIN THE SPECIFIC PERIOD OF 120 DAYS.

PRAYER:

ON ACCEPTANCE OF THE INSTANT APPEAL, IT IS VERY HUMBLY PRAYED THAT, THE APPELLANT MAY KINDLY BE PROMOTED W.E.F. THE DATE AT WHICH THE MOST JUNIOR TEACHERS FROM THE APPELLANT, WERE PROMOTED TO SST POST, WITH ALL CONSTITUTIONAL BACK BENEFITS.

Respectfully Sheweth,

FACTS

- 1) That, appellant was appointed as a "CT" in BPS-09, at GMS Basian, District Abbottabad on 07/10/1989 vide order Endst: No. 60/SV(M) and appellant took over charge on 08/10/1989. **(Copy of First appointment order dated 07/10/1989 is attached as Annexure "A")**
- 2) That, the appellant passed his B.Sc Examination from University of Peshawar in 2nd Division in the Annual Session 1988 and appellant was promoted into BPS-14 on 01/06/1991. **(Copies of Academic and professional certificates/degrees are attached as Annexure "B")**
- 3) That, on 26/01/2008, finance department Govt of KPK issued a up-gradation order in which appellant was promoted from BPS-14 to BPS-15 w.e.f. 01/10/2007. **(Copy of promotion order dated 26/01/2008 is attached as Annexure "C")**
- 4) That, on 11/07/2012, Respondent No.1, issued a Notification for promotion of 1/3 of all cadres including C.T teachers to next higher scale BPS-15 to BPS-16, at the basis of prescribed qualification / seniority cum fitness. **(Copy of notification dated 11/07/2012 is attached as Annexure "D")**
- 5) That, on 28/02/2013, appellant was promoted from C.T (BPS-15) to SCT post (BPS-16) vide order No.1502/09 issued by respondent No.3 in the light of above said notification dated 11/07/2012 and appellant adjusted at GHS No.3, Abbottabad. **(Copy of order dated 28/02/2013 issued by respondent No.3 is attached as Annexure "E")**

- 6) That, on 20/12/2013, Respondent No.1, issued a notification according to which 75 % teachers (CT/SCT, DM/SDM, AT/SAT, TT/STT,Qari/Sr.Qari) were to be promoted to SST post and in the said 75/% Promotion Quota, 40% quota was also fixed for the promotion of C.T to SST post. **(Copy of Notification dated 20/12/2013 is attached as Annexure "F")**
- 7) That, on 07/02/2020, in the light of above said notification dated 20/12/2013, respondent No.2 issued a promotion order from SCT to SST post in which the most junior teachers from the appellant, placing at sr. No.5 to Sr.No.23 and in Seniority List No.139 to 169, were promoted but the appellant was ignored / differed from promotion and respondent No.3 issued adjustment orders of the said promotes on 14/02/2020. **(Copy of adjustment order dated 14/02/2020 is attached as Annexure "G")**
- 8) That, appellant badly suffered by the above said order and appellant submitted an appeal dated 06/03/2020 before respondent No.1 at which respondents assured the appellant that in the next promotion order, the appellant will surely be promoted. **(Copy of the appeal dated 06/03/2020 is attached as Annexure "H")**
- 9) That, on 08/12/2020, respondent No.2 once again issued promotion orders from SCT to SST posts in the light of Notification dated 20/12/2013 and respondent No.3 also issued adjustment order on 11/12/2020 but the name of appellant was once again differed from the promotion of SST post although appellant submitted necessary / required documents before respondent No.3 before the DPC meeting held on 11/09/2020. **(Copy of order dated 11/12/2020 is attached as Annexure "I")**

10) That, appellant badly suffered from the order dated 08/12/2020 and from the act of respondents No. 2&3 due to which appellant filed a departmental appeal before respondent No.1 on 07/01/2021 which was not honored.

(Copy of departmental appeal 07/01/2021 is attached as Annexure "J")

11) That, the appellant assails the impugned promotion notifications on the following amongst other grounds:-

GROUND:

- a. That, the seniority of any employee is to be considered from the date of first appointment of the employee according to the Rules, Law and Policy.
- b. That, according to the Judgment of August Supreme Court of Pakistan (2004 PLC (C.S) 1228) any permanent basis appointed employee, could never become underside from his junior in seniority.
- c. That, the impugned Notifications/orders were issued only at the basis of malafide intention in which law and Rules were not followed.
- d. That, due to the impugned notification/orders, the service career of the appellant is being suffered badly alongwith financial loss.
- e. That, the appellant fulfills all the codal formalities for promotion into SST post because the appellant have prescribed qualification alongwith seniority cum fitness.
- f. That, there is no such kind of order was issued against the appellant under section-4 of the E&D Rules 2011, by the competent or Hire authority due to which the promotion of appellant was liable to be stopped.
- g. That, respondents ignored the appellant from promotion which is not in the jurisdiction of respondents thus, respondents exceeded their power and intentionally ignored the appellant from promotion only to mentally torture the appellant.

- h. That, up to 2003 all the departmental promotions or fresh appointments through Public Service Commission were made as per the qualification, of which the appellant is now holder and, now creating any hurdle on the part of respondents, in the promotion of appellant, is totally illegal and against the Article 25 of the Constitution of Islamic Republic of Pakistan 1973.
- i. That, the instant appeal is well within time.
- j. That, the other point shall be raised at the time of argument with the prior permission of Hon'ble Tribunal.

It is therefore, respectfully prayed that the instant appeal may graciously be accepted, and the appellant may kindly be promoted w.e.f. the date at which the most junior teachers from the appellant were promoted to SST post with all back benefits. Any other relief for which the appellant is entitled and same is not asked/prayed specifically, may kindly be granted in the favour of the Appellant too.

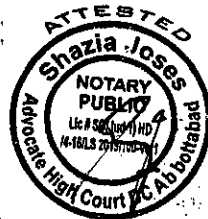
