Through this appeal, the appellant has impugned order dated 25.02.2021 of respondent No. 3, whereby the transfer order dated 09.02.2021 of the appellant, available at page 30 of the file, has been cancelled purporting the same in interest of public service. Learned counsel for the appellant contends that the appellant in compliance with transfer order dated 09.02.2021 took-over the charge and quite after a short time of about 15/16 days, the same was cancelled apparently for no just reason. Let the respondents be put on notice to justify the necessity of the impugned order. The appeal is admitted to full hearing, subject to all just and legal objections, including that of limitation to be determined during full hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. File to come up for arguments on 13.10.2021 before the D.B at camp court, Abbottabad.

At the end of memorandum of appeal, prayer for interim relief has been made. Accordingly, it has been prayed to restrain the respondent No. 3 from appointment of any other person against the post lying vacant at GGPS Karka Syedan. The respondents are directed to maintain status quo in respect of the said post till disposal of the appeal.

PRAYER:-

On acceptance of the instant service appeal, impugned order dated 25.02.2021 may kindly be set-aside or in alternative the respondents be directed to transfer the appellant to school near by her residence where vacant post are available.

Respectfully Sheweth:-

BRIEF FACTS:-

1. That, appellant was appointed as PST in GGPS Phalkot, vide order No. 14430-14548/Estt: (F) Appt: (PST) 2017 dated 02.08.2017 on Adhoc/Contract basis. The service was regularized on the same post in BPS-12 vide office order No. 1748-1989 dated 06-04-2018. The appellant performed her duty in the said school since the first appointment, till the issues of mutual transfer order dated 09.02.2021.

(Copies of appointment order regularization order are annexed as Annexure "A" and "B").

2. That, maximum tenure in hard area is two years as per policy of KP Education

Department and the GGPS Phalkot is situated in hilly and hard area and appellant had to reach school by hiring 4x4 vehicle as ordinary public traffic is not available. Similarly, appellant had to reach school some time on foot due to non availability of private vehicle and appellant being a teacher could not afford for her to hire jeeps on regular basis.

3. That, appellant on completion of two years tenure, requested respondent No. 03 time and again for her transfer to any of schools having vacant posts any way in the same union council or other union councils in District Mansehra, nearby to the residence of the applicant, but with no response.

(Copies of applications are annexed as Annexure "C").

4. That, appellant was told by the respondent No. 03 that she only has an option for mutual transfer, so appellant arranged same with one Mst. Bibi Zahida PST, posted at GGPS Karka Syedan for mutual transfer.

5. That, thereafter respondent No. 03 issue a mutual transfer order No. 2193-97 dated 09.02.2021.

(Copy of mutual transfer order is annexed as Annexure "D").

6. That, after issuance of said mutual transfer order Mst. Zahida took charge of the GGPS Phalkot on 10.02.2021. The charge report was properly received at SDEO office on 22.02.2021 under diary No. 3087.

(Copy of charge report of Ms. Zahida is annexed as Annexure "E").

7. The appellant took charge in the GGPS Karka Syedan on dated 11.02.2021.

(Copy of arrival report is annexed as Annexure "F").

8. That, **respondent No. 03** again issued impugned order Endst No. 2950-52 on dated 25.02.2021 whereas the order **No. 2193-97/M/TRANSFER/ PST/SPST/PSHT DATED 09.02.2021** was cancelled without any reason.

(Copy of impugned order annexed as Annexure "G").

9. That, the standard inquiry questionnaire for the mutual transfer was issued by the inquiry officer on the order of the respondent No. 03 to both the teachers on 02.03.2021.

(Copy of inquiry questionnaire format is annexed as Annexure "H").

10. That, the appellant and the other teacher in mutual transfer submitted the said inquiry questionnaires in writing on 02.03.2021, thereby

mentioning the actual situation in that format. Same were duly received at the office of respondent No. 03 on the same date. The same inquiry report was kept confidential and was not shared with the appellant till date.

(Copy of filled inquiry formats submitted on dated 02.03.2021 is annexed as Annexure "I" and "J").

11. That, other mutual orders were also issued by Respondent NO-3 but no action was taken against this order and case is almost same.

(Copies of other mutual orders is annexed as Annexure "K").

12. That, aggrieved from the impugned order, appellant filed a Departmental appeal before respondent No. 02 on 03.03.2021, which has not been responded so far.

(Copy of Departmental appeal dated 03.03.2021 Annexed as Annexure "L").

13. That, under section 4 of the Civil Service Act, after the collapse of the 90 days of the departmental appeal, from where no response is received to the appellant, hence this appeal.

GROUND:-

- A) That, as per policy of E&SE Department Government of KPK the tenure of posting at hard area is two years and after passage of this period, a teacher is eligible for transfer to nearby areas.
- B) That, when the transfer of appellant was made, no objection was raised by anyone, nor any appeal was filed in this regard, but changing the position, all of sudden, by respondent **No. 03** is a mind boggling and a totally absurd exercise, mala-fide, violating the rights of the appellant.
- C) That, due to the impugned order vested service rights of the appellant have been violated and infringed for no justifiable reason at all.
- D) That, before revising the impugned order, due process of law was not followed by the respondent No. 03 including opportunity of being heard before cancelling the order, due to which, legal rights of the appellant stood violated.

E) That, another teacher was posted as fresh appointment at this school vide office order No. 4756/88 dated: 10.04.2021. The status of the said fresh appointee was unclear from the last two months, until she took charge in this school i.e. GGPS Phalkot on 28.06.2021 this way with her joining at this school now the number of teachers is two instead of a single teacher and by transfer of the appellant there is no threat of the closure of school and now even the one teacher policy is not applicable in this case.

F) That, upon applications among the multiple applications moved by the applicant it was responded by the respondent No. 3 and even mentioned at the e-transfer portal that as per policy, the single teacher or two teachers (less than three teachers) at a single school cannot be transferred.

(Copies of the applications, responses from E-Transfer Portal and E-Transfer Policy are annexed as Annexure "N", "O" and "P").

G) That, it is on the record that in other cases, the respondent No. 3 followed

the tenure policy notwithstanding the fact that question of single teacher was there in all the cases. But the appellant is being treated discriminately which is clear violation of fundamental rights of the appellant.

(Copy of adjustment order as Annexure "Q").

- H) That, all these facts clearly suggest that the respondents are making the appellant a scapegoat under the pretext of single teacher and e-transfer policy.
- I) That, appellant reserves the right to raise any other ground available at the time arguments.

.....PRAYER.....

That in the light of above mentioned fact and circumstances, it is humbly prayed that on acceptance of instant appeal impugned order dated 25.02.2021 may kindly be set-aside or in alternative the respondents be directed to transfer the appellant to school near by her residence where vacant post are available.

INTERIM RELIEF:

Respondent No. 02 may kindly be restrained to appoint any other person against the posts lying vacant at GGPS Karka Syedan or anywhere nearby to the residence of the appellant till the final disposal of instant appeal.

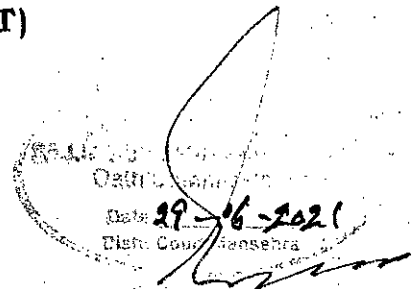

5. The documents of any PST teachers whose have already verified or still not verified found fake or bogus in any stage their regularization will be withdrawn automatically.





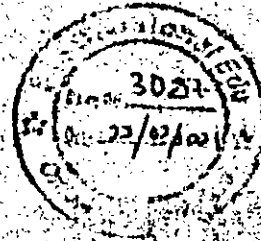

No.SO(ISM) E&SED/7-1/2020/PT/General: In order to facilitate the Teaching Cadre Employees and to Streamline and standardized/ automate the Process of posting / transfer, the Competent Authority is pleased to approve the E-Posting/Transfer policy for the Employees of the Teaching Cadre (BS-12 to BS-18) of E&SE Department Khyber Pakhtunkhwa with immediate effect, in the best public interest.

E-TRANSFER POLICY OF TEACHING CADRE (BS-12 to 18) IN E&SE DEPARTMENT KHYBER PAKHTUNKHWA

- i. The introduction of e-Transfer policy for Teaching Cadre shall supersede all previous e-posting/transfer policies in the E&SE Department.
- ii. This policy covers transfers related to intra district transfers of district cadre post and inter district transfers of Provincial cadre posts.
- iii. Transfers on Complaint (Administrative Ground), Mutual basis, inter district and transfer for Operationalization of Newly Established schools, newly created posts will be exempted from the present policy.
- iv. Transfers shall be made at least once a year, preferably at the end of academic year.
- v. The vacant positions will be uploaded by the District Education Officers for all teaching cadres (BS-12 to BS-18).
- vi. The Education Monitoring Authority will provide requisite data as per format provided by the Director EMIS.
- vii. Each Competent Authority shall visit the Dashboard of e-Transfer app, check and verify all the particulars of the applicants.
- viii. The teachers appointed on Contract/Adhoc basis shall remain non transferable until regularized.
- ix. The Teachers in Schools having 2-teachers are not allowed in the e-transfer policy for transfer.
- x. Inter district transfer against senior positions (100% District promotion Quota) i.e. SCT, SDM, SPET, SAT, STT, S-Qari, SPST and PSHT are not allowed neither manually nor through e-transfer.
- xi. Transfer shall be made only against the vacant posts.
- xii. Teachers bearing Minimum tenure of two years on the present post in the present school will be eligible for e-posting/transfer.
- xiii. In case of same score of two or more candidates, merit will be 1st on Seniority, then by Date of Birth and if there is tie, then on first come first get basis.
- xiv. Subsequently Transfer orders generated by e-Transfer App will be issued.
- xv. Each Competent Authority shall constitute a Grievance Redressal Cell headed by a BPS-18 or above officer which will resolve the grievances and determine the merit position of the applicants within a week positively.
