30.08.2019 AND PROMOTION ORDER DATED 11.12.2019
ARE ILLEGAL AND AGAINST THE LAW, WHEREAS, THE
JUNIORS, IN TERMS OF THEIR LENGTH OF SERVICE HAVE
BEEN PROMOTED BY VIOLATING THE LAWS, RULES,
POLICY AND PROCEDURE OF PROMOTION AND
PROMOTION ORDER OF PETITIONER DATED 02.05.2019
TO BE IMPLEMENTED IN ITS TRUE LETTER AND SPIRIT**

**PRAYER : *On acceptance of the instant service appeal
the impugned final seniority list dated
30.08.2019 and promotion order dated
11.12.2019 of respondents No.5 to 18 may
graciously be set aside and respondents No.1
to 3 be directed to issue promotion order w.e.f
02.05.2019 of BPS-11 with all back benefits of
petitioner as per DPC approval. Any other relief
which this Honorable Court deem proper may
also be granted to the petitioner in the best
interest of justice.***

Respectfully shewth:

1. That the appellant was appointed as Village Secretary (BPS-07) on 21.09.2015. Copy of appointment order is annexed as **Annexure "A"**.
2. That the respondent No.3 prepared seniority list of Secretaries dated 26.12.2016 according to their date of charge and date of birth as per existing policy. Copy of final seniority list dated 26.12.2016 is annexed as **Annexure "B"**.
3. That final seniority list dated 26.12.2016 maintained vide No. AD(LG-H)/1-25/2017/1911-15 dated 03.04.2019, which was acceptable to all the employees including the petitioner, for the reason of being in line and in accordance with law/rules of promotion. Copy of seniority list alongwith covering letter No.AD(LG-H)/1-25/2017/1911-15 dated 03.04.2019 is attached herewith as **Annexure "C"**
4. That respondent No.3 called DPC and DPC was held on 02.05.2019 whereby petitioner was promoted from BPS-9 to BPS-11 by the DPC and as per approval of DPC the petitioner promotion order has not been issued whereas the Drivers and others mentioned in DPC were promoted and receiving salaries. Copy of DPC minutes of meeting dated 02.05.2019 is annexed as **Annexure "D"**.

5. That the respondent No.3 issued seniority list by violating law, rules and policy vide letter No. AD(LG-H)/1-15/VCS-NCs/2018/3928 dated 30.08.2019 whereby the petitioner was placed on at S.No.28 in the final seniority list which was illegal and against the norms of justice. Copy of letter No. AD(LG-H)/1-15/VCS-NCs/2018/3928 dated 30.08.2019 and seniority list are annexed as **Annexure "E"**.

6. That respondent No.3 illegally and unlawfully held departmental selection and promotion committee on 11.12.2019 in which the respondents No. 5 to 18 were promoted from BPS-9 to BPS-11 which shattered the principle of supremacy of law and natural justice. Copy of impugned minutes of meeting dated 11.12.2019 is annexed as **Annexure "F"**.

7. That the petitioner alongwith Muhammad Akmal have filed appeal before the Director General(LG&RDD) and Secretary Local Government and Rural Development Department, Khyber Pakhtoonkhawa, Peshawar against the final seniority and promotion of respondents No. No.5 to 18 wherein illegalities and irregularities committed by the respondent No.3 as petitioner was entitled for promotion in BPS-11 as per recommendation of DPC dated 02.05.2019 but no heed was paid to the departmental appeal. Copies of departmental appeals are annexed as **Annexure "G"**.

8. That the petitioner feeling aggrieved from the illegal final seniority and promotion of respondents No.5 to 18 being junior inter-alia on the following grounds

GROUND:

- (a) That the impugned seniority list dated 30.08.2019 and promotion order dated 11.12.2019 of respondents No. 5 to 18 are unlawful, fanciful, and discriminatory, against the promotion rules, and is a result of colourful exercise, hence, liable to be set aside and promotion of petitioner dated 02.05.2019 is liable to be implemented in true letter and spirit.
- (b) That, the impugned final seniority list and promotion of respondents No. 5 to 18 are against the policy being repeated violation committed by respondents from a settled rules, policy and procedure, hence, liable to be set aside and promotion of petitioner dated 02.05.2019 is liable to be implemented in true letter and spirit.
- (c) That the respondent No.3 violated the clear direction laid down in Section 8(4) of KPK Civil Service Act, 1973, clearly reveals that seniority in post, service or cadre to which a civil servant is promoted, shall take effect from the date of regular appointment to the post, hence the impugned final seniority list and promotion of respondents No. 5 to 18 are liable to be set aside being unlawful and against the policy.
- (d) That KPK Civil Servants (Appointment, Promotion & Transfer) Rules, 1989, also lay down the rule of inter se seniority of civil servants in certain cadre to which promotion is made from different lower posts, carrying the same pay scale shall be determined from

the date of regular appointment/promotion of the civil servants in the lower post , provided that if the date of regular appointment of two or more civil servants in lower post is the same , the civil servant older in age , shall be treated senior, hence the respondent No.3 committed great illegality and violated the rules and regulation, hence, liable to be set aside and promotion of petitioner dated 02.05.2019 is liable to be implemented in true letter and spirit.


- (e) That the respondent No.3 committed grave miscarriage of justice and favouritism, promoted the respondents No. 5 to 18 due to nepotism.
- (f) That, it was well understood and obvious that the promotions will be carried out according to date of appointment and quantum of age but the illegalities committed by respondent No.3.
- (g) That, the constitution of land provides protection and safeguard from all kinds of discrimination and ensures that every citizen will be dealt, strictly in accordance with law and principles of equality and warns every colourful exercise or misuse of any vested power or mandate but the respondents neither took into consideration the commands of constitution nor followed the laws, legislated and promulgated under its guidelines.
- (h) That, the petitioner has exhausted all the forums and necessary legal requirements/formalities, prior to filing of instant appeal and all the related documents, in this context, have been annexed herewith, for kind perusal of this Honourable tribunal.

It is therefore most humbly prayed that on acceptance of the instant service appeal the impugned final seniority list dated 30.08.2019 and promotion order dated 11.12.2019 of respondents No.5 to 18 may graciously be set aside and respondents No.1 to 3 be directed to issue promotion order w.e.f 02.05.2019 of BPS-11 with all back benefits of petitioner as per DPC approval. Any other relief which this Honorable Court deem proper may also be granted to the petitioner in the best interest of justice.

**THE KHYBER PAKHTUNKHWA EPIDEMIC CONTROL AND EMERGENCY
RELIEF ACT, 2020**

(KHYBER PAKHTUNKHWA ACT NO. XXVII OF 2020)

(First published after having received the assent of the Governor of the Khyber
Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa.
(Extraordinary), dated 24/07/2020)

AN
ACT

*to provide for prevention and control of infectious diseases
in the Province of the Khyber Pakhtunkhwa and to provide
relief to the people in emergency situation.*

WHEREAS it is expedient to provide for prevention and control of infectious diseases in the Province of the Khyber Pakhtunkhwa, to implement and enforce mechanism to control the spread of such diseases and to provide relief to the people in an emergency situation arising due to spreading of such infectious diseases and for matters connected therewith and ancillary thereto;

AND WHEREAS it is necessary to amend certain laws relating to public health and disaster management in order to bring them at par in combating the epidemic and other infectious diseases;

It is hereby enacted as follows:-

**PART-I
PRELIMINARY**

- 1. Short title, extent and commencement:--** (1) This Act may be called the Khyber Pakhtunkhwa Epidemic Control and Emergency Relief Act, 2020.
 - (2) It shall extend to the whole of the Province of Khyber Pakhtunkhwa.
 - (3) It shall come into force at once.
- 2. Definitions.—** In this Act, unless the context otherwise requires,-
 - (a) "declaration" means the declaration of a serious and imminent infection threat, made under section 3 of this Act and may also include declaration of any emergency relating to outbreak of any disease under any law relating to public health and disaster management;

28. Relief by Government.--- (1) Notwithstanding anything contained in any other law, for the time being in force, Government may,-

- (a) provide total or partial exemption, suspension or deferral of the payment of the provincial taxes, duties, fees, cess, levies and charges in the manner as may be notified; and
- (b) appoint the health staff on short term contracts under locum tenens or otherwise, with such package and on such terms and conditions as the Government may specify:

Provided that the health staff, hired for short-term services under clause (b) of this sub-section, shall not be entitled to any permanent status, regularization or absorption into Government service in any manner.

(2) No penalty or surcharge shall be imposed for late submission of sales tax or other returns under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013) by the relevant authorities for the months of March 2020 to June 2020.

29. Courts proceedings to be through video link.--- (1) Notwithstanding anything contained in any law, for the time being in force, all the Courts and Tribunals, wherever possible, may direct any litigant, accused, witness, legal representative or any other person or officer of the Court to participate in any proceeding of the Court, through video link:

Provided that while giving such directions the Courts or Tribunals, as the case may be, must consider all the circumstances of the case and may rescind such directions where it appears to the Court or the Tribunal that it is not in the interest of justice to do so.

Provided further that any proceedings so undertaken through video link shall be considered judicial proceedings and shall form part of the record. Upon pronouncement of a decision upon such proceedings, it shall not be called in question on the ground that presence of persons concerned was not procured physically.

(2) The powers of the Court or Tribunal under this section are in addition to and not in derogation of any other powers already available to such Courts or Tribunals, in this respect.

(3) High Court, if so deems appropriate, may issue guidelines for regulating the proceedings before Courts or Tribunals through video-link, which guidelines, if so issued, shall be notified in the official Gazette and shall be binding on all concerned.

30. Period of limitation under various laws.--- Notwithstanding anything contained in the Limitation Act, 1908 (Act No. IX of 1908) or any other law prescribing limitation for initiating any legal proceedings, the limitation period provided under various laws shall remain frozen from 1st March 2020 till the culmination of the emergency period and the proceedings so filed before any court or tribunal during or immediately upon cessation of such emergency period, shall not be time-barred on account of any delay for the aforesaid period.
