

REGARDING THE ADVERSE REMARKS OF RESPONDENT
NO.2 IN THE ACR FOR year 2020 BE DECLARED ILLEGAL
AND NULL & VOID AND EXPUNGED.**

**PRAYER :- *On acceptance of the appeal, the impugned
order dated 07.04.2019 of learned respondent
No.1 and order dated 24.11.2021 of Honorable
Respondent No.3 may graciously be set aside
and adverse remarks in ACR for the period of
2020 be expunged being illegal, unlawful and
against the facts and circumstances. Any other
relief which this Honorable Court deem proper
may also be granted in the best interest of
justice.***

Respectfully Sheweth:-

Brief facts giving rise to the present appeal are arrayed as under:-

1. That the appellant is permanent employee of District Judiciary Haripur since 20.03.2008 and presently performing his duty as Reader/Junior Clerk in the Court of learned Additional District & Sessions Judge-IV, Haripur. Copy of appointment order is annexed as **Annexure "A"**.
2. That the appellant has performed his duties since his appointment in different courts on different posts with honesty, dedication and devotion to the satisfaction of his all presiding officer including reporting officer, no any written or oral complaint against the appellant available on my service record, in this regard previous ACRs shows the honesty and performance of the appellant.
3. That during the posting with the respondent No.2/ Reporting Officer, the ACR of the appellant for the period of 2021 communicated adverse remarks against the appellant.
4. That on the adverse remarks in the ACR by the reporting officer/respondent No.2, the learned respondent No.1 District & Sessions Judge agreed with the reporting officer and issued impugned letter No. 2799-PF-ACR/D&SJ dated 07.04.2021 with direction to prefer representation before

competent authority. Copy of impugned letter dated 07.04.2021 is annexed as **Annexure "B"**.

4. That the appellant filed appeal/representation before the Honorable Respondent No.3 against the adverse remarks in the ACR for year 2020. Copy of departmental appeal/representation dated 12.04.2021 is annexed as **Annexure "C"**.
5. That the Honorable Respondent No.3 vide letter No. 688/Confdl dated 24.11.2021 dismissed the appeal of appellant. Copies order of respondent No.3 dated 24.11.2021 alongwith covering letter of respondent No.1 are annexed as **Annexure "D"**.
6. That appellant aggrieved from the impugned orders of respondents knock the door of this Honourable Court for setting aside the orders of respondents on the following grounds:-

GROUND OF APPEAL:-

- (a) That the orders of respondents are illegal, unlawful and against the law, hence untenable in the eye of law.
- (b) That prior to posting with reporting officer/ respondent No.2, the appellant performed his duties in different courts including Sub-Division Ghazi, the

appellant remained posted for about more than 9-years during different tenures and there are no single adverse remarks against the appellant in ACRs are good, very good and excellent, the impugned order regarding adverse remarks in the ACR for the period of 2021 be declared expunged.

- (c) That the appellant had posted as "Reader" in the Court of Reporting Office in the year 2019, during the said period under report, the appellant performed his duties as Reader with quite honestly and to the best of my abilities and skill, but the reporting officer/ respondent No.2 recorded adverse remarks in ACR of appellant for the year 2020 without any substantiating incriminating material, contrary to the facts and ground realities having dissention and bias against appellant. The adverse remarks communicated to the appellant are without any proof or substantiating material, hence liable to be expunged.
- (d) That the appellant was condemned unheard, prior to recording the above mentioned adverse remarks, the reporting officer never served the appellant with any warning, advice or counseling notice, Under Article 10-A of the Constitution of Islamic Republic of Pakistan, notice to the appellant was necessary prior to recording of adverse remarks and no opportunity

of personal hearing, reply, or defense was accorded to him, during the period under report, no explanation, show cause notice, or warning was issued to the appellant by the learned respondents No.1&2 with regard to his conduct and service. Even no complaint from any corner or any inquiry was against the appellant with regard to said remarks in ACR, hence the adverse remarks in ACR need to be expunged.

- (e) That the appellant assigned duties as "Reader" for the period under report, with utmost devotion, responsibility and honestly without any fault on his part, the dates in cases were fixed under the direct supervision of reporting officer, no error, omission or fault was found and the remarks of reporting officer in this regard "checked and found correct" but the reporting officer suddenly recorded adverse remarks in ACR contrary to the facts and ground realities having dissention against the appellant, hence the adverse remarks in ACR need to be expunged
- (f) That the ACR always prepared on the available record per annum, during the said period the appellant has not issued any explanation/warning letters, show cause notice to appellant as alleged by the reporting officer/respondent No.2 in his adverse remarks, which shows the malafide intention of reporting

officer with the appellant, all the proceeding were initiated one-side against the appellant, which is liable to be declared null, void and expunged in the best interest of justice.

- (g) That the valuable rights of the appellants are involved in the instant service appeal which is well within time.
- (h) That other points will be agitated at the time of arguments.

In the light of above stated facts it is humbly prayed that on acceptance of the appeal, the impugned order dated 07.04.2021 of learned respondent No.1 and order dated 24.11.2021 of Honorable Respondent No.3 may graciously be set aside and adverse remarks in ACR for the period of 2020 be expunged being illegal, unlawful and against the facts and circumstances. Any other relief which this Honorable Court deem proper may also be granted in the best interest of justice.


