- 2) That petitioner having M.A (Political Science), M.Ed from Shah Abdul Latif Bhitai University, Khairpur (sind). (Copies of credentials of petitioner are attached as Annexure "A").
- That the petitioner was appointed as PTC teacher vide order dated 01.10.1989 in BPS-7, presently working as PST in BPS 15 at Dheri Hamid Mian. (Copy of first appointment order is attached as Annexure "B").

- 4) That on 19.12.2020 respondent No.2 issued notification for promotion of different categories of teachers including PST. As per mentioned notification teachers were promoted/ upgraded who are having lesser length of service than petitioner (Copy of notification is attached as Annexure "C").
- 5) That petitioner approached the respondents for the redressal of his grievances but till date no positive reply given rather verbally informed the petitioner that seniority will count from the date of completion of training.
- 6) That petitioner being aggrieved and finding no other efficacious remedy but to invoke the constitutional jurisdiction of this hon'ble court on following grounds:

#### **GROUNDS:**

- a. That as per judgment of the Apex Court seniority will always be counted from the date of appointment not from the date of completion of training. Hence stance of respondents is not tenable in the eyes of law.
- b. That section 24-A of General Clauses Act has been violated but the respondents are not performing their statutory duty to redress the grievance of petitioner within department, without Deputy Registrar
- c. That upgradation is not falling within the terms and conditions of service.
- d. That petitioner has a fundamental right under Article 4 of Constitution of Pakistan 1973 to be dealt in accordance with law but ignoring aforementioned section of law is violent disregard of fundamental right of petitioner.
- e. That the criteria for upgradation is seniority-cum-fitness, which in fact means length of service and admittedly length of

service of petitioner is greater than others mentioned in the notification.

f. That respondents have executed their powers and jurisdiction by enjoying their own innovation and monopoly creating hurdles for petitioner, by giving him discriminatory treatment which deprived him of his legally vested rights.

It is, therefore, humbly prayed that on acceptance of this writ petition, petitioner may please be promoted/ upgraded to BPS-16 from BPS-15.

Any other relief which this hon'ble court deems appropriate in the circumstances of the case though not specifically asked for may kindly also be granted.


