



Learned counsel for the appellant while opening his arguments pleaded that the appellant was initially appointed as PET (BS-09) on 16.02.1991. She was promoted to the post of senior PET (BS-16) vide notification dated 21.02.2013 with immediate effect. She was further promoted to the post of Director Physical Education (DPE) (BS-17) vide notification dated 11.05.2017. The appellant was having the requisite qualification as per notified service rules dated 13.11.2012 and as such she was required to have been considered for antedated promotion from the due date of her initial appointment as she had acquired the requisite qualification before joining her service. The same was challenged through departmental appeal dated 23.06.2021, however it was not responded to within the stipulated period, hence, the instant service appeal was filed in the Service Tribunal on 28.09.2021. Moreover, fresh cause of action is the seniority list of BS-18 officer and serial No. 1 is even junior in service to the appellant. Learned counsel for the appellant could not respond to a question that the seniority list (senior Instructor, Physical Education (BS-18) Female) does neither contain the exact date nor duly signed and circulated by the authority, does not seem to be a valid document but a computer print to have been included with the memo of appeal. Let pre-admission notice be issued to submit reply before admitting the case provisionally for regular hearing. To come up for preliminary hearing on 15.03.2022 before S.B.







**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED INACTION OF THE OFFICIAL RESPONDENTS BY NOT GRANTING REGULAR PROMOTIONS TO BPS-16 W-E-F 11-05-1999 (FROM THE DATE OF ACQUIRING THE PROFESSIONAL QUALIFICATIONS), BPS-17 W-E-F 19-05-2009 AND SUBSEQUENT PROMOTION TO BPS-18 W-E-F 23-05-2018 AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEALS OF THE APPELLANT WITHIN THE STIPULATED PERIOD OF NINETY DAYS.**

**PRAYER:**

That on acceptance of this service appeal the respondents may please be directed to consider the appellant for regular promotion to BPS-16 w-e-f 11-05-1999 then for regular promotion to BPS-17 w-e-f 19-05-2009 and subsequently for regular promotion to BPS-18 w-e-f 23-05-2018 with all back benefits including seniority. Any other remedy which this August Tribunal deems fit that may also be granted in favor of the appellant.

**R/SHEWETH:**

**ON FACTS:**

**The appellant submits as under:**

- 1- That the appellant was initially appointed as PET (BPS-9) in the respondent department vide order dated 16-02-1991. Copy of the appointment order is attached as annexure .....**A.**
- 2- That the appellant is a highly qualified in her respective filed of Physical Education and had acquired Diploma/ certificates/ degree of P.E.T in the year 1998, JDPE on 11-05-1999 as well as having/ obtained Master of Physical Education in the year 2010 from a recognized university. Copies of the educational testimonials are attached as annexure .....**B & C.**
- 3- That it is important to mention here that vide notification dated 13-11-2012 the service structure/ rules of the appellant cadre along with other were notified and vide serial No. 9 of that rules the appellant was entitled for promotion to the post of Senior Physical Education Teacher (BPS-16) w-e-f 11-05-1999 but the appellant was ignored. Copy of the notification dated 13-11-2012 is attached as annexure .....**D.**
- 4- That the appellant was promoted to the post of Senior Physical Education Teacher (BPS-16) vide order dated 21-02-2013 irrespective of the fact that the appellant was entitled for that post w-e-f 11-05-1999 i.e. from the date when she had obtained the required one year

diploma in the physical education. Copy of the order dated 21-02-2013 is attached as annexure .....E.

5- That vide order dated 11-05-2017 the appellant was again promoted to the post of Director Physical Education (BPS-17) with immediate effect but it is important to mention here that juniors to the appellant were promoted to BPS-17 w-e-f 19-05-2009 and all the private respondents are amongst those promtees. Copy of the promotion order dated 11-05-2017 is attached as annexure .....F.

6- That it is pertinent to mention here that the private respondents/ juniors to the appellant were promoted to the post of Senior Instructor Physical Education (BPS-18) w-e-f 23-05-2018 and the private respondents are juniors to the appellant.

7- That vide impugned seniority list of the Senior Instructor Physical Education (BPS-18) the private respondents i.e. from serial No. 10 to serial No. 55 of the impugned seniority list of the year 2020 all the private respondents are juniors from the appellant but astonishingly they were promoted in the year 2018 and the appellant was ignored time and again and hence the private respondents being junior to the appellant are made seniors. Copy of the seniority list of the Senior Instructor Physical Education of the year 2020 is attached as annexure .....G.

8- That the appellant feeling aggrieved from the erroneous/ impugned seniority list and the inaction of the official respondents by not granting BPS-16, BPS-17 and BPS-18 as per the law and rules prevail preferred a departmental appeal/ representation before the appellate authority but no response has been given within the stipulated period. Copy of the departmental appeal is attached as annexure .....H.

9- That feeling aggrieved from the inaction of the respondents and having no other remedy the appellant preferred the instant appeal on following grounds inter alia.

**GROUND:**

A- That the impugned seniority of the senior instructor physical education (BPS-18) to the extent of private respondents and inaction of the official respondents by not granting BPS-16 w-e-f 11-05-1999, BPS-17 w-e-f 19-05-2009 and BPS-18 w-e-f 23-05-2018 are against law, facts, norms of natural justice and material on record hence liable to be set aside/ modified.

B- That appellant has not been treated by the respondent department in accordance with law and rules on the subjected noted above and as such respondents violated the Article 4 and 25 of the Constitution of Islamic Republic of Pakistan.

C- That the appellant has been discriminated by the respondents while issuing the impugned seniority whereby juniors to the appellant have been placed seniors and not granting BPS-16 w-e-f 11-05-1999, BPS-17 w-e-f 19-05-2009 and BPS-18 w-e-f 23-05-2018.

D- That by issuing the impugned seniority list and not granting BPS-16 w-e-f 11-05-1999, BPS-17 w-e-f 19-05-2009 and BPS-18 w-e-f 23-05-2018 the respondents have violated section-8 and section- 9 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 and Rule-7 and Rule-17 of the Khyber Pakhtunkhwa (APT) Rules, 1989.

E- That the respondents acted in arbitrary and mala fide manner while issuing the impugned seniority.

F- That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.
