Appeal Under Section 4 of the Service Tribunal Act, 1974, against act, omission and denial of respondents to reinstate the appellant against the post of Projectionist (BPS-13).

<u>Prayer:</u>

On acceptance of this appeal, the act, omission and denial of respondents to reinstate the appellant as well as to cancel the retirement of appellant, be declared illegal, unlawful, unconstitutional and void and respondents may please be directed to reinstate the appellant against the post of Projectionist (BPS-13).

Any other relief not specifically prayed for, but this Hon'ble Tribunal deems proper may also be granted.



- 1. That appellant was serving against the post of Projectionist (BPS-13) at District Population Welfare Office, since 20-12-1994.
- 2. That during service, appellant suffered from Epilepsy, for which appellant remained under treatment from the concerned doctors, however when appellant did not recovered from the ibid disease, an application dated 17-09-2018 for early retirement was filed before respondent No. 3, which was forwarded / processed to rest of the concerned respondent (Copy of application is annexure A).
- 3. That after filing the aforesaid application, appellant was referred for expert opinion vide letter bearing No. 2532-34 dated 17-09-2018 to Medical Superintendent Saidu Group of Teaching Hospitals, Saidu Sharif, Swat, whereupon appellant was examined and found to be suffering from Epilepsy, moreover it was also opined that appellant is unable to perform his duties and may be retired on medical ground, which was forwarded to respondent No. 2 vide letter No. 3553-57 dated 09-10-2018 (Copies of letter dated 17-09-2018, medical certificate dated 08-10-2018 along with covering letter and letter dated 09-10-2018 are annexure B).
- 4. That consequent upon the aforesaid medical certificate, appellant was directed to be retired on medical grounds with effect from 08-10-2018 vide order bearing F.No.3(9)95-2006/Admn-Vol-IV:/7962-68 dated 19-10-2018 (Copy of order dated 19-10-2018 is annexure C).
- 5. That vide letter dated 20-10-2018, respondent No. 2 was requested for compilation of pension papers of the appellant, however instead of compilation of the pension papers, the retirement order dated 19-10-2018

(inadvertently mentioned as 19-11-2018) was withdrawn vide order bearing F.No.3(9)95-2000/Admn-Vol-IV dated 22-07-2019, and appellant was directed to join the duty vide letter dated 30-07-2019 (Copies of letter dated 20-10-2018, order dated 22-07-2019 and letter dated 30-07-2019 are annexure D).

- That before withdrawal of the order dated 19-10-2018, some legal / requisite steps regarding the retirement were taken and ultimately the retirement of appellant was approved in August, 2020.
- 7. That after retirement, the treatment of appellant was kept continued and after regular treatment and with the grace of almighty Allah, appellant completely recovered from the aforesaid disease of epilepsy.
- 8. That after getting 100% recovery from the aforesaid sickness, an appeal was filed on 18-07-2022, before respondent No. 2 for reinstatement of the appellant against the post of Projectionist, which was not responded (Copy of appeal / application is annexure E).
- 9. That being aggrieved from the act, omission and denial of respondents to reinstate the appellant against the post of Projectionist, appellant approaches this Hon'ble Tribunal inter alia on the following grounds.

GROUNDS:

- i. That refusal of respondents to reinstate the appellant against the post of Projectionist, is illegal and unlawful.
- ii. That appellant has fully recovered from the sickness and is thus eligible to reinstated against the said post.

- iii. That being a healthy person and capable to perform his duties, appellant is entitle to be reinstated against the post of Projectionist.
- iv. That appellant has not attained the age of superannuation uptill now and is thus eligible to be reinstated against the said post.
- v. That earlier other persons have been reinstated, retired on medical grounds after their recovery from the sickness.
- vi. That appellant is entitled to be equally treated with the similarly placed persons and respondents are not authorized to make any discrimination with the appellant.
- vii. That there is no hurdle in acceptance of the present appeal.
- viii. Any other grounds not specifically raised will be argued with prior permission of this august court.

It is therefore very humbly prayed that, on acceptance of this appeal, the act, omission and denial of respondents to reinstate the appellant as well as to cancel the retirement of appellant, be declared illegal, unlawful, unconstitutional and void and respondents may please be directed to reinstate the appellant against the post of Projectionist (BPS-13).

Any other relief which is otherwise deemed proper, lawful, efficacious may also be granted in favour of appellant.


