PRAYER:

That on acceptance of this appeal the impugned minutes dated 15.04.2022 and subsequent Notification dated 11.8.2022 to the extent of appellant and private respondents may kindly be set aside and the appellant be promoted to the post of professor (BPS 20) when the private respondents were promoted to the subject post with all back benefits including seniority.

Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

<u>R/SHWETH:</u> ON FACTS:

- **1.** That the appellant is the employee of the respondent department and performing her duty as Associate Professor of Zoology (BPS-19) with zeal and zest and up to the entire satisfaction of the superiors.
- **3.** That vide letter dated 15.04.2022 minutes of the meeting of PSB held on 06.04.2022 regarding promotion of associate Professor (BPS 19) to the post of Professor (BPS 20) and its approval to the respondent No. 2. That the appellant at serial No. 14 was deferred on the basis of quantification irrespective of the fact that the service record of the appellant is much better than the pricate respondents and also the private respondents are juniours to the appellant. Copies of the letter dated 15.04.2022 along with minutes are attached as annexure......**B**.
- **5.** That having no other remedy the appellant preferred the instant appeal on the following grounds amongst others.

GROUNDS:

- **A.** That by not promoting the appellant to the post of Professor (BPS-20) and promoting the private respondents to the subject post vide impugned PSB decision and the inaction of the respondents are against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- **B.** That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

- **C.** That, the treatment meted out to the appellant is clearly based on discrimination and malafide and as such the respondents violated the principle of natural justice.
- **D.** That appellant is fully entitled to be promoted to the post of Professor (BPS-20) with all back benefits including seniority in light of the section 9 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 read with the Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion and Transfer) Rules, 1989.
- E. That respondents violated Article 38(e) of the Constitution of Islamic Republic of Pakistan 1973, according to which state is bound to eliminate disparity in the income and earning of individuals including persons in the services of the Federation, thus in light of the above quoted Article of the Constitution the respondents are duty bound to promote the appellant to the post of Professor (BPS-20).
- F. That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may very graciously be accepted as prayed for, please.






