Supreme Court of Pakistan in C.A 36/2014, which was dismissed on 05.05.2015, upholding the judgment of Peshawar High Court, where-after the petitioner was appointed but she was not given seniority alongwith her batch mates but also below the people who were appointed after the appointment of the batch mates of the petitioner compelling the petitioner to file appeal No.76/2018 before this Tribunal, which was decided on 07.09.2021. Learned counsel for the petitioner objects that the date in the column No. 4 of entry into service may be got corrected from the department to which learned Addl: AG very fairly submitted that let the matter be taken with the department in this regard. Representative of the respondents produced a copy of letter 5800/CA-I/Estt:Branch/A-12/Ms.Abida/Islamiyat dated No. 07.10.2022 addressed to the Secretary to Govt: of Khyber Pakhtunkhwa Higher Education Department, Peshawar, annexing therewith a tentative seniority list of Lecturers (Female cadre) and stating that in compliance with the judgment of this Tribunal dated 07.09.2021, name of the petitioner had been conditionally incorporated in the seniority list of Female Lecturers subject to the final outcome of the CPLA. The name of the petitioner is reflected at S.No.2 of the list. Learned counsel for the petitioner submitted that although the serial number on the seniority list was correct but the date of entry into government service was wrongly mentioned as 04.02.2014 instead of the date on which her batch mates of the original recommendation were appointed as was the spirit of the judgment passed in favour of the petitioner in writ petition No. 534/2011. The issue of date of appointment had been the subject matter of writ petition No. 534/2011 which was decided in favour of the petitioner with clear direction of issuance of appointment letter to the petitioner from the date of her first recommendation, which admittedly was the date when her batch mates were recommended and later on appointed ignoring the petitioner. The judgment of the Hon'ble Peshawar High Court was challenged before the august
