

The applicant submits as under:-



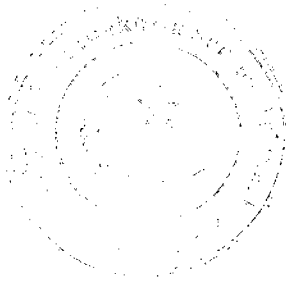
