SERVICE APPEAL UNDER SECTION 04 OF KP SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED TRANSFER ORDER DATED 18.05.2022

Case Summary: Appellant was promoted to the post of Primary School Head Teacher (Hereinafter referred to as 'PSHT') however he was posted as PSHT in a different Union Council instead of Union Council of his domicile in violation of the prevailing departmental policy despite a vacant PSHT post present in the same Union Council. (Policy **àttached herewith as 'F').**

 Appellant is the citizen of Pakistan with CNIC No. 17201-6245222-5 and resident of village Shaidu, Union Council Shaidu, Tehsil Jehangira, District Nowshera.

2. Appellant was appointed as a Primary School Teacher (Hereinafter referred to as 'PST') (BPS-12 which was BPS-07 at the time that is in 1990) in Education Department on 24.04.1990. After appointment the Appellant was allocated to Government Primary School No.2, Shaidu (hereinafter referred to as 'GPS No.2') which is Union Council Shaidu. Since his appointment the Appellant served for 25 years as PST in the same school.

Copy of the appointment letter is attached herewith as 'B'

- 3. In 2015, the Appellant was promoted as a Senior Primary School Teacher (BPS-14) (hereinafter referred to as SPST) in the Education department. After promotion the Appellant served in the same school as SPST for 7 years. In other words, the Appellant served in the same school for approximately 32 years.
- 4. On 18.05.2022, Departmental Selection Committee (hereinafter referred to as 'DPC') conducted its meeting to consider the Appellant along with other eligible employees of the department for promotion. In the same meeting, Appellant

along with other employees were promoted from SPST to PSHT (hereinafter referred to as 'Primary School Head Teacher').

Copy of the impugned office order is attached herewith as 'C

- 5. After promotion the Appellant was allocated to GPS No.1 Masam khel, Adamzai Union Council, Jehangira Teshil, District Nowshera. However, the post of PSHT was available in Government Primary School Sheenbagh, Shaidu that is the same union council as the Appellant was already serving in but the Appellant, in violation of the regular practice of the department and the policy, was allocated to GPS No.1 Masam Khel, Union Council Ademzai.
- 6. According to prevailing practice of the education department and as per the policy, if the post is available in the same school then the promotee is supposed to be promoted to the post in the same school whereas in case the post is not available in the same school then the promottee will be allocated to the same post in another school in the same union council and if the post is not even vacant in the same union council then the promottee will be transferred to the post in a school located in the nearest union council and so on.
- 7. It is because of the reasons stated in the above paragraphs that the other employees who were promoted to PSHT were allocated to the post available in the same union council. Only where the post was not available in the same union council were they allocated to the post outside their union councils.
- 8. It is also important to mention here that on 20.05.2022 the education department issued a corrigendum to their earlier

office order dated 18.05.2022 but the Appellant was still not reallocated to the post at his union council. After office order dated 18.05.2022, the department was legally required to wait for 15 days for any appeal that could potentially be filed against the decision before it can issue any corrigendum. However, as already stated the corrigendum was issued on 20.05.2022 that a day after the initial office order.

It is also important to mention here that the respondents because of pressures from the local member of parliament gave the said post to an employee, namely Abdul Basit through corrigendum dated 20.05.2022, who does not belong to the same union council and more importantly, said employee Abdul Basit was not promoted as a result of the office order dated 18.05.2022 but was promoted earlier through different order. However, same Abdul Basit was transferred to the GPS No.2 Shaikhi through the corrigendum dated 20.05.2022. The question arises, how can Abdul Basit be part of the corrigendum that was for the office order dated 18.05.2022. It clearly shows that the department as a result of the political pressures of the local MPA allocated their favourite to the said post through illegal means.

A copy of the corrigendum dated 20.05.2022 is attached herewith as 'D'

9. On 21.05.2022, the Appellant filed a departmental appeal against the office order dated 18.05.2022. Nevertheless, even after more than 3 months no decision has been given on the appeal.

Copy of the departmental appeal is attached herewith as 'E'

- 10. Furthermore, the Appellant also submitted a complaint on the Pakistan Citizen's Portal (PCP) regarding the same matter. The Respondents mentioned that since the PSHT is a district based post; therefore, the Appellant can be posted anywhere in the district.
- 11. Therefore, feeling aggrieved on the actions and inactions of the Respondents, the Appellant seeks indulgence of this Hon'ble Tribunal, inter alia, on the following grounds:

GROUNDS

A. Office order dated 18.05.2022 was notified in violation of section 3 of the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011 (hereinafter referred to as 'the 2011 Act).

Copy of the Act is attached herewith as 'F'

B. Impugned action of the Respondents is in violation of the departmental policy and therefore, is illegal and unlawful.

i. As per the departmental policy dated 18.01.2013, a PSHT needs to be posted in the same Union Council subject to the provisions of sanctioned post. The relevant portion of the policy is reproduced underneath for convenience:

"3.

Posting on Promotion

4. On Promotion o PST B-12 to the Senior PST B-14 and **PSHT B-15, may be posted in the same UCs** subject to the provisions of sanctioned post.

5. Senior most PSHT B-15,SPSTB-14 & PSSSTB-12 (According to the Seniority list) may be retained in the school of their present posting and junior most may be transferred to other schools

Copy of the Departmental Policy regarding posting on promotion is attached herewith as 'G'

C. Actions of the Respondents are in violation of Article 4 of the Constitution of Pakistan.

i. To be treated in accordance with the law is an alienable right of every citizen in the country. The Appellant has been denied this right as he was posted to a different union council in violation of the prevailing policy.

D. The Respondents by not posting the Appellant in his Union council has acted in violation of the Article 25 of the Constitution.

i. Previous similar notifications clearly show that in cases where PSHT posts were available the employees were posted in their same school or in the same union council.

Copy of the relevant notifications attached herewith as 'H'

E. Respondent No. 1 to 3 are infringing upon the rights of the Appellant that are guaranteed by the Article 18 of the Constitution.

- F. The actions/inactions of the Respondents are in violation of Article 10A of the Constitution.
 - i. The Respondents could not have been posted in the different Union Council against the policy without his consent especially when PSHT post was available in the same post.
 - ii. The Respondents refusing to give a decision on the appeal filed by the Appellant are is grave violation of article 10-A of the constitution

Prayer

It is therefore, prayed that:

- I. The posting of the Appellant to GPS Masam Khel No.1 upon promotion to PSHT vide the impugned notice be declared illegal and unlawful.
- II. The Respondents may be directed to post the Appellant in Shaidu Union council for it being the Union Council of his domicile.
- III. Direct the Respondents that Appellant be posted to GPS Sheen Bagh, Shaidu
- IV. Posting of Respondent No.4 to GPS Sheen Bagh, Shaidu be declared illegal and unlawful as it is against the prevailing policy





The applicant respectfully submits as under :-

c)

That, the applicant has been serving in Government Primary School Shaidu No. 2 (SPST) in BPS-14 vide appointment letter dated : 17/1/1990 and during his entire stint of service career has served his department diligently with unblemished record without giving any chance to superiors to raise their eyebrows regarding his conduct.

 That, the applicant has received your office order dated : 16/7/2022 wherein he has been transferred to Masam Khel whereas, the post of Primary Head Teacher post Shin Bagh Union Council Shaidu.

3) That, the applicant seeks benevolent indulgence of your good office to have 2nd view/review of order in question inter-alia on following grounds :-

a) That, the applicant has been serving in the current school which falls within territorial Jurisdiction of his Union Council Shaidu and as per Government policy employee of Government are to be preferred in their home Union Council. Sir in this regard it is also worth mentioning that said policy is anchored on time tested/wisdom spawning principle of convenience to the Government employees as in case of their appointment in far off station it won't be possible for them to keep workable balance between their official and domestic duties.

b) That, department of education is created by statutory laws of legislature under Government of Pakistan, 1973. In broad sense where department concerned is created by law the respective powers and duties of concerned officials are defined and demarcated with no scope of discrationary powers being used by official beyond their mandated domain. The impugned order is an exercise to travel beyond allotted sohere hence, needs review.

That, the applicant and his wife named Naveeda Rehman CNIC# 172DI-2138365-4 who is currently serving in GGPS Khairabad No. 2 is also entitled to be posted in Union Council Shaid as both are serving in Government department are entitled to be both posted in the same Union Council and as per spousal policy technically known as wedlock policy by 'transfer/posting of one the spouse to far off area creates domestic tension and problems which adversely effects their professional conduct. Sir in this regard following points and case law of superior courts of Pakistan are ware worth perusal

a) In case law reported as IN THE HIGH COURT OF SINDH, KARACHI C.P. No>D-

877 of 2014 worth SHC observed "The Office Memorandum or instructions contained in Estacode unequivocally make it clear that in view of the socio economic problems and hardships faced by husbands and wives in Government service due to posting at different stations of the duty, the office order on the wedlock policy was issued to facilitate posting of husbands and wives at the same station and the posting of unmarried female civil servants at the place of residence of their parents/families" the court further supported wedlock policy in following seminal words "We feel no hesitation in our mind to hold that once the competent authority issued wedlock policy, it their responsibility to implement and adhere to such policy guidelines so that the benefit may be given to all such persons who are covered under the wedlock policy. Its implementation cannot be left at the whims and volition of the competent authority to bestow this benefit or

advantage on pick and choose basis, while such type of guidelines or policy should be implemented across the board without any discrimination.
b) That, the applicant has unblemished service of 32 years in the current school and in this context it is worth mentioning that Mr. Mufakharikh Shah retired and applicant was directed by ADO named Mr. Shamsul Had to take

care of school as Head Teacher in which capacity he has served for a period of one year during which he has not given any chance to authorities to raise their eyebrows regarding their conduct. In case law reported as PLD 2013 S.C. 195 (Syed Mahmood Akhtar Naqvi and others a federation of Pokistan and others) It is rightly emphasized that

others v. Federation of Pakistan and others). It is rightly emphasized that "Tenure, appointment, promotion and posting/transfer are of utmost importance in the civil service. If these are made on merit in accordance with definite rules, instructions etc., the same will rightly be considered and treated as part of the terms and conditions of service of a civil servant. If, however, rules and instructions are deviated from and as a result merit is discouraged on account of favoritism, sifarish or considerations other than merit, it should be evident the civil service will not remain independent or efficient".

In case law reported as 2003 PLC (C.S) 1322 (Muhammad Zia-ul-Haq v. Secretary to Government of the Punjab and 4 others). The wisdom of wedlock policy has been explained in detail in following words "Wedlock Policy had been introduced and acted upon with a philosophy. If husband in Government Department was posted at one city and his wife posted in another Government Department was working in a different city, it was definitely going to cause mental distress to both of them with the consequences which were not only injurious to them, but to the public and Government exchequer."

e) The worthy shc in same case while quoting <u>SL.No.4</u>: <u>Posting' of serving husband/wife at the same station</u> also appreciated The government taking note of the socio-economic problems and hardship faced by husbands and wives in government service due to posting at different stations of duty, laid down basic guidelines in following words "Posting of husband and wife at the same station should not be made by dislocation of any government servant already serving at a particular station

THE KHYBER PAKHTUNKHWA (APPOINTMENT, DEPUTATION, POSTING AND TRANSFER OF TEACHERS, LECTURERS, INSTRUCTORS AND DOCTORS) REGULATORY ACT, 2011

Anner "F

AN ACT

to regulate by law appointments, postings and transfers of teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges and instructors in technical institutions and doctors in health facilities.

Preamble.---WHEREAS it is expedient to regulate by law appointments, postings and transfers at local level, of teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges and instructors in technical institutions and doctors in health facilities and to ensure the availability of teachers in schools, lecturers in colleges and instructors in technical institutions and the doctors in health facilities, and to regulate deputation of doctors abroad, and to provide for matters connected therewith or ancillary thereto;

It is hereby enacted as follows:

1. Short title, application and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011.

(2) It shall apply to teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges as well as commerce colleges and instructors serving in technical institutions and doctors serving in the health facilities in the Province of the Khyber Pakhtunkhwa.

(3) It shall come into force at once.

2. Definitions.---(1) In this Act, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them that is to say,-

(a) "Commission" means the Khyber Pakhtunkhwa Public Service Commission;

(aa) "college" means a degree college;

(b) "doctor" means a doctor serving in the health facility;

(c) "Government" means the Government of the Khyber Pakhtunkhwa;

(d) "health facilities" mean all health facilities established and managed by Government to provide medical facilities to general public;

(e) "lecturer" and "instructor" respectively means a lecturer or an instructor serving in a Technical Institution as well as in a college, as the case may be;

(f) "prescribed" means prescribed by rules made under this Act;

(g) "rules" mean the rules made under this Act;

(h) "school" means school in the public sector including primary, middle, secondary school, higher secondary school or an institution of equivalent level imparting education through any system or medium of instruction in the public sector;

(i) "teacher" means a teacher of primary, middle, secondary or higher secondary school; and

(j) "technical institution" means and includes a Commerce College or Government College of Management Sciences or Technical Institute or Technical and Vocational Training Center or Skill Development Center in the public sector imparting technical education to students leading to the award of a degree or a diploma or a certificate.

(2) Words and phrases used in this Act, but not defined, shall have the same meanings as respectively assigned to them under the relevant federal law or provincial law or any other statutory order or rules for the time being in force.

3. Appointment, posting and transfer of primary school teachers.---(1) The vacancy of primary school teacher shall be filled in from the candidates belonging to the Union Council of their permanent residence mentioned in their Computerized National Identity Card and domicile, on merit and if no eligible candidate in that Union Council is available where the school is situate, such appointment shall be made on merit from amongst eligible candidates belonging to the adjacent Union Councils:

Provided that on availability of a vacancy, a primary school teacher, appointed from adjacent Union Council, as referred to in this sub-section, shall be transferred against a vacant post in a school of the Union Council of his residence within a period of fifteen days.

(2) Upon marriage, the primary school teacher on request may be transferred to the school in the Union Council, where his spouse, ordinarily resides, subject to the availability of vacancy.

(3) The primary school teacher shall be transferred to other school within the Union Council on completion of tenure as may be prescribed or before completion of tenure, subject to the policy of rationalization for maintaining certain students teachers ratio, if any.

(4) Government shall, within a period not exceeding one year of the commencement of this Act, make arrangement for posting of all the primary school

teachers appointed prior to coming into force of this Act, to the schools of their respective Union Councils or adjacent Union Councils, as the case may be.

4. Appointment of doctors, lecturers, instructors, subject specialists and teachers on adhoc basis.---(1) Government may, through the competent authorities make adhoc appointment on merit against the vacant posts of doctors, lecturers, instructors, subject specialists and teachers, falling within the purview of Commission, in a district concerned from the domicile holders of that district for a period of one year or till the arrival of recommendees of Commission, whichever is earlier after fulfilling the pre-requisites of giving wide publicity in the press. On assumption of charge of post by recommendee of the Commission, the services of such ad hoc appointee shall stand automatically terminated:

Provided that if no suitable and eligible candidate is available in the district concerned for appointment, then the candidates belonging to the neighbouring districts shall be considered for appointment in the order of their merit.

(2) Save as the appointment made under proviso of this section, "ad hoc appointee" shall serve in the district of his domicile.

(3) The post of a doctor, lecturer, instructor, subject specialist or teacher who proceeds on training or long leave may be treated as vacant post for the purpose of contract or contingent appointment till the return of such employee from training or long leave and assumption of charge of the post:

Provided that the period of such training or long leave shall not be less than one year and no appointment on contract or contingent shall be made on the post which may fall vacant for a period less than one year.

5. Initial posting. --- (1) The doctors, lecturers, instructors subject specialist or teachers, upon their appointment shall be first posted in the periphery of the zone against whose quota they have been recruited, and they shall not be transferred for a period of at least three years.

(2) Upon expiry of the tenure as referred to in sub-section (1), transfer shall be made only upon the availability of substitute.

6. Deputation of Doctors.---(1) Government may allow deputation abroad for all categories of doctors only once in their entire service, for a period not exceeding three years.

(2) Deputation to "Foreign Service" within Pakistan shall be permissible only in respect of medical officers for a period not exceeding three years:

Provided that no further extension, on expiry of agreed tenure shall be given to the doctors who are already on deputation abroad or within Pakistan.



7. Postgraduate Medical Education.---(1) The Health Department, on the basis of objective need assessment and analysis, shall determine the intake number of Trainee Medical Officers (TMOs) in Postgraduate Medical Institute (PGMI) and Junior Registrars in Tertiary Care Hospitals every year. This stipulated number shall not exceed in any case.

(2) Any doctor selected or permitted for postgraduate medical training shall be treated on leave without pay and may be entitled only for stipend fixed by Government from time to time for such training.

(3) A doctor selected or permitted for postgraduate medical training shall provide surety bond prescribed by Government ensuring that upon completion of his studies for which he was initially selected, shall compulsorily serve for three years in the district of his domicile and in case of non-availability of a post in the district of domicile, he shall serve for three years in the rural area.

(4) For the purpose of sub-section (3), the doctor shall also provide guarantee of two government officers.

(5) In case of violation of sub-section (3), Government shall serve one month notice upon the doctor for resumption of duty, failing which the amount shall be recovered from him or from the guarantor, as the case may be.

8. Provisions relating to doctors apply to lecturers and instructors. --- The provisions relating to doctors in section 7 of this Act shall mutatis mutandis apply to lecturers and instructors.

9. Act to over-ride other laws.---The provisions of this Act shall have effect notwithstanding any thing contained in any other law for the time being in force.

10. Jurisdiction barred.---Save as provided under the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973), the Khyber Pakhtunkhwa Civil Servants (Appeal) Rules, 1986 and the Khyber Pakhtunkhwa Service Tribunal Act, 1974 (Khyber Pakhtunkhwa Act No. I of 1974), no order made or proceedings undertaken under this Act, or the rules made there under or any officer authorized by it shall be called into question in any Court, and no injunction shall be granted by any Court in respect of any decision made, or proceedings taken in pursuance or by any power conferred by or under this Act or the rules.

11. Removal of difficulties.---Government may, by order, provide for the removal of any difficulty which may arise in giving effect to the provisions of this Act.

12. Power to make rules.---Government may make rules for carrying out the purposes of this Act.





POSTING OF UNMARRED FEMALE GOVERNMENT SERVANTS AT THE PLACE OF RESIDENT OF PARENTS/FAMILY

The undersigned is directed to state that it has been brought to the notice of Government that unmarried female Government servants face socio-economics and security problems when they are posted at stations other than the place of residence of their parents / family .The Government has taken note of this difficulty and it has been decided to prescribe the following guidelines for dealing with requests of unmarried female Government servants for posting at the place of residence of their parents/family.

- (i) Where request is made the posting at a different station in the same department service cadre in which an employee is already serving, the request may be accepted subject to availability of a post in the same BPS.
- (ii) If a request involves temporary deputation to another department, it may be processed in consultation with the concerned department and may be accepted on the prescribed terms of deputation subject to availability of a post in the same BPS.
- (iii) When a request is made for permanent transfer to absorption in another department/agency, the request may be processed in consultation with the department concerned subject to the condition that in the event of permanent transfer, seniority shall be determined in accordance with Rule 4 of the Civil Savants (Seniority) Rules, 1993.
- (iv) If there is a tie between two or more Government servants for posting of the same department and of an organization, the government servant with greater length of service may be referred.

S.R.O 365(I)/2007 - In exercise of the powers conferred by sub-section (10 of section 25 of the Civil Servants Act, 1973 (LXXI of 1973) read with Notification No. SRO 120 (I)/98 dated the 27th February 1998, the Prime Minister is lead to direct that the following further amendments shall be made in the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973 namely:-

In the aforesaid Rules, after rule 20, the following new rule shall be inserted, namely:-

"20A Appointment on deputation.

(1)A person in the service of a Provincial Government or an autonomous, semi-autonomous body or any other organization set-up, establishment owned managed or controlled by the Federal Government who possesses the minimum educational of service qualifications, experience comparable length prescribed for a post shall be eligible for appointment to the said post on deputation for a period not exceeding three years which may be extended for another period of two years on such terms and conditions as may be sanctioned by Federal Government in consultation with the lending Organization.

(2) Subject to any rule or orders on the subject issued by the Federal Government, a civil servant who fulfills the conditions and is considered suitable may be sent on deputation to an autonomous, semi-autonomous body or corporation established by law or to the Provincial Government on such terms and conditions as may be decided by the lending and borrowing organizations.
