- That vide Advertisement No. 03/2018 dated 09/02/2018 the government of Khyber Pakhtunkhwa, Finance Department advertised certain posts of Auditor BPS 14 in the Directorate of local Fund Audit, detailed as below,
- (I) 49 posts were to be filled on merit vide serial No. 48 of the advertisement.
- (ii) 9 posts were to be filled in Female Quota vide serial No. 49.
- (iii) 4 posts were to be filled in Minority Quota vide serial No. 50.
- (IV) 01 (one) post had to be filled in **Disable Quota** vide serial No. 51 of the advertisement.

2. That the appellant being eligible applied for the female Quota posts at serial No. 49 of the advertisement, hence the ability tests thereof took place on 22/12/2018 vide revised FOURTH SCHDULE for ability tests of Public Service Commission.

(Copy attached as annexure B)

- 3. That after qualifying the test and interview the appellant was recommended by the Public Service Commission to the Government for appointment against the subject post vide letter PSC/SR-VII/017292 dated 09/08/2018. (Copies of interview result and recommendation letter are attached as annexure C, D)
- 4. That vide notification LFA/Estt:/Recruitment/2019/2218-31 dated 09/10/2019 the appellant was appointed against the subject post who took over the charge vide arrival report dated 10/10/2019.
 (Copies of appointment order and arrival report are attached as annexure E, F)
- 5. That ability test for the subject posts of Respondents No. 3 to 45 at serial No. 48 of the advertisement took place on 10/04/2019 vide 5th schedule of Public Service Commission public notice, where after interviews were conducted and they were tentatively considered to be recommended to the Government for appointment against the subject posts vide interview result dated 23/12/2019

6. That vide letter PSC/SR-VII/Auditor/2020/011776 dated 11/11/2020 Respondents No. 3 to 45 were recommended to the Government for appointment.

7. That vide Notification LFA/ESTT:/S.L/2017/320-3022 dated 29/01/2020 Respondent No. 1 issued final seniority list of 2019 vide which the appellant is at serial No. 65 thereof while as Respondents No.3 to 45 had not been appointed till then.

8. That vide Notification LFA/ESTT:/S.L/2017/46-47 dated 17/08/2021 Respondent No. 1 issued final seniority list of 2020 vide which again the appellant is at serial No. 65 whereas respondents No 3 to 45 are at serial No. 73 to 116 thereof.

9. That vide tentative seniority list of 2021 issued by Respondent No.1 surprisingly Respondents No. 3 to 45 were illegally made senior to the appellant despite of they being appointed much later on the subject posts as in the said list Respondents No.3 to 45 have been placed at serial No. 50 to 78, 82 to 92 and 94 to 96 while the appellant was placed at serial No. 100.

10. That feeling deeply aggrieved of the said tentative seniority list the appellant filed an objection with Respondent No.1 on 18/01/2022.

11. That despite of objection thereof the Respondent No.1 issued final seniority list vide Notification LFA/ESTT:/S.L/2020/1226-1332 dated 22/04/2022 with the same order of seniority.

12. That the appellant being aggrieved thereof filed departmental appeal before Respondent No.1 on 12/05/2022 and an appeal to Respondent No.2 on 08/06/2022.

13. That appeal of the appellant was illegally filed/rejected by Respondent No.1 vide letter dated 26/09/2022.

14. That now the appellant being deeply aggrieved of and having no other remedy prefers this service appeal inter alia on the following grounds amongst others.

GROUNDS:

- A. That the impugned seniority list issued as such is in sheer violation of the law and rules on the subject, hence not sustainable in any manner what so ever.
- B. That the impugned seniority list is based on misuse of power and authority and is the result of favoritism, arbitrariness and nepotism.
- C. That the ability test, interview, recommendation and appointment of the appellant is much earlier than Respondents No.3 to 45, hence vide impugned seniority list placing of them senior to the appellant is violation of law and the rules thereunder.
- D. That the final seniority lists of 2019 and 2020 were issued vide Notifications dated 29/01/2020 and 17/02/2021 have never been objected or challenged by Respondent No. 3 to 45 within the time limit as provided under the law, hence got finality, therefore the impugned seniority list does not hold any legal ground or justification' hence needs rectification.
- E. That appellant is at serial No. 65 of the seniority list of 2019 and 2020, hence the impugned seniority list of 2021 is in gross violation of law and the rules which needs to be rectified.
- F. That vide the impugned seniority list Article 3, 4, and 25 of the constitution of Islamic Republic of Pakistan have been drastically violated.
- G. That vide the impugned seniority list valuable rights of the appellant have been illegally usurped, infringed and violated.
- H. That the status and character of public service commission is of merely a recruiting agency limited to recruitment only, it has nothing to do with the terms and conditions of service of the appellant, hence the way and



the manner departmental appeal/ representation of the appellant is filed is extremely illegal and un-precedented, therefore does not sustain in the eye of law.

- I. That the way and the manner juniors are made senior to appellants is the worst example of mis-use of power and authority.
- That other point will be raised at the bar at the time of hearing of the appeal.

It is therefore most graciously prayed that while allowing the instant **APPEAL** by declaring the impugned seniority list as unlawful, illegal, null, and void-ab-initio to the extent of the appellant may very kindly be rectified and be made in consonance with the seniority lists of 2019,2020 with all benefits ancillary and incidental therewith.

Any other remedy which is appropriate in circumstances of the case may also be granted.







RESERVATIONS AND OBJECTION REGARDING THE SENIORITY LIST OF AUDITORS BPS-14/15 AS STOOD ON 31-12-2021 DUE TO VIOLATION OF CIVIL SERVICE RULES.

Respected Sir,

With due respect it is stated with great concern that there has been clear violation of the following rules of the act and ordinance regarding the issuance of SENIORITY LIST OF AUDITORS BPS-14/15 AS STOOD ON 31-12-2021:

- THE KHYBER PAKHTUNKHWA CIVIL SERVANTS ACT, 1973. [KHYBER PAKHTUNKHWA] ACT NO. XVIII OF 1973
- COMMISSION SERVICE (AMENDMENT) ORDINANCE, 2002 (KHYBER PAKHTUNKHWA ORDINANCE PAKHTUNKHWA PUBLIC XXVII OF 2002) vide NOTIFICATION NO. KP/PSC/ 41094 A.

The respective rules from the act and notification are quoted below:

Under CHAPTER-II, TERMS AND CONDITIONS OF SERVICE OF SERVANTS, subheading Serial No 8, Seniority, Subsection 4, of THE KHYBER (i). PAKHTUNKHWA CIVIL SERVANTS ACT, 1973. [KHYBER PAKHTUNKHWA] ACT NO. XVIII OF 1973, rule page attached (Annex-A), it is stated:

"Seniority in a post, service, or cadre to which a civil servant is promoted shall take effect from the date of regular appointment to that post:

Provided that civil servants who are selected for promotion to a higher post in one batch shall, on their promotion to the higher post retain their inter-se seniority as in the lower post."

The above rule in its first para clarifies that the seniority will first take effect from the date of regular appointment, which isn't being followed and in second para the seniority will be inter-se, only among the same batch, which has joined from that specified regular date. That too has been violated. Different batches with different dates of joining have been merged into one inter-se seniority list without considering date of joining. This has affected me and my batch fellow employees who has joined on the same date i-e 10-09-2019 and have been put down at the bottom of seniority list.

(ii). Under PART - XI MERIT LIST / ZONAL ALLOCATION / RECOMMENDATION, subheading Serial No 34, Recommendations, Subsection (c), OF KHYBER PAKHTUNKHWA PUBLIC SERVICE COMMISSION (AMENDMENT) ORDINANCE, 2002 (KHYBER PAKHTUNKHWA ORDINANCE XXVII OF 2002) vide NOTIFICATION NO. KP/PSC/41094 A, rule page attached (Annex-B), it is stated: "At the time of advertisement, separate serial numbers, and sub-serial number shall be given to each subject. [serial-wise / sub serial-wise] recommendations along with inter-seseniority shall also be conveyed to the department."

The above rule clearly stipulates that the inter se seniority recommendation will be in accordance with the serial-wise/ sub serial-wise, which means different serial number candidates seniority will be separately dealt and will follow inter se seniority pattern. No two serial number seniority will be mixed or compiled with one another. It has happened in this case resulting in violation of this ordinance as well. (The concerned advertisement attached) (Annex-C).

Moreover, the ability test for Female Auditors (BPS-14) In Local Fund Audit, Finance Department. (Advt: No. 03/2018, S. No. 49) and Auditors (BPS-14) (M/Q) +(Disabled Quota) In Local Fund Audit, Finance Department. (Advt: No. 03/2018, S. No. 50 and 51) was held on 22/12/2018 (1723) Evening Session. Whereas, test for Forty Nine Auditors (BPS-14) In Local Fund Audit, Finance Department. (Advt: No. 03/2018, S. No. 48) held on 10/04/2019 (8174) Evening Session. Combined Merit list has been made of above mentioned posts although ability tests were held on different dates. (The concerned schedule for ability tests are attached) (Annex-D).

Respectfully Sir, our seniority has been affected by not considering the above rules, since our induction (interview result notification of our batch attached i-e Female Auditors (B-14) In Local Fund Audit, Finance Department. (Advt: No. 03/2018, S. No. 49), Date and time of display result: 2019-07-25 11:09:24) was done earlier and we had joined the service months prior from the other employees (interview result notification of their batch attached i-e Auditor (B-14) In Directorate of Local Fund Audit. (Advt: No. 03/2018, S.No 48). Date and time of display result: 2019-12-23 12:48:31), yet we got last positions in the seniority i-e 79, 80, 97-106 in mentioned SENIORITY LIST OF AUDITORS BPS-14/15 AS STOOD ON 31-12-2021. (List attached). In the previous SENIORITY LIST OF AUDITORS BPS-14/15 AS STOOD ON 17-02-2021, we were from 59 to 71 (list attached) (Annex-E), which has been altered in the current seniority list.



It is therefore, requested to arrange the seniority list in accordance with the stipulated service rules, in order of date of joining, seniority, batch inter-se seniority list, in accordance with the serial and sub serial number of the advertisement. The aggrieved candidates' signatures are attached in respect of the application for grievance redressal.

The objections raised by the undersigned on seniority list issued by your office vide letter NO:LFA/ESTT:/S.L/2020/1226-1332 dated 22-4-2022 (Annex-C) already communicated to you vide letter NO NIL dated 18-1-2022(Annex-D) still stand.

Rule17 (1) (a) of Part (IV) of CIVIL SERVANTS (SENIORITY) RULES 1993 provided by kppsc vide letter No.PSC/SR-VIIII/023984 Dated 04/04/2022 Annex-E) which Cleary states that, "The seniority inter se of civil servants" (appointed to a service, cadre or post) shall be determined:-

(a) In the case of persons appointed by initial recruitment, in accordance with the order of merit commission 56 or as the case may be, the Departmental Selection Committee;] provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection."

In the instant case, auditors (female, disable and minority) quota were appointed/selected seven months earlier than auditors appointed in a general quota moreover their test, interview and date of recommendation date were also different. Therefore, in light of above quoted rule of seniority, auditors appointed earlier should be ranked senior to the auditors appointed in general quota. It is pertinent here that a final seniority list has already been issued by your office vide letter No.LFA/ESTT:/S.L/2017/46-47 dated 17-2-2021 (Annex-F) wherein auditors appointed in general quota were ranked junior.

It is therefore requested that the case may be reconsidered to avoid any future complications/litigations.
