JUDGMENT

QAZI HAMID-UD-DIN-J, CHAIRMAN:— This appeal has been filed by Abdul Haleem against the respondents with the prayers that the appellant's services be regularized as Subject Specialist from retrospective effect, that the appellant be allowed arrears of pay and that the appellant be granted seniority/service benefits from the date of his first appointment under section 7(5) of the Civil Servants Act XVIII of 1973.

The facts leading to the present appeal are that the appellant, who is M.A in Pak: Studies and having the experience of C.T.I for a period of 3 years, was appointed as Subject Specialist in BPS-15 (Fixed) on temporary basis against the

vacant post of B-17 on 12.5.1990. According to the appellant the said appointment could be deemed to have been made on contractual basis as envisaged by section 5(2) of the NWFP Civil Servants (Regularization of Services) Act, 1988 and on the promulgation of NWFP Employees on contract basis (Regulation of Services) Act, 1989 the appellant attained the status of a civil servant on adhoc basis. It was, however, obligatory under section 4 of the said Act to appear before the Public Service Commission within a period of 3 months but the said provision could not be implemented as the Public Service Commission failed to arrange interview within the prescribed period. In the meanwhile NWFP employees on contract basis Amendment Act, 1990 was promulgated through which the above mentioned obligation was removed and the appellant as such was entitled to have regularized his service as a regular civil servant as Subject Specialist. Therefore, on 14.12.1991 he submitted a departmental appeal. He then filed a writ petition in the Peshawar High Court which was also dismissed as withdrawn with permission to file a fresh one. The appellant filed a second writ petition which was also dismissed as withdrawn in order to seek relief from a proper forum having jurisdiction in the subject matter. Hence the present appeal. The appellant contends that vide notification dated 26.9.1992 he was appointed in B-17 on regular basis on the recommendation of Public Service Commission and is entitled to service benefits and seniority, graded pay and arrears from the date of his appointment as Subject Specialist i.e. 12.5.1990.

The respondents have filed their joint reply in which the claim of the appellant has been denied and it has been stated that since the appellant has been appointed in B-17 on regular basis on 26.9.1992, therefore, he is only entitled to service benefits and seniority from the date of his regular appointment in B-17 w.e.f. 26.9.1992.

It is an admitted fact that the appellant was appointed in BPS-15 (Fixed) on 12.5.1990 against the vacant post of Subject Specialist (B-17) on temporary basis by the respondent department. This Tribunal as well as the Superior Courts have held in various judgments that if a person is qualified to hold a higher post and if he is made to work against a higher post who ther on the basis of adjustment or stop gap arrangement or on temporary basis, he would be entitled to the presumptive pay of the post alongwith increments and his pay would be regularized accordingly if he possess minimum qualification for the post. In this case as the appellant has been working against the post of Subject Specialist which is a BPS-17 post, therefore, he is held to be entitled only the presumptive pay of the post alongwith increments with effect from the date he a acquired the minimum qualification for the post with arrears if any from that date. As regards other prayer, since the appollant o pervices beverbe megulerized in B-17 es Subject Specialist on 26.9.1992 on the recommendation of the NWFP ... Public Service Commission, therefore, he is entitled to service benefits and seniority from the date of his regular appointment in B-17 w.e.f. 26.9.1992 The appeal is accepted in the above terms. Parties are left to bear their own costs. File be onsigned to the record.

- 2. That consequent upon qualifying test and interview of Public Service Commission for the post of SS in Pakistan Studies, I was appointed as regular SS, w.e.f 26-9-1992.
- 3. That my continuous officiation on SS Post upto my regular appointment was not considered, hence I went in appeal and was given relief of presumptive pay alongwith increments from 26-09-1992. but the department did not allow me increments w.e.f 25-05-1990 to 26-09-1992. Further more, I was told by the department that on any final decision in respect of subject specialists from S.No. 1 to 12 you can claim the benefits of any service rights if they were awarded by the department or courts, in your respective lien.
- 4. That now vide No. SO (S) 4-24/2009/T SL (M)/B-17 dated 12-01-2010 all the 12 subject specialists were given seniority in BPS-17 from the date of their respective appointment as SS in BPS-15 against BPS-17, with the direction that the objection / observation if any shall reach the E & SE within 30 days positively.

Respectfully Sheweth,

The Respondents submit as under:-

Preliminary Objections:-

- 1. That the appellant has no cause of action/ locus standi.
- 2. That the instant appeal is badly time barred.
- 3. That the appellant has concealed the material facts from this Hon 'able Tribunal, in the instant service appeal.
- 4. That the instant service appeal is based on malafide intention.
- 5. That the Appellant has not come to this Honorable Tribunal with clean hands.
- 6. That the Appellant is not entitled for the relief he has sought from this Honorable Tribunal.
- 7. That the instant Service Appeal is against the prevailing law & rules.
- 8. That the Appellant is not an aggrieved person.
- 9. That the appellant has been treated as per law, rules & up-gradation policy.
- 10. That the Appeal is not maintainable in its present form.
- 11. That the instant appeal is bad for mis-joinder & non-joinder of the necessary parties.
- 12. That the instant Service Appeal is barred by law.
- 13. That the Appellant is not competent to file the instant appeal against the Respondents.

FACTS.

- 1. That para-1 is incorrect & misleading on the grounds that the Appellant was initially appointed against the SS (Pak Study) BS-15, post on contract /Adhoc basis & later on the recommendations of DPC KPK the Service of the appellant has been required vide Notification dated 25-09-1992 & adjusted at GHSS Wari Dir (Lower) vide No. 54 of the said Notification.
- 2. That Para-2 is correct to the extent that the Appellant has filed a Service Appeal No. 89/1994 before this Hon'able Tribunal wherein the plea regarding regularization of his services against the SS post has been rejected vide judgment dated 06-01-1994 and upon this, the appellant has been regularized against the above said post w.e.f 26-09-1992 vide this office Notification

dated 12-05-1996 issued by the Respondent No. 2 in the interest of Public Service & with immediate effect (Copy of the same Notification is Annexure-A).

- 3. That para-3 is correct. Hence needs no comments.
- 4. That para-4 is incorrect and denied. The service of the Appellant has been regularized w.e.f 26-09-1992 in pursuance of the judgment dated 21-10-2008 passed by this Honorable Tribunal with the submission that the case of the Appellant is not at par with those officials as referred by the Appellant. Hence the plea of the appellant is liable to be rejected.
- 5. That Para-5 is correct to the extent that the appellant has been promoted from BS-18 to 19 vide Notification dated 21-04-2014 on the basis of his seniority cum fitness as well as qualifying service against the Principal post, hence which is not only legally competent but is also liable to be maintained in terms of his seniority position in the Respondent Department.
- 6. That para-6 is incorrect & denied, No Departmental Appeal has been filed by the Appellant against the impugned order dated 21-04-2014, nor any such record is available in the Respondent Department till date. Hence the instant Service Appeal is liable to be dismissed on the following grounds inter alia:-

GROUNDS.

- A. Incorrect and denied. The impugned Notification dated 21-04-2014 is in accordance with law, rules & policy, hence is liable to be maintained in favour of the respondents Department. Therefore, the appellant is not entitled for the grant of regularization & seniority from the date of his Ist: appointment against the SS post in the Respondent Department.
- B. Incorrect & denied. The statement of the appellant is against the facts & circumstances of the instant case on the grounds, as mentioned in the forgoing paras, by the Respondents.
- C. Incorrect and denied. The appellant has been made entitled for the grant of service regularization in pursuance of the judgment of this Hon"able Tribunal as mentioned above & against which the Appellant has not filed any CPLA/CP before the August Supreme Court of Pakistan, hence the said judgment has got finality against the Appellant on the basis of the same judgment. The Appellant has been regularized against the SS post alongwith his further promotions in BS-18 & 19 in terms of seniority cum fitness basis in the Respondent Department., hence the plea of the appellant is liable to be dismissed.
- D. Incorrect and denied. The Appellant has been made entitled for the grant of service regularization against the SS post in accordance with law, rules & seniority provisions, hence the plea of the appellant is not tenable in the eyes of law.

E. The Respondent seek leave of this Hon"able Tribunal to advance additional grounds record & case law at the time of arguments on the date fixed.

In view of the above made submission, it is requested that this Hon'able Tribunal may very graciously be pleased to dismiss the instant service appeal with cost in favour of the Respondent Department.



Preliminary Objections:

(1-13) All objections raised by the respondents are incorrect and baseless. Rather the respondents are estopped to raise any objection due to their own conduct.

While para-1 of the appeal is correct as mentioned in the main appeal of the appellant because the respondent's department admitted itself that the appellant was appointed as SS (Pak Stud) BS-15 and the appellant recommended by the PSC through departmental permission and adjusted by the concerned department.
- In para-2 of his reply respondent department admitted first portion of the appeal as correct as mentioned in the main appeal of the appellant while rest of the para of the reply is incorrect while para-2 of the appeal is correct.
- No comment endorsed by the respondent's which mean they have admitted Para-3 of the appeal as correct.
- Incorrect. While para-4 of the appeal is correct as mentioned in the main appeal of the appellant. More over the other



colleagues of appellant were also appointed as SS on fixed pay alike the appellant later on regularized as SS from the date of appointment vide order dated 18.4.2009 on the basis of judgment of this august tribunal. So appellant also entitled for the same benefits.

- In Para-5 of the reply, respondent's department admitted First portion of Para-5 of the appeal while rest of para-5 of the reply is incorrect. While para-5 of the appeal is correct as mentioned in the main appeal of the appellant
- That Para-6 is incorrect & denied. While para-6 of the appeal is correct as mentioned in the main appeal of the appellant.

GROUNDS:

•

- A) Incorrect. While Para-A of grounds of the appeal is correct. Moreover, impugned order dated 21.4.2-014 is against the law, rules policy & facts and norms of justice. And the appellant is entitled for the grant of regularization & seniority from the date of his 1st: appointment against the SS post in the respondent department.
- B) Incorrect. while Para-B of grounds of the appeal is correct. Moreover ,respondent's department already some of colleagues regularized from the dates of 1st appointment. therefore the appellant also entitled for the same benefits.
- C) Incorrect. while Para-C of grounds of the appeal is correct. Moreover, appellant has also filed appeal in honorable court. As like others SS filed appeal in the honorable court and courts also decided the same nature cases in the favor of his colleagues and the respondent's department grant benefits according to the rules and policy. But respondent department restrain/deprive the appellant from the same benefits which is against the principles of fair play and equality.

- D) Incorrect. while Para-D of grounds of the appeal is correct. Moreover, the appellant has been made entitled for the grant of service regularization against the SS post in accordance with law, rules & seniority which is the fundamental right like same the others SS, So the appellant is also entitled to the benefits of service already granted to his colleagues.
- E) legal
