Moreover, the delay of 02 days, was pointed out. Learned counsel for the appellant referred to various judgements of the Service Tribunal including a recent one in Service Appeal No. 1075/2019 titled Muhammad Rafiq-Vs-Government-of_Khyber-Pakhtunkhwa, through Chief_Secretary.
