- That there was no Junior Clerk available at GHSS Kawai except the appellant.
   Therefore, the appellant requested to respondent No. 4 for relieving order from

the School to Join GHS Maira Amjad Ali but he refused to relieve the appellant until or unless replacement of the appellant is provided by respondent No.3. As a result, the appellant regularly served at GHSS Kawai w.e.f 10/09/2018 to 25/03/2019. In this regard, service certificate issued by respondent No. 4 is attached as Annexure "B".

3. That during this period, respondent No. 3 sent show cause notice, final show cause notice against the appellant through respondent No. 4 on 10/10/2018 and 27/11/2018 but respondent No. 4 did not show the show cause notices to the appellant and wrote letter to respondent No. 3 to the extent that the appellant shall be relieved from service provided the replacement of the appellant is provided. Copies correspondence of respondent No. 4 with respondent No. 3 are available with the said respondents. However show cause notice dated 10/10/2018 and 27/11/2018 are attached as Annexure "C" & "D".

- dated 22/12/2018 for personal hearing from respondent No.3, therefore, the appellant was forced by respondent No. 3 to submit reply of the show cause notice during his personal hearing. Therefore as dictated by respondent No. 3 the appellant submitted reply of show cause notice and affidavit as desired and dictated by respondent No. 3.

  Copy of letter dated 22/12/2018 are annexed as Annexure "E".
  - That as a result, respondent No. 3 issued impugned Endst No. 4655-61 dated 25/03/2019 wherein one annual increment w.e.f 01/12/2019 with accumulative effect and period of service w.e.f 10/09/2018 to 25/03/2019 has illegally been treated with out pay which is against the law and facts. Copy of impugned order dated 25/03/2019 and relieving order dated 31/03/2019 is attached as Annexure "F". Hence, the appellant filed departmental appeal to respondent No. 2 for redressal of his

grievances but of no avail. Copy of departmental appeal is attached as Annexure "G".

That feeling aggrieved this instant service appeal is filed, inter-alia on the following grounds;-

### **GROUNDS;-**

- (a) That the impugned order dated 25/03/2019 is illegal against the law and is a result of without following the prescribed codal formalities.

  Hence the impugned order dated 25/03/2019 is liable to be set aside.
- respondent No. 3 to stop one increment with accumulative effect.

  Hence, whatever is prescribed in the law on the subject has not been followed.
- (c) That the appellant was not relieved by respondent No. 4 to join GHS Maira

Amjid Ali. Therefore, the appellant Kawai served at GHSS w.e.f 10/09/2018 to 25/03/2018. In this regard respondent No. 4 could be directed by this Honourable Tribunal to produce attendance register w.e.f 10/09/2018 to 25/03/2019. Therefore, respondent No. 3 without proper inquiry converted the service period of the appellant into leave without pay in the impugned order 25/03/2019.

- (d) Therefore, the period of services rendered by the appellant cannot be converted into extra ordinary leave, leave without pay. Hence, impugned order dated 25/03/2019 may be cancelled.
- (e) That the matter of relieving of the appellant from GHSS Kawai to GHS Maira Amjid Ali was remained heldup and struck between respondent No. 4 and respondent No. 3 but due to

their turmoil, and no fault the appellant has been made escape goat.

The circumstances were beyond the control of the appellant being a low paid Govt. employee.

- (f) That instead of taking any action against the relieving officer respondent No.3 imposed minor punishment against the appellant which is unjust and not maintainable at law.
- (g) That the matter relates to the terms and conditions of service, therefore, the Honourable Tribunal has jurisdiction to entertain the present appeal.
- (h) That other grounds shall be urged at the time of arguments.

It is, therefore, humbly prayed that, on acceptance of the instant service appeal, stoppage of one annual increment w.e.f 01/12/2019 with


