APPEAL U/S 4 OF THE SERVICE TRIBUNAL ACT. 1974 AGAINST THE IMPUGNED ORDER ENDST: NO.813-20, DATED: 12/02/2022 OF RESPONDENT NO.1. WHEREBY THE APPELLANT HAS BEEN REMOVED FROM SERVICE ILLEGALLY AND AGAINST APPELLATE ORDER NO.6521-24. DATED: 27/06/2022 COMMUNICATED TO THE APPELLANT DURING PENDENCY OF APPEAL ON 16/08/2022 WHEREBY DEPARTMENTAL APPEAL OF THE APPELLANT HAS BEEN REJECTED ON NO GOOD GROUNDS.

Respectfully sheweth,

- **1.** That the appellant is the permanent resident of Village Tapa Mir Was Khel, Hussaini Abad, P.O Kuriz, District Orakzai. (**Copy of NIC is attached as annexed-A**).
- 2. That the Office of District Education Officer, Orakzai (Respondent No.1) advertised in February 2020 different cadre Posts of Male/Female Teachers in various Schools of Merged Tribal District Orakzai through ETEA in Local News Paper. (Copy of Advertisement is attached as annexed B).

- 4. That it is also pertinent to point out that the appellant had also obtained certificate of Shahadatul Aalia in Arabic and Islamiat equivalent to B.A form Wifaqul Madaris Al-Shiatul Pakistan, Jamiatul Muntazir,Lahore. (Copies of Certificate of Shahadatul Aalia is annexed-H & H-1)
- 5. That after passing ETEA test and fulfilling all codal formalities the appellant was appointed as AT (Arabic Teacher) School Based in BPS-15 in Govt: High School Dran Shekhan Central Orakzai vide Appointment Order Endst.No.6300-10, dated: 26/11/2020. (Copy of Appointment Order Dated. 26/11/2020 is attached as annexed-I).
- 6. That the appellant was performing his duties efficiently and without any complaints to the satisfaction of his superiors and in the meanwhile all the documents/certificates of the appellant were verified by Office of respondent No.1 from the concerned institutions and thereafter salary of the appellant was started in the month of August 2021.(Copies of letters regarding verification of B A degree are annexed- J & K respectively)
- **7.** That an anonymous complaint was lodged before Pakistan Citizen Portal on 25/12/2021 regarding candidates possessing Degrees from fake, illegal and unrecognized institutions already appointed during 2019-20 & 2020-21.
- 8. That the Respondents also sent a letter to the Higher Education Commission of Islamabad on 11/01/2022 regarding recognition and affiliation of the Islamic University of Pakistan, Sialkot wherefrom the appellant had obtained his B A degree. And allegedly as per list of fake and unrecognized institutions in Punjab visible at HEC URL Islamic University of Sialkot, Punjab was found included in that particular list at Serial No.96.

- **9.** That thereafter the appellant on the charge of either having fake degree or degree from fake, illegal and unrecognized University was suspended and an Inquiry Committee was constituted on 04/02/2022 to inquire about the said issue.
- 10. That the Inquiry Committee submitted its inquiry report on 11/02/2022 and in lights of their recommendations the competent authority (Respondent No.1) in exercise of Powers conferred under rules 4(b)-iii of Khyber Pakhtoonkhwa Government Servants (Efficiency & Discipline) Rules 2011, while imposing major penalty, removed the Appellant from Service Vide Order Endst No. 813-20, dated. 12/02/2022 on account of his B A degree obtained from fake, illegal, unlawful and unrecognized institution. (Copy of Removal from Service Order No. 813-20, dated. 12/02/2022 is annexed-L)
- **11.** That aggrieved from the said impugned removal from service order dated. 12/02/2022 the appellant filed departmental Appeal before the Respondent No.2 which has been rejected by the appellate authority vide Order No.6521-24, dated-27/06/2022 communicated to the appellant on 16/08/2022 (Copy of departmental appeal and rejection Order along with envalop are annexed- M & N).
- 12. That the appellant feeling aggrieved of the said impugned orders and having no other remedy, approaches this Hon'ble Tribunal through the instant appeal for relief inter- alia on the following other grounds:-

### **GROUNDS:**

- a. That the impugned Order dated 12/02/2022 and rejection Order dated-27/06/2022 are illegal, arbitrary, without lawful authority, discriminatory and against the law, rules and regulations, hence untenable and liable to be set aside.
- b. That no show cause notice or charge sheet was served upon the appellant and without providing opportunity of personal hearing/defense to appellant, the Department has conducted the so called inquiry in a short time and the appellant has been removed from service illegally ignoring the procedure provided under the Law, rules and regulations.

- d. That after leveling the charge of B.A degree obtained from fake, illegal and unverified university of Sialkot, the appellant submitted another certificate of Shahadatul Aalia in Arabic and Islamiat equivalent to B.A form Wifaqul Madaris Al-Shiatul Pakistan, Jamiatul Muntazir, Lahore, before Respondent No.1 for consideration, but the same was not considered at all.
- e. That as per W.P no.470-M/2016 decided on 20/03/2018 titled "Faiz Ur Rehman Vs Director E & S Education & Others" the Hon,ble High Court, Peshawar in similar issue/cases of degrees/diploma's being obtained from fake, illegal or unrecognized Universities has held that **" all those who have been appointed and are still in Service on the basis of said degrees etc are given two years' time to get equivalent qualification from any recognized University ", but the Respondents/Department totally ignored the same principle and while imposing major penalty, removed the appellant from service, which is illegal, arbitrary and harsh in the eyes of law.**
- f. That the appellant has also passed/obtained his B.A degree from Gomal University, D.I Khan in December 2020 and if the appellant would have given proper opportunity of personal hearing the same fact would definitely come in the knowledge of the respondents and the Order of removal from Service of appellant might have not happened. (Copy of. B.A degree is annexed-O & O/1)
- g. That by accepting the offer of appointment validly made to the appellant by the department on the basis of his qualifications a valuable right had accrued to him and he could not be made to suffer for the mistake or error of others/officials. Indeed the offer had been accepted and acted upon for almost 15 months, <u>thus the case of the appellant be</u> governed by the principle of Locus Poenitentia and the department cannot retrace the steps already taken and lawfully acted upon by the appellant. Reliance is placed on C.P No.4439 of 2017, decided on 18/10/2019.
- h. That any other ground if needed will be raised at the time of arguments with the permission of this Hon'ble Tribunal.
