- 3. - 4. It is evident on record that the present service appeal was called on for hearing on 01.03.2018 but no one appeared on behalf of the appellant resulting into its dismissal in default. The application for restoration of appeal was submitted on 16.09.2019 beyond the prescribed period of limitation nevertheless, while keeping in view the arguments of the learned counsel for petitioner/appellant and the law and precedent on the subject which prefer decision on merits rather than looking at technicalities and since valuable rights are involved, therefore, the appeal is restored to the file but for admonition costs of Rs. 2000/- is imposed to be paid to the respondents. On payment of costs receipt to this regard has to be obtained from the duly authorized representative of the respondents to be deposited in the government exchequer and by placing the receipt on file.
