

Counsel for the appellant present. Preliminary arguments have been heard. Memorandum of appeal and the copies of record annexed there with have been perused.


Learned counsel for the appellant contended that the appellant is senior, office Assistant who is fit and eligible to be promoted in (BS-17). However, he is aggrieved of the minutes of DPC dated 01.04.2015 when he was deferred on the sole ground that his PER's were not available. PER's for the period from 2002-2008 and 2014 in respect of the appellant while serving in DHS former FATA had duly been communicated to DG Health Services on 24.03.2015. Moreover, maintenance and safe custody of the PER's of the employees, is the responsibility of respondent-department and not the appellant. Moreover, no DPC Meeting has been held after 1st April 2015 making it recurring cause for due rights of the appellant to have been negated by the respondents. The appeal is admitted for regular hearing subject to all just legal objections including question of limitation. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. File to come up for arguments on 22.02.2022 before the D.B.




