

**Prayer:-**

**It is, therefore, prayed that the office order No. 4171-98-SO (M) at 28/10/2022 to the extent of petitioner at serial No. 11 and office order No. I-R-V/SO/Mansehra at 3400-3403 at 07/11/2022 be set aside and the**

*petitioner be allowed to serve at its present place of posting.*

*Respectfully Sheweth:*

1. That the petitioner is serving in Revenue Department District Mansehra since 2005 at Revenue Patwari in BPS-05 and now working as Revenue Patwari in BPS-09 in Moza Battal, Mansehra.
2. That the petitioner was serving in Moza Oghi in the year 2019 and was transferred and posted at Dodhial through order No. 4179-84/DK on dated 15/11/2019. *(Copy of order is attached as Annexure "A")*.
3. That through office order No. 3353-56-SO (M) dated 26/11/2019 petitioner was posted at Halqa Sachan Kalan, Mansehra. *(Copy of order is attached as Annexure "B")*.
4. That only after 30 days, the petitioner was again transferred and posted at Moza Chikiya through order No. 3532-35 on dated 27/12/2019. *(Copy of order is attached as Annexure "C")*.
5. That again through office order No. 4940-SO/(M) dated 16/02/2021, the petitioner was transferred

and posted at Patwar Halqa, Khushala. *(Copy or order is attached as Annexure "D")*.

6. That at through Order No. 5183-5203-SO/(M) dated 06/05/2021, petitioner was transferred to Patwar Halqa Jallu from Patwar Halqa Khushala. *(Copy of order is attached as Annexure "E")*.

9. That the petitioner, feeling aggrieved by this illegal order preferred an appeal before the respondent No. 2 on dated 03/11/2022. *(Copy of Appeal is attached as Annexure "H")*.

10. That the respondent No. 2, through respondent No. 1 dismissed the appeal of petitioner through order No. IRV/SO/Mansehra /3400-3403 on dated

11. That on feeling aggrieved by both the orders, this appeal is preferred before this Hon'ble Tribunal, inter alia on the following.

**GROUNDS:-**

- A. That the posting / transfer order impugned is wrong, illegal and against the public interest to extent of petitioner and therefore, is not sustainable in the eye of law.
- B. That the petitioner has been made a rolling stone for the last 3 years by regularly transferring him and this is a great hindrance in the performance of the petitioner.
- C. That the transfer order of the petitioner is a clear violation of the posting transfer policy of the Govt. of KPK and thus the same is not sustainable in the eye of law.
- D. That the transfer order of the petitioner is under undue political pressure and some ill will against the petitioner for unknown reasons.
- E. That the petitioner has an unblemished service record and without any fault on the petitioner

part he has been made a rolling stone by the respondent which is source of disappointment for the petitioner and also a disgrace in the public.

F. That the posting / transfer of the petitioner in the last 03 years have been made due to political involvement and to give undue advantage to some blue eyed and this is against the good administration efforts.

G. That this transfer, being illegal and against the police has badly disrupted the efficiency of the petitioner and thus is liable to cancellation.

H. That other points will be raised at the time of arguments.
