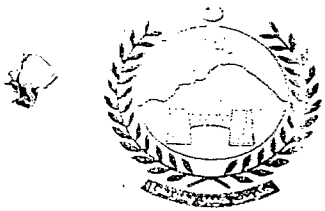



It is certified that, I have gone through my particulars mentioned at Sr. No. 23 of the tentative seniority list (PPS, BS-18) and found the following discrepancies among others:-

1. The officers mentioned at S.No. 29, 30, 33 to 61 included in the tentative seniority list of BS-18 mentions that their method of recruitment/ appointment is through "inclusion" in the cadre. Whereas the notified service rules of PPS (**Annex-I**) does not have any such provision of inclusion in BS-18.
2. The officers mentioned at S.No. 17, 18 and 19 of BS-19 were not in the previous final seniority list of BS-19 & 18 (**Annex-II & III**). Their method of recruitment/ appointment is also through "inclusion" in the cadre. Whereas the notified service rules of PPS does not have any such appointment method in BS-19. Hence, needs to be removed from the same.
3. The only entry point in the notified service rules of the PPS cadre is BS-17, subsequent to competitive process of Public Service commission. Therefore, inclusion of these non-cadre officers in BS-19 & 18 are violation of the PPS cadre rules itself and needs rectification.
4. Most of the officers mentioned in BS-17 tentative list are through inclusion, while the entry into the same grade is through competitive process of Public Service Commission. Therefore, only those officers who are recruited through Public Service Commission needs to be mentioned in the final BS-17 seniority list.
5. The inclusion of these non-cadre officers in BS-19, 18 & 17 are clear violation of the decision of the Apex Court duly endorsed by the Provincial Government (**Annex-IV**). The Apex Court has declared that;

"No Civil Servant of a non-cadre post can be transferred out of cadre to be absorbed to a cadre post which is meant for recruitment through competitive process"

In view of the foregoing, it is humbly stated that the seniority list of BS-19, 18 & 17 be revised on the basis notified service rules of PPS Cadre and in line with the laid down principles of ESTA Code/ Apex Court, please.





1. That induction in said manner (being prescribed by law/rules) have earned the appellant terms and condition of his service as provided in chapter II of Khyber Pakhtunkhwa Civil Servant Act, 1973 and Rules, *ibid*.
2. That terms and conditions of service of a civil servant (including the appellant) are protected by law as provided in Section 4 of Services Tribunal Act, 1974.
3. That services of employees of P&D Department (including the appellant) are being regulated by the provincial Government through a notification standard in terms of No: SO(E)/P&D/6-1/SR/PPS/2018 dated 22.02.218 (**Annex-C**)
These rules have been framed and notified under Section 26 of KP Civil Servant Act, 1973.

The Act, though sub-judiced before the court for its constitutionality, but concerned establishment in Khyber Pakhtunkhwa P&D Department have been devising modalities for a wishful absorption/ encadrement of the incumbent project employees in total restraint of law and transgressing on terms and conditions of services of regularly inducted employees of P&D Department.
5. That the impugned absorption/ encadrement is being maneuvered through a protracted mechanism, thereby infringing rights of the regularly inducted staff (including the appellant) as under.
 - a. On 20.02.2020, P&D Department circulated tentatively seniority list of the employees vide No. SO(E)P&D/3-4/SLS/PPS/2020 (**Annex-E**). The appellant was placed at S.# 23. The Seniority list was appealed against vide application dated 04/3/2020 (**Annex-F**). No response from P&D Department received as yet.
 - b. On 23.10.2020, the P&D Department have issued another Tentative Seniority list vide NO: SO(E)/P&D/3-4/SLC/PPS/2020. This time the appellant has been pushed back to S#. 55 on unexplained grounds (**Annex-A**).

LEGAL POSITION

1. The honorable Apex Court of Pakistan, through CRL original petition No. 89/2011 and connected (17 Number) cases have issued Judgment wherein following principle have been laid down to streamline services structure of civil servant.

These principles have been endorsed to all federal ministries and provinces for observance/compliance by Establishment Division dully endorsed by Establishment Department, Khyber Pakhtunkhwa (**Annex -G**).

The principles, to the effect are;

C146

- a) Absorption of a non civil servant, conferring on him status of a civil servant and like-wise absorption of a civil servant from non cadre post to cadre post without undertaking the competitive process under the recruitment rules is an illegal practice/act.
- b) No civil servant of a non cadre post be transferred out of the cadre to be absorbed to a cadre post which is meant for recruitment through a competitive process (**Annex-H**).

In view of above, absorption of non cadre post to cadre post is clear violation of the decision of the Apex Court of Pakistan and, therefore, illegal.

2. Article '4' of the Constitution of Pakistan, 1973, inter-alia states, "Right of individuals to be dealt with in accordance with 'law'".

Article-4(1) inter-alia provides "To enjoy protection of law and to be treated in accordance with law is the inalienable right of every citizen".


Article 4 (c) further provides: "No person shall be compelled to do that which the law does not require him to do".


The express provisions of the constitution have clearly been violated at the level of Khyber Pakhtunkhwa P&D Department in this particular case.

PRAYER


1. It is, therefore, most humbly prayed that on the acceptance of this application the impugned tentative seniority list issued by P&D Department may kindly be set-aside on above, amongst other grounds.
2. The appellant may be restored his original seniority in the cadre in light of legal position referred above.
3. The persons notified vide Notification No. SO(E)P&D/071/19-39/2019 dated 09/01/2020 to be included in the Provincial Planning Service (PPS) Cadre be excluded from the seniority list (**Annex-I**).
4. Any other relief appropriate in the circumstances may also be extended to the appellant.
