However, the appellant despite having rendered five years service as Cook (BS-03) qualified as B.A and DIT, was ignored in the appointment by the departmental selection committee. The impugned order dated 24.08.2021 is basically the order vide which departmental appeal dated 20.08.2021 of the appellant was turned down. Where-after the instant service appeal has been instituted of 17.09.2021.
