But there are two letters one from the Assistant Commissioner, D.I.Khan bearing No. 1087/BC dated 14.10.2022 addressed to the Commissioner, D.I.Khan for seeking advice for retirement from Government service on superannuation/grant of 365 days encashment of LPR in lieu of LPR & other benefits and another from the office of Commissioner, D.I.Khan to the Secretary to Government of Khyber Pakhtunkhwa, Board of Revenue & Estate Department bearing No.5822-24/Acctt: dated 28.10.2022 for grant of 365 days encashment of LPR in lieu of LPR and others benefits. So, the process for grant of leave encashment has already been initiated been and it is now for the SMBR/Secretary to Government of Khyber Pakhtunkhwa Board of Revenue Estate Department to issue order of 365 days encashment, therefore, respondents shall process the case of leave encashment and submit report in this regard on 15.11.2022 before S.B. To come up for further proceedings on date fixed.
