





RESPONDENT NO.2, WHEREIN NAME OF
THE APPELLANT IS ILLEGALLY SHOWN AT
S.NO. 598, AND WAS NOT RECOMMENDED
FOR PROMOTION.

Prayer in Appeal,

By acceptance this appeal the name of the appellant may kindly be recommended for promotion in the impugned seniority list and his service may kindly be

counted from the date of regular appointment i.e. dated 23.04.2012 instead of 25.4.2012, which is incorrectly mentioned/written in service book of the appellant and consequently the respondent No. 3 may very graciously be directed to correct the date of appointment of the appellant as 23.04.2012 instead of 25.04.2012 in his service book.

Respectfully sheweth,

1. That the appellant along with others batch fellow were appointed on a single order dated 23.4.2012 as Primary School Teachers (PST) in different schools in BPS-7. It worth to mention here that the post of PST was upgraded to BPS-12(Copy of appointment order is attached).
2. That on 24/4/2012 the appellant appeared before the concerned Medical Officer, and on 25/4/2012 and the newly appointees took their charge in their respective schools while the appellant and three others took their charge in Govt. Primary School wargha Banda district Karak. (copy of the charge Reports are attached)
3. Thereafter the appellant Started duty regularly and having unblemished record, no complaint whatsoever have been have been received from the high ups against the appellant since than till date.
4. That due to clerical mistake in column No.7 of his service Book, the appointment date of the appellant has been

entered wrongly in his service book as 25/4/2012 instead of 23/4/2012, Infact on 25/4/2012 the appellant took charge, which date wrongly entered in column No.7 as appointment date in his service book and due to which the appellant suffered and his name was not recommended for promotion in the impugned seniority list. (copy of service book of the 1st entry page is attached)

5. That thereafter the appellant approached to the Respondent No.2 by submitting the Appeal/Application for correction of the above mentioned wrong entry i.e. 25/4/2012 to 23/4/2012 in his service book.(copy of application is attached)
6. That on the above mentioned application the Respondent No.2 constitutes a committee through a notification dated 29.01.2022 to resolve the matter/Appeal of the appellant. (Copy of the same is attached).
7. That thereafter the committee assigned its remarks on the appeal/application of the appellant as follows“24/4/2012 ADEO, ESTABLISHMENT Uniform policy of seniority may please be corrected followed “. (copy attached)
8. That thereafter the respondent No.2 issued the impugned seniority list wherein the name of the appellant is shown at S.No. 598 and is not recommended for promotion.(Copy of the impugned seniority list is attached)

9. That the appellant is aggrieved from ignoring the committee remarks for not correction the date of appointments in Colom No.7 as 23.04.2012 in his service Book and later on the name applicant is not recommended in the impugned seniority list for promotion and come to this honorable Tribunal form the following amongst other grounds.

GROUNDS

- A. That the act of the respondent No. 2 by issuing the impugned seniority list, wherein the name of the appellant is not recommended for promotion is sheer volition of his accrued right.
- B. That this act of the respondents is totally illegal, unlawful and is against the facts and circumstances of the case hence liable to be corrected.
- C. That as stated in the body of the appeal and also an admitted fact that the appellant along with others were appointed vides same order dated 23/4/2012, where other colleagues of the appellant promoted as per the impugned seniority list, whereas the name of appellant not considered for promotion hence clearly discriminated.
- D. That the appellant was suffered due to the clerical mistake done by the respondent No.3, in his service book, wherein due clerical mistake the appointment date is

wrongly/incorrectly mentioned in column No.7, as 25/4/2012 instead of 23/4/2012.

- E. That it is well principal of law that the seniority should be counted from the regular appointment but in the instant this is not be done by the respondent and impugned seniority list.
- F. That any additional grounds will be raised at the time of arguments with prior permission of this Hon, ble tribunal.

It is therefore humbly prayed that by acceptance of the instant appeal the name of the appellant may kindly be considered in the impugned seniority list for promotion, as prayed for in heading of the instant appeal.






