Contends that for upgradation to the post of SPST prescribed qualification from intermediate with PTC Certificate and 10 years service as PST was changed on 30.01.2018, to the effect that it was enhanced to Bachelor Degree from a recognized university and nine months training at RITE. The said change of rules was applied to the case of appellant for promotion while the erstwhile rules dated 13.11.2012 were applied in case of employees similar to appellant in other districts who were promoted/upgraded. The said act on the part of the respondents was discriminatory towards the appellant and others whose promotion/ upgradation was deferred on the count of notification dated 30.01.2018.

In view of the arguments of learned counsel and material available on record, instant appeal is admitted for regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents. To come up for written reply/comments on 28.03.2019 before S.B.
