

Learned counsel for the appellant present. Preliminary arguments heard.

Learned counsel for the appellant opened his arguments apprising the court that the appellant was serving as Sepoy in Kurram Levy Force since 03.06.1996. The appellant was nominated in FIR U/S 302 PPC on 28.01.2015 who also surrendered voluntarily on 08.02.2015 to the authorities of Ex-FATA. The Trial court of Additional Session Judge-II Kurram awarded him the penalty of 14 years rigorous imprisonment vide order dated 23.09.2020. The appellant assailed and challenged the said order in criminal appeal No. 881-P/2020 before the Hon'ble Peshawar High Court and the Peshawar High Court set aside the judgement of trial court dated 23.09.2020 vide its judgement dated 11.11.2021. The Peshawar High Court, Peshawar acquitted the appellant of the charge leveled against him. On the departmental proceedings, the appellant was dismissed from service vide impugned order dated 08.07.2021 against which departmental appeal was filed but during pendency of his criminal appeal before the Hon'ble Peshawar High Court, the appellate order was passed on _____ 18.01.2022 and his departmental appeal was dismissed on the ground being devoid of merits. The appellant, thereafter instituted the instant service appeal invoking Sec 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 on 17.02.2022.

Points raised need consideration. The appeal is admitted to regular hearing, subject to all just and legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments. To come up for reply/comments before the S.B on 17.06.202/2.
