


Counsel for the appellant present. Preliminary arguments have been heard.

Learned counsel for the appellant while opening arguments highlighted background and service history of the appellant who applied to the Public Service Commission for the post of Female SET's/SSTs (both Science and Arts) as appeared at serial No. 55 of Advertisement No.1/2009 dated 26.01.2009. She was appointed as SST (General) in BS-16 vide Notification dated 22.10.2012 and posted at GGMS Bakhhalozo Bajaur Agency vide adjustment order dated 25.10.2012. She was transferred from Bajaur to settled district Malakand and adjusted against the vacant post of SST (General) at GGHS Haryan Kot vide Notification dated 04.07.2014. The appellant is aggrieved of the impugned Notification of respondent No.2 dated 11.06.2021 whereby her appointment/adjustment Notification dated 06.08.2012 and 15.08.2012 were disowned ab-initio and ordered the recovery of salary/allied benefits drawn by her during the period. Her departmental appeal dated 28.06.2021 was not responded within the stipulated statutory period where-after the Service Appeal was filed in the Service Tribunal on 06.10.2021.

The appeal is admitted to regular hearing subject to all just legal objections including limitation. The appellant is directed to deposit security and process fee within 10 days. Thereafter notices be issued to respondents for submission of reply/comments. To come up for reply/comments on 03.02.2022 before S.B.


