




The department, in pursuance of judgement of Service Tribunal dated 06.12.2021, submitted copy of office order dated 15.08.2022 whereby the petitioner has been reinstated in service by setting aside major penalty of "dismissal from service", learned counsel for the petitioner has reservation who pointed out that the petitioner should have been reinstated in service from the date of his absence i.e. 05.06.2017 instead of "with immediate effect". The department is therefore, under obligation to come up with proper implementation report on the next date.
