- O2. In pursuance of the judgement of Service Tribunal rendered on 31.07.2018, the petitioner has been reinstated w.e.f 29.12.2020 as is evident from Notification dated 19.11.2021 and also posted against the post of Arabic Teacher GGHS Tindo Central Kurram. Considering the implementation report, the Single Bench disposed of the execution petition on 28.06.2022. Now learned counsel for the petitioner has come up with the request for restoration of the execution petition on the ground that the Service Tribunal judgement has not been implemented in its letter and spirit. The point of controversy arises, is that the petitioner though reinstated and also posted, is not being paid monthly salary against the post.
- O3. This Bench is of the view that so far the question of implementation of Service Tribunal judgement is concerned the same stands implemented by the respondents and none payment of salary to the petitioner does arise fresh cause of action. The available course of action before the petitioner is therefore, to seek remedy through departmental appeal whereafter she will be at liberty to approach the Service Tribunal in case her grievances are still not redressed and she still feels aggrieved. Disposed of accordingly.
