

Learned counsel for the appellant argued that in pursuance of this Tribunal judgment dated 18.05.2015, the appellant was reinstated in service vide impugned order dated 26.01.2017. However back benefits/arrears of pay from the date of dismissal i.e 12.01.2011 to 18.12.2015 were not granted to him. The appellant preferred departmental appeal on 22.02.2017 which was not decided within stipulated period, hence the instant service appeal. When learned counsel for the appellant confronted on the point that explicit orders were not passed by the Service Tribunal in the above judgment regarding payment of back benefits, he contended that reinstatement without back benefits was violation of various judgments of the august Supreme Court of Pakistan. In response to an observation that payment of back benefits in such cases is contingent upon submission of an affidavit by the appellant that he was not engaged in a gainful employment during the intervening period which in this case has not been submitted. Learned counsel stated that he would submit affidavit with the rejoinder. He relied on 1994 SCMR 1801.
