**Respectfully Sheweth:**

Facts leading to appeal are as under:-

1. That, the appellant was appointed as a "Lab Assistant" BPS-7, in Higher Education Department, at Government Home Economics Department, Abbottabad on 10/09/2015, vide order No.21572-82 and appellant took over charge on 18/09/2015. **(Copies of appointment order dated 10/09/2015 and charge report dated 18/09/2015, are annexed as annexure –"A")**
2. That, Respondent No.3 published and advertisement in News Paper regarding vacant post in Elementary & Secondary Education Department and appellant applied for the post of C.T (BPS-15) through proper channel and got NOC from department. **(Copy of Departmental NOC dated 02/12/2016 is annexed as annexure "B")**

3. That, on 20/04/2017, Appellant was appointed as a C.T BPS-15 vide order No.2742-48 issued by Respondent No.3 and appellant Relieved from Higher Education Department on 21/04/2017 (FN) and took over charge on 21/04/2017 (AN) at Government Girls High School Nawansher, Abbottabad. **(Copies of appointment order dated 20/04/2017, Relieving certificate and charge report dated 21/04/2017 are annexed as annexure "C")**
  
4. That, on 14/10/2017, Respondent No.3 issued Pay Activation order of the appellant at initial pay scale i.e. BPS-15 and did not considered / counted the previous service of the appellant w.e.f. 18/09/2015 to 20/04/2017. **(Copies of both the service books of the appellant are annexed as annexure "D &E")**
  
5. That, on 10/03/2018, vide order No.1838-1914, respondent No.3 issued the order whereby the service of appellant was regulized in the light of notification dated 16/02/2018 by respondent No.1. **(Copy of Regulation order dated 10/03/2018 is annexed as annexure "F")**
  
6. That, on 23/05/2019, Respondent No.2 make an advertisement in the Newspaper for vacant vacancies in E&SE Department and appellant applied through proper channel for the post of SST (BPS-16) **(Copy of Advertisement dated 23/05/2019 is annexed as annexure "G")**
  
7. That, on 14/05/2020, appellant again appointed as a SST (IT) BPS-16 vide order Endst: No.2002-2007 issued by Respondent No.2 and appellant took over charge on 15/05/2020, at Government Girls High School Samundar



Katha, Abbottabad. (Copy of appointment order dated 14/05/2020 and charge report dated 15/05/2020 are annexed as Annexure "H")

8. That, the previous service of the appellant was again not counted / considered by the Respondent No.2 vide above said order dated 14/05/2020 and appellant being badly aggrieved filed Departmental appeal on 10/06/2020 before the Respondent No.1 which was not honored by the respondent No.1 up till the end of specific period of three months. (Copy of Departmental Appeal dated 10/06/2020 is annexed as Annexure "I")
9. That, feeling aggrieved by the conduct of Respondents, appellant left no other option but to file the instant Service appeal inter-alia on the following grounds:-

**GROUND:**

- A. That, the matter of appellant is concerning with the terms and conditions of the service under Article 212 of the Constitution of Islamic Republic of Pakistan 1973 hence, the appellant have no other proper forum except this Hon'ble KPK Service Tribunal.
- B. That, Appellant was appointed in Higher Education Department at Regular Basis and appellant applied for the job in Elementary & Secondary Education Department through Proper Channel.
- C. That, the previous service of the appellant has not been considered / counted by the Respondents which is clear cut violation of the Civil Servant Act and also the violation of fundamental rights of the appellant.

- D. That, the behavior of the respondent not to consider the previous service of appellant and also not providing the Pay Protection is totally against the appointment policy of the KPK Government.
- E. That, the Service Carrier of the appellant is being badly suffered due to the said conduct of the respondents.
- F. That the instant appeal is well within time.
- G. That the other points shall be agitated at the time of arguments with the prior permission of Hon'ble tribunal.

*In view of the above facts, grounds and Law, It is very, humbly prayed that on acceptance of instant appeal, Respondents may graciously be directed to consider / include the Previous Service of the Appellant w.e.f. 18/09/2015 to 14/05/2020 and respondents may also be directed to issued the "Pay Protection Order" of the Appellant with all back benefits. Any other Relief which this Hon'ble Tribunal deems fit and appropriate may also be granted to the appellant.*

1. Their services shall be governed by the Khyber Pakhtunkhwa Civil servants Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, posting & Transfer of teachers, Lecturers, Instructors & Doctors) Regulatory Act, 2011 & such rules & regulations as may be issued from time to time by the Government.


