PESHAWAR SERIOUSLY DISTURBING APPELLANT'S ORIGINAL
SENIORITY IN VIOLATION OF LAW AND RULES & REGULATIONS.**

**PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL ORDER
DATED 04-06-2020, AND 14-10-2020 MAY GRACIOUSLY BE SET
ASIDE AND SENIORITY "D-LIST" DATED 24-01-2020 BE ORDERED TO
BE CORRECTED BY PLACING APPELLANT AT RIGHT POSITION IN
ACCORDANCE WITH "D-LIST" DATED 08-12-2015 WITH GRANT OF
ALL CONSEQUENTIAL SERVICE BACK BENEFITS.**

Respectfully Sheweth:

1. That appellant was enrolled as Constable in District Police Haripur on 24-06-2000. After qualifying departmental examinations A-1 & B-1, the appellant

was selected and deputed for Lower College Course at PTC Hangu for the term ending 25-07-2007 which he passed securing good marks vide Notification dated 02-08-2007. **(Copy of Notification dated 02-08-2007 is attached as Annex-"A")**.

2. That on 15-03-2012, appellant was promoted to the rank of officiating Head Constable (B-7) vide DPO Haripur order dated 20-03-2012. **(Copy of order dated 20-03-2012 is attached as Annexure-"B")**.
3. That the Regional Police Officer Hazara Region Abbottabad transferred the appellant from District Haripur to District **"TORGHAR"** vide his Order No. 1866-67/E dated 06-02-2013. **(Copy of order dated 06-02-2013 is attached as Annexure-"C")**.
4. That before appellant's transfer from Haripur to Torghar:
 - A. Appellant had passed Lower College Course from Hangu on 25-07-2007.
 - B. Appellant had been promoted as Head Constable (B-7) on 13-03-2012.
 - C. Appellant had worked and tested in all the branches of Head Constable.
 - D. Appellant had already been brought on "List-C-1".
 - E. At those transferred from other district to Torghar were LHCs (B-5) at that time and none of them was Head Constable (B-7) except one Saif-ur-Rehman HC.
5. That appellant while serving at District Torghar, he on the basis of seniority, passing Lower Class Course and other requisite qualifications was **selected for Intermediate Class Course** at PTC Hangu in Term Ending on 20-09-2013 vide RPO Abbottabad order No. 4353-63 dated 01-04-2013 and was relieved under DPO Torghar letter OB No. 94 dated 01-04-2013. **(Copies both the orders dated 01-04-2013 are as Annexure-"D & E")**.

6. That appellant passed the "INTERMEDIATE COLLEGE COURSE" vide Notification dated **26-12-2013** issued by Principal PTC Hungu and his name stands in merits at Serial No. 6 of the Notification. **(Copy of Notification dated 26-12-2013 is attached as Annexure-"F")**.
7. The "D-LIST" of seniority was prepared and issued under No. 20342-59/EA dated 08-12-2015 the name of appellant stands at S/No. 249. **(Copy of seniority "D-List" dated 08-12-2015 is attached as Annexure-"G")**.
8. That after about more than 04 years, in the year 2020 the "D-List" prepared and circulated vide No. 2241/E DATED 24-01-2020 therein appellant's seniority has been disturbed by placing his name below those who were/are far junior to him. Thus appellant has been made junior to his most juniors and his name has been placed at S/No. 178 of the said list. **(Copy of "D-List" dated 24-01-2020 is attached as "H")**.

9. That without any reason, justification and against the law, departmental rules and regulation, the appellant has been made junior to his juniors in the "D-List" issued and circulated on 24-01-2020.
10. That as per Police Rules 1934, only those Head Constable who have passed the departmental courses i.e. Lower College Course and Inter College Course could be brought on "List-D" otherwise not. However, in appellants case those Head Constables who passed their Inter College Course in the terms ending on 28-02-2017 (while appellant passed on 26-12-2013) have been placed as senior to appellant in seniority "List-D" issued/circulated on 24-01-2020 against the Police Rules-1934 and norms of justice.
11. That placing appellant as junior to his junior in seniority "D-List" is tantamount to awarding him with major punishment under departmental rules and regulation.
12. That appellant aggrieved of the "D-List" dated 24-01-2020 preferred an Objections Petition before the Regional Police Officer, Hazara Region, Abbottabad which petition was rejected vide order dated 04-06-2020. **(Copy of Objections Petition and rejection Order dated 04-06-2020 are attached as "I & J")**.
13. That though appellant's Objections Petition was rejected on 04-06-2020 but copy of order was not given to him which appellant obtained through his request

dated 25-06-2020. (Application dated 25-06-2020 is attached as Annexure-"(K)").

14. That there after appellant filed department appeal before the PPO KPK Peshawar which was rejected vide order dated 14-10-2020 but copy of the same was not issued to him and the appellant had to obtain the same through personal efforts after filing application and then it was issued on 25-11-2020. (Copies of departmental appeal, rejection order dated 14-10-2020 and application are attached as Annexure-"L,M & N") hence instant service appeal, inter alia, on the following grounds:-

GROUND:

- a) That impugned orders dated 04-06-2020 and dated 14-10-2020 of the respondents are illegal, unlawful against the facts, departmental rules and regulations and principle of natural justice hence are liable to be set aside.
- b) That appellant was appointed as Constable in the District Police Haripur on 24-06-2000, promoted as Head Constable on 20-03-2012 and transferred to District Torghar vide order dated 06-02-2013 as Head Constable (B-7). But those who were juniors to him have been made senior in seniority list-D issued on 24-01-2020 against the departmental rules and regulations.
- c) That respondents have not treated the appellant according to law, Police Rules 1934 and other departmental rules & regulations and policy on the

subject and have acted in violation of Article-4 of constitution of Islamic Republic of Pakistan 1973.

- d) That appellate authority has also failed to abide by the law and even did not take into consideration the grounds taken by appellant in the memo of appeal. Thus act of respondent is contrary to the law and Police Rules 1934 read with section 24-A of General Clause Act 1897 and Article 10-A of the Constitution of Islamic Republic of Pakistan 1973.
- e) That those who are far junior to appellant in appointment and qualifying departmental courses like Lower and Intermediate College courses and even in promotion as Head Constable (B-7) conditions precedent for bringing on seniority List-D have been placed senior to appellant.
- f) That instant appeal is well within time and this honorable Service Tribunal has got every jurisdiction to entertain and adjudicate upon the lis.

PRAYER:


It is, therefore, humbly prayed that on acceptance of instant Service Appeal order dated 04-06-2020 and 14-10-2020 of respondents may graciously be set aside and seniority list-D dated 24-01-2020 be modified to the extent of appellant by placing him at right place in List-D with grant of all consequential service back benefits. Any other relief which this
