

**JUDGEMENT.**

**MIAN MUHAMMAD, MEMBER(E):-** The service appeal has been instituted with the prayer that “on acceptance of this appeal the impugned seniority list No. 11662-11761/Promotion cell dated 22.10.2019 and promotion call letter No. 13147-99 personal/promotion dated 28.11.2019 may be revived/corrected and the appellant may kindly be considered for promotion to the

post of office Assistant (BPS-16) with all back benefits admissible under the law & rules”.


02. Brief facts of the case are that name of the appellant was at serial No. 59 of the seniority list of 129 Senior Clerks (BS-14) issued on 21.12.2016. On the basis of this seniority list, 39 Senior Clerks were promoted to the post of office Assistant (BS-16) on 04.01.2018. Subsequently, another seniority list of Senior Clerks was issued on 22.10.2019 wherein name of the appellant was allegedly placed at serial No. 63 instead of serial No. 20. Respondent department called for record/documents of 47 Senior Clerks on 28.11.2019 for consideration to the post of office Assistant (BS-16) but name of the appellant was not included in the list. Departmental appeal of the appellant was regretted on the ground of being time barred whereafter the instant service appeal was filed in the service Tribunal.



03. On admission of the service appeal in preliminary hearing on 06.03.2020, the respondents were put on notice to submit written defense through reply/para-wise comments. Reply/Parawise comments were submitted on 13.01.2021. We have heard learned counsel for the appellant as well as learned Assistant Advocate General for the respondents in Divisional Bench and gone through the record thoroughly with their assistance today.

04. Learned counsel for the appellant contended that the appellant was initially appointed as Dark Room Assistant

(BS-05) in DHQ Hospital Chitral on 02.07.1986 and the post was later on redesignated as Junior Clerk on 01.11.1988. The appellant was promoted as Senior Clerk (BS-09) on 30.06.2008 and the post of Senior Clerk was subsequently upgraded to (BS-14) by the provincial government. Seniority list of Senior Clerks (BS-14) was circulated by respondent No. 1 on 21.12.2016 wherein name of the appellant appeared at serial No. 69. Respondent No.1 promoted 39 Senior Clerks (BS-14) was out of the said seniority list on 04.01.2018 and thus his name was required to have come up to serial No.20 but when final seniority list of Senior Clerks (BS-14) was circulated on 22.10.2019 his name was placed at serial No. 63 instead of serial No. 20. The appellant submitted departmental appeal on 28.10.2019 which was regretted on the ground of being time barred vide order dated 23.12.2019. It was further argued that a call letter dated 28.11.2019 asking for "PERs/No demand/judicial enquiry certificate" in respect of 47 Senior Clerks did not contain his name. Moreover, the impugned order dated 23.12.2019 being a non-speaking order is illegal, unjust and against the law. The appellant has been deprived of right of promotion as office Assistant (BS-16) without assigning any ground or reason. The impugned seniority list dated 22.10.2019 and promotion call letter dated 28.11.2019 may be revised/corrected and the appellant may kindly be considered for promotion to the post of office Assistant (BS-16) with all back benefits, he concluded.

05. Learned Assistant Advocate General on the other hand controverted arguments of the learned counsel for the appellant mainly on the ground that respondent No.1 circulated provisional seniority list of Senior Clerks (BS-14) on 03.06.2019 and invited objections within one month from all concerned. The appellant failed to submit his departmental appeal within the stipulated period. He submitted the departmental appeal after the lapse of 04 months on 02.10.2019 which was rejected being time barred. It was further argued that the appellant being employee of the district government, his promotion as Senior Clerk was made at district level and on dissolution of the District Local Government system in 2012, his seniority was to be reckoned from the date of dissolution i.e. 15.05.2012 on the provincial list of Senior Clerks. The case of all such employees was examined by a scrutiny committee in its meeting dated 14.11.2017. The appellant being not qualified as yet, will be considered for promotion on his turn according to his seniority and other requirements for promotion. The appeal may therefore very graciously be dismissed with costs, he concluded.

06. A careful perusal of the record reveals that the appellant's name was reflected at serial No. 59 of the seniority list of Senior Clerks (BS-14) of 2016. In the subsequent list of Senior Clerks (BS-14) of 2019, name of the appellant appeared at serial No. 63 despite the fact that 39 Senior Clerks were promoted to post of Office Assistant (BS-16) on 04.01.2018. The

appellant challenged the seniority list of Senior Clerks (BS-14) dated 22.10.2019 through his departmental appeal on 28.10.2019 which was declined on the ground of being time barred. However, it is a matter of record and it stands established that the departmental appeal had been submitted within 30 days of the impugned seniority list of Senior Clerks (BS-14) as provided under Rule 3 of the Khyber Pakhtunkhwa Civil Servants (Appeal) Rules, 1986.

07. Foregoing in view, we find it appropriate to remit the case to the appellate authority to decide departmental appeal of the appellant through a speaking order within a period of one month of receipt of copy of this judgement. Parties are left to bear their own costs. File be consigned to the record room.

It was further contended that as per seniority list dated 21.12.2016 of Senior Clerks (BPS-14) of Health Department, the appellant has been shown at serial no. 59. It was further contended that the respondent-department has promoted 39 Senior Clerks (BPS-14) of the Health Department to the posts of Office Assistants (BPS-16) vide notification dated 04.01.2018. It was further contended that the respondent-department issued another seniority list dated 22.10.2019 wherein the respondent-department was required to place the name of the appellant at serial no. 20 but the respondent-department has placed the name of the appellant at serial no. 63 instead of 20. It was further contended that the respondent-department has again issued call letters dated 28.11.2019 to Senior Clerks for promotion on the basis of said seniority list, therefore, the respondent-department was also required to call the appellant for the said promotion but the respondent-department has not issued any notice to the appellant for promotion, therefore, the impugned seniority list dated 22.10.2019 and the call letters dated 28.11.2019 are liable to be rectified.

The contention raised by learned counsel for the appellant need consideration. The appeal is admitted for regular hearing subject to limitation and all legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 30.03.2020 before S.B. Learned counsel for the appellant also submitted application for suspension of the call list mentioned above. Notice of the same be also issued to the respondents for the date fixed.

**PRAYER**

On acceptance of this appeal the impugned  
seniority list No. 11662-11761/ Promotion cell dated

22.10.2019 and promotion call letter NO. 13147-99 personal/promotion dated 28/11/2019 may be revived/ corrected and the appellant may kindly be considered for promotion to the post of Office Assistant (BPS-16) with all back benefits admissible under the law & rules.

**Respectfully submitted:**

- 1) That the appellant was appointed as Dark Room Assistant (BPS-5) in District Headquarter Hospital (DHQ), Chitral on 02.07.1986. (Copy of the appointment order is annexed as annexure "A")
- 2) That the appellant was appointed/ re-designated and posted as Junior Clerk in the DHQ, Hospital Chitral on 01.11.1988. (Copy of the order is annexed as annexure "B")
- 3) That on 30.06.2008, the appellant was promoted to the post of Senior Clerk (BPS-9) by the competent authority and later on the post of the Senior Clerk was upgraded to BPS-14 by the government. (Copy of the office dated 30/06/2008 order is annexed as annexure "C")

- 4) That a seniority list No. 8206-8306/Personnel/Promotion, dated 21.12.2016 issued by respondent No. 1 of 129 senior clerks wherein the appellant was placed at serial No. 59 and in pursuance of which 39 senior clerks were promoted to Office Assistant (BPS-16) vide office order No. 440-49/Personnel/Promotion Cell, dated 04.01.2018. (Copy of promotion order is attached as annexure "D").
- 5) That on 22.10.2019, respondent No. 1 issued another seniority list No. 11662-11761/Promotion Cell, dated 22.10.2019 of 98 Senior Clerks and strange enough the appellant was placed at serial No. 63 instead of placing at serial No. 20. On the basis of this impugned seniority list, the respondents called for the documents of 47 senior clerks for consideration for the post of Office Assistant (BPS-16) vide office letter No. 13147-99/Personnel/Promotion, dated 28.11.2019 and name of the appellant was not included in this promotion list. (Copy of the seniority & promotion call letter list is annexed as annexure "E").

- 6) That the appellant filed department appeal No. 4873, dated 28.10.2019 in the office of respondent No. 1 which was regretted and dismissed vide order No. 14082-87/ Promotion Cell, dated 23.12.2019 by respondent No. 2. (Copy of the departmental appeal & order is annexed as annexure "F")
- 7) That being aggrieved the appellant having no other adequate efficacious remedy for redressal of his grievance, hence approached this Hon'ble Tribunal on the following grounds inter-alia:

**GROUND:**

- A. That the impugned order dated 23.12.2019 of respondent No. 1 is illegal, unjust and against the law. The departmental appeal of the appellant was well within time.
- B. That the impugned order of respondent No. 2 is a non-speaking order and has dismissed the departmental appeal of the appellant without going through the record.

- C. That the name of the appellant has illegally been placed at serial No. 63 instead of serial No. 20 in the seniority list No. 11662-11761/Promotion Cell, dated 22.10.2019 issued by respondent No. 1. The respondents should have considered the appellant for promotion and his name should be included in the promotion list dated 28.11.2019.
- D. That the appellant has requested respondent No. 1 through his departmental appeal for reviving/ correcting the seniority list dated 22.10.2019. But the respondent has rejected the genuine request of the appellant which shows the ill-will of the respondents.
- E. That the appellant has illegally been deprived from promotion to the post of Office Assistant (BPS-16) to which the appellant is entitled under the law.
- F. That the appellant has been deprived of his due promotion and back benefits as compared to the others. Moreover, junior rank employees have

been promoted which is clear discrimination with the appellant. The respondents should promote the appellant with all back benefits.

- G. That the appellant is qualified and is fit for promotion to the post of Office Assistant but the respondents are unlawfully not considering the appellant for promotion. The appellant has been discriminated.

It is, therefore, most humbly prayed that on acceptance of this appeal the impugned seniority list No. 11662-11761/ Promotion cell dated 22.10.2019 and promotion call letter NO. 13147-99 personal/promotion dated 28/11/2019 may be revived/ corrected and the appellant may kindly be considered for promotion to the post of Office Assistant (BPS-16) with all back benefits admissible under the law & rules.

You are hereby offered a post of Post Substation Post Substation plus usual allowance sanctioned by the Government from time to time on the following terms and conditions:-  
w.e.f. 1-7-86.

1. The post is purely temporary but likely to continue on the year basis.
2. Your appointment is purely on the temporary basis and your services can be terminated at any time without any reason being a signed during probationary period and on successful completion of probationary period on 14 days notice or 14 days pay in lieu thereof.
3. If you wish to resign you will have to give a prior notice likewise in Para -2 and will continue service the Govt: till your resignation is accepted and communicated to you in writing.
4. You will be governed by such rules and orders relating to Pay T.A. leave and Medical attendance rules etc issued by the Govt: for the category of Govt: Servant you belong.
5. Your appointment will be subject to your Medical Fitness and satisfactor character report.

PARAWISE COMMENTS ON BEHALF OF RESPONDENTS

Preliminary Objections:-

1. That the Appellant has got neither cause of action nor locus standi to file the instant Appeal.
2. That the Appellant has filed the instant appeal just to pressurize the respondents.
3. That the instant Appeal is against the prevailing Law and Rules.
4. That the Appeal is not maintainable in its present form and also in the present circumstances of the issue.
5. That the Appellant has filed the instant Appeal with mala-fide intention hence liable to be dismissed.
6. That the Appellant has not come to the Tribunal with clean hands.
7. That the Appeal is time barred.
8. That the Honorable Tribunal has no Jurisdiction to adjudicate upon the matter.
9. That the instant Appeal is bad for mis-joinder and non-joinder of the necessary parties.

ON FACTS:

1. Para No. 1 pertains to record, hence no comments.
2. Para No. 2 pertains to record, hence no comments.
3. Para No. 3 pertains to record, hence no comments.
4. Para No. 4 pertains to record, hence no comments.
5. Para No. 5 is correct to the extent that this Directorate issued the Provincial Seniority list of Senior Clerk on 03/06/2019 (Annex-A) by giving one month period for objection if any. The Appellant failed to submit his appeal within the stipulated period of one month. The Appellant submitted his appeal against the Seniority list on 02/10/2019 after the lapse of 04 months so it was time barred and rejected. Also called service documents of the Senior Clerk who are in promotion



zone vide letter No. 13147-99/Personnel/Promotion dated 2/11/2019. It is pertinent to mention here that the Appellant was promoted to the post of Senior Clerk by the District Govt. under district cadre policy without obtaining NOC and by passing the Health Department Khyber Pakhtunkhwa. The Appellant was promoted by the District Govt. as Senior Clerk inspite of the fact that he was most junior in the Provincial Cadre. According to Govt. Notification dated 15/01/2002 (Annex-B). The Provincial cadre post BPS-15 and below of the Provincial Health Department were converted into district cadre, so the Appellant was promoted as Senior Clerk in district cadre and not in Provincial Cadre. According to Civil Servant Act, 1973, ESTA Code, fixation of seniority Para-6 an employee from one cadre to other cadre will be adjusted in seniority in the bottom (Annex-C), so on repealing the Act and abolishing of the district cadre and in the light of scrutiny committee decision dated 14/11/2017 (Annex-D). The names of promotes of district cadre of Health Department have been incorporated in the seniority list of Provincial Cadre the date of repealing of the Act i.e. w.e.f. 15/05/2012 and now he is at Serial No. 63 and does not come in the promotion to the post of Office Assistant being not in promotion zone. Moreover, similar Service Appeal No. 1062/2019, 1063/2019, 1064/2019 & 1369/2019 of Mr. Shamsheer Ali, Mr. Fazal Subhan, Mr. Mian Irshad and Farid Iqbal Assistants respectively versus Govt. also under trial in the Service Tribunal.

6. Para No. 6 is correct to the extent that he filed an appeal on 28/10/2019 (Annex-E) which was considered and rejected by the competent authority (Annex-F).
7. Para No. 7 needs no comments being formal.

#### ON GROUNDS:

- A. Para-A is incorrect. The seniority list of Senior Clerks has been issued in accordance with Civil Servant Act, 1973, Para-8 and APT Rules, 1989. The appeal of the Appellant being time barred was rejected.
- B. Para-B is incorrect. The appeal of the Appellant was rejected in accordance with prevailing rules being time barred.
- C. Para-C is incorrect. Detailed reply has already been furnished in Para No. 5 of Facts.
- D. Para-D detailed reply has already been furnished in Para-A above.
- E. Para-E is incorrect. The Appellant does not come in the promotion zone as yet and will be considered on his turn according to the seniority list and Service Rules.
- F. Para-F is incorrect. The Appellant will be considered for promotion on his turn and no discrimination has been made and everything will be done according to

the Govt. rules and regulations. In the eyes of the Department all the employees are equal and will be dealt according to the rules.


G. Para-G is incorrect. The Appellant not yet qualified and will be considered for promotion on his turn, according to seniority list and other documents required for promotion.







NOTIFICATION

No. SOR-II(E&AD)I(20)98-VIII. The Governor, NWFP is pleased to convert provincial cadre posts in BPS-15 and below of the provincial Health Department into the District cadres with immediate effect on the following terms and conditions:-

- a) Permanent transfer to the Districts will be made on domicile and seniority basis.
- b) In case of the personnel of that particular District being more than the sanctioned strength, the deployment will be on the basis of seniority and the junior most over flow will be posted temporarily to the adjacent Districts till such time vacancy occurs in the District of their domicile.
- c) All such employees of the above status working in FATA but belonging to settled Districts will be adjusted as per their seniority in the cadre and the over flow will continue working in FATA till such time a vacancy occurs in their District of Domicile.
- d) The Domicile of the Female officials will be counted under the wedlock policy and such employees will be given one time, irreversible choice to opt for the District of their Spouse or their own. In case of Spouse being a Govt. employee and his transfer in other District, inter District transfers of the female official will be allowed subject to availability of vacancy in the desired district.
- e) The territory Hospital will be allowed to opt once for retention of staff of their choice which, in light of the autonomy rules, would be absorbed in their service. It will be incumbent upon the territory Hospitals and provincial Institution who returned such employees to carry out on subsequent recruitment at provincial Govt.
- f) Succquent to the permanent transfer of all BPS-15 and below staff to the Districts, further inter district transfer and service matters, including appointment, shall be made by the District Govt. in light of the "District Rules of business 2001".
- g) All cases of transfer from one district to another will be decided and ordered upon by the Director General Health Services, albeit with the prior consultation of the district concerned.

- (d) If no suitable person is available in the surplus pool to be adjusted against the vacant/revised post, such a post would be filled up by initial recruitment manner after getting clearance from the E&AD.
- (e) <sup>86</sup>Surplus Staff in BPS-01 to 15 shall not be adjusted in the district other than their district of domicile.
- (f) To facilitate the adjustment of surplus staff, it will be incumbent upon the Administrative Department to take up the case with Finance Department for revival of the essential posts so retrenched as a result of general directive issued by Finance Department from time to time, giving cogent reasons/justification. Against the resultant revival/restoration of the post, the concerned Department will place a requisition on the E&AD for transferring of suitable surplus employee against the said post.
- (g) Unless the surplus employees in Class-IV are fully adjusted/ absorbed against their respective graded posts in various Government Departments/ Organizations, the general policy of the Finance Department regarding conversion of BPS-1 & 2 posts to posts in fixed salary @ Rs.2000/- per month for contractual appointed should be restricted to the above extent.

#### FIXATION OF SENIORITY

The inter-se seniority of the surplus employees after their adjustment in various Departments will be determined according to the following principles:-

- (a) In case a surplus employee could be adjusted in the respective cadre of his parent Department he shall regain his original seniority in that cadre.
- (b) In case, however, he is adjusted in his respective cadre but in a Department other than his parent Department, he shall be placed at the bottom of seniority list of that cadre.
- (c) In case of his adjustment against a post in a corresponding basic pay scale with different designation/nomenclature of the post, either in his parent Department or in any other department, he will be placed at the bottom of seniority list.
- (d) <sup>87</sup>In case of adjustment against a post lower than his original scale, he shall be placed at the top of seniority list of that cadre, so as to save him from being rendered surplus again & becoming junior to his juniors.

COMMITTEE REPORT REGARDING CORRECTION OF SENIORITY LISTS OF OFFICE ASSISTANTS, SENIOR CLERKS, COMPUTER OPERATORS, STATISTICAL ASSISTANTS AND SUPERINTENDENTS OF HEALTH DEPARTMENT(DIRECTORATE) KHYBER PAKHTUNKHWA

The committee constituted by the DGHS vide No. 5871-93/Coord/Office Order (scrutiny committee) dated 14/11/2017 to review the seniority lists of Office Assistants and Senior Clerks in the light of different complaints submitted by the officials of the department.

BACKGROUNDS OF THE CASES

OFFICE ASSISTANTS

The committee has scrutinized and evaluated all the relevant records, P/Files, Seniority lists and other materials connected with case has observed that the office assistants at S.No 11, 28, 29, 30, 31, 32, 33, 34, 58, 84, 85, 86, 87, 88, 89, 90, 91, 104, 105, 106 (Copy of seniority list at Annex-A) were promoted from senior clerk to office assistants by the District Local Government and usurped the right of other officials of the health department/Directorate by placing them in the seniority list of office assistants Provincial Health cadre from the date of promotion in the District Local Govt by ignoring the rules of 'Fixation of Seniority' of Civil servant Act 1973 para 6 (a, b, c, d) (copy attached Annex-B) which is reproduced below:-

"The inter-se seniority of the surplus employees after their adjustment in various departments will be determined according to the following principles;

- (a) In case a surplus employee could be adjusted in the respective cadre of his parent department he shall regain his original seniority in that cadre
- (b) In case, however, he is adjusted in his respective cadre but in a department other than his parent department, he shall be placed at the bottom of seniority list.
- (c) In case of his adjustment against a post in a corresponding basic pay scale with different designation/nomenclature of the post, either in his parent Department or in any other Department he will be placed at the bottom of the seniority list.
- (d) In case of adjustment against a post lower than his original scale, he shall be placed at the top of seniority list of that cadre, so as to save him from being rendered surplus again & becoming junior to his juniors.

The Provincial Assembly KPK vide their Notification No. PA/Khyber Pakhtunkhwa/Bills/2012/20753 dated 15.05.2012 has notified the Khyber Pakhtunkhwa

Local Government Act, 2012 (Khyber Pakhtunkhwa Act No. VIII of 2012), by virtue of which the Khyber Pakhtunkhwa Local Government Ordinance, 2001 (Khyber Pakhtunkhwa Order No. XIV of 2001) shall be repealed and all local governments created under the said law shall stand dissolved.

So the seniority of the officials of dissolved local Govt is required to be fixed from the date of dissolution of District Government i.e. 15.05.2012 in accordance with laid down rules vide para-06 (a,b,c,d) mentioned above in the Provincial Health Directorate cadre.

#### SENIOR CLERKS

There is similar position as narrated above in the seniority list of senior clerks. However record of few officials is incomplete. The officials at S.No. 59, 60, 62, 63, 65, 67, 69, 70, 118, 119, & 125, (Copy of seniority list attached Annex-C) were promoted from Junior Clerks to Senior Clerks by the District Govt and needs to be incorporated in the seniority of senior clerks from the date of dissolution of District Government i.e. 15.05.2012.

#### COMPUTER OPERATORS

For preparation of seniority list of computer operators, all sub-offices have been asked to furnish their bio-data which are still awaited. As and when the information are completed their seniority list will be prepared.

#### STATISTICAL ASSISTANTS

The case of the Statistical Assistants is in court of law, therefore till final decision of the court, the issue is required to be kept pending.

#### SUPERINTENDENTS

The seniority list of the Superintendents is correct and no action is required.

#### CONCLUSION

It is concluded that the contents of appeal of the officials of the Health Directorate is based on facts and needs to be considered and the officials promoted by District Government may be included in seniority list after the date of dissolution of District Governments and rejoining w.e. from 15.05.2012 because they were promoted by District Govt and included in the District cadre before dissolution of District Govt in the light of above rules. It is cleared that the surplus staff of District Government may be placed in the seniority lists at bottom i.e. from the date of their absorption from District Government Cadre to Provincial Health Directorate cadre of the Office Assistants/Senior Clerks. As the

Amendment made in the NWFP Civil Servants (appointment, promotion and transfer rules 1989) (copy attached Annex-D) which is reproduced below:-

In rule 17, after sub rule (2), the following new sub rule shall be added namely:-

(3) in the event of merger/restructuring of the Departments/Attached Departments or Subordinate Offices, the inter se seniority shall be determined in accordance with the date of their regular appointment to a cadre or post' does not applicable in this case as no merger/restructuring in the sub offices and Provincial Health Directorate has been taken place but they became surplus after dissolution of district governments.

It is also pertinent to mention here that in a similar case, the Govt has given its decision vide letter No. SO/III/8-89/2011(SL/jr. Clerk) dated 23/07/2012(copy attached Annex-E).

#### OTHER POINT

The seniority list of Junior clerks DGHS cadre was also discussed and it was recommended that this should also be decided on the above analogy of Senior Clerks and Office Assistants and fixation of seniority rules.

#### RECOMMENDATIONS

- 1) In the light of above, the committee recommended that the seniority lists of Office Assistants may be reviewed in accordance with rules mentioned above and the officials promoted in the District local government be placed in the seniority lists from the date of dissolution of the district local government i.e, from 15/5/2012..
- 2) Similarly the seniority list of senior clerks is required to be corrected.
- 3) The seniority list of Computer Operators is required to be prepared in due course of time.
- 4) The case of statistical assistants be kept pending till final decision of the court.

The report is submitted to DGHS KPK Peshawar for perusal and approval please.

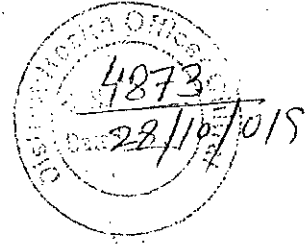

3. As per provisional seniority list of senior clerks issued vide your letter No. 8206-8306/personnel/promotion, dated 21.12.2016, I stood at S.No. 59. Copy of seniority list attached as Annex-D
4. It is pertinent to mention here that 39 Nos senior clerks were promoted to Office Assistant BS-16 during 2018 vide your office order bearing No. 440-49/personnel/promotion cell, dated 04.01.2018. 

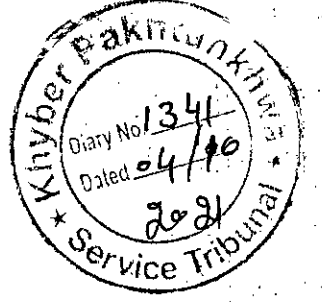
