Appellant alongwith his counsel present. Preliminary arguments heard.

Learned counsel for the appellant has contended that the appellant is serving as Revenue Patwari (BPS-09) in Revenue Department, who was transferred from Moza Namal to Dodhial Malkal vide order dated 15.11.2019; that vide order dated 26.11.2019, the appellant was transferred to Halqa Sachan Kalan District Mansehra and just after 30 days, he was again transferred and posted at Moza Chikiya vide order 27.12.2019; that vide order dated 06.05.2021, the appellant was transferred from Patwar Halqa Khushala to Patwar Halqa Jallu and vide order dated 04.02.2022, the appellant was again transferred and posted at Patwar Halqa Battal; that vide the impugned order dated 28.10.2022, the appellant was again transferred from Mouza Battal to Mouza Jallu, which was challenged by the appellant through filing of departmental appeal, however the same was declined in a cursory manner without giving any cogent reasons; that the appellant has been made a rolling stone for the last about 03 years by transferring him from one place to another without completion of his normal tenure as prescribed in Posting/Transfer Policy of the Provincial Government; that frequent transfers of the appellant has caused him extreme inconvenience and has adversely affected his efficiency; that the impugned transfer order of the appellant has not been made in public interest, rather the same has been made on the basis of political interference.

Points raised need consideration, hence the appeal in hand is admitted to regular hearing subject to all legal and valid objections. The appellant is directed to deposit security and process fee within 10 days. Out district respondents be summoned through TCS, the expenses of which be deposited
