

It has been found that LHW Rubina has always found a constant and deliberate poor performer as well as non resident for her allocated catchment area where she was and is supposed to deliver her services, currently her status is still Non Resident due to her marriage and she has left her area from March 2019 till date, therefore, her termination on account of Poor Performance and Non Resident Status that has been followed by all the codal formalities must be retained, therefore, office order No 12538-43/PF dated 29-11-2019 (Annex-VII above) that pertains to cancellation of her termination may be withdrawn and Office order No 12309-14/PF dated 27-11-2019 (Annex-VI above) regarding her termination may be implemented.


