**PRAYER**

On acceptance of the instant Service Appeal the illegal acts of deduction of amount from the pensionary benefits of the appellant by the respondents and not to release the full pension and accrued arrears of pensionary benefits and increments may kindly be set aside and declared as illegal, void ab intio being without lawful authority and the respondents be released the full pensionary benefits without any deduction and also release the remaining arrears including increments for which the appellant is entitled and also against the non-action of the appellate authority on the departmental appeal meaning thereby rejection qua the departmental appeal within stipulated period.

Respectfully Sheweth:-

The Appellant most respectfully submits as under:-

**BRIEF FACTS:**

1. That the appellant was appointed as Chowkidar/Class IV employee on 07/09/1981 in the Health Department District Tank and was retired on 12/12/2018 from his service w.e.f. 04/09/2017 vide office order No. 5804-9. Copies of the service book and retirement letter dated 12/12/2018 are annexed as **Annexure-A & B.**
2. That the appellant performed his duties to the entire satisfaction of his superiors from the date of appointment i.e. 07/09/1981 till 12/12/2018.
3. That thereafter the respondents released the pensionary benefits of the appellant with deduction and by not releasing the remaining arrears including increments, hence, the appellant aggrieved and submitted various oral requests by himself and through immediate boss and higher authorities and lastly preferred a departmental appeal/representation on 03/10/2020 to the respondent#2 being appellate authority, which was not accepted/decided within stipulated period. Copies of the departmental appeal along with postal receipts are annexed herewith as **Annexure-C.**
4. That the appellant being aggrieved, the instant service appeal is being filed, inter alia, on the following grounds.

**GROUND:**


- a. That the impugned acts i.e. illegal deduction from the pensionary benefits, non-releasing of pensionary benefits and arrears including increments are against law, facts, natural justice, void ab initio, hence, liable to be set aside.
- b. That actually the appellant performed duties till 12/12/2018 and as per service rules and policy and as per verdicts of superior courts the appellant is rightful of his salaries/remuneration (اجرت) because the monthly salary has been paid against duty.

- c. That the appellant served the department for 37 years and now the appellant is suffering from poor health due to performance of duties in his whole life in the Health Department, hence, appellant is entitled for the whole pensionary benefits and arrears.
- d. That counsel for appellant may kindly be allowed to raise additional grounds at the time of arguments.

**It is therefore, humbly prayed that on acceptance of the instant Service Appeal the illegal acts of deduction of amount from the pensionary benefits of the appellant by the respondents and not to release the full pension and accrued arrears of pensionary benefits and increments may kindly be set aside and declared as illegal, void ab intio being without lawful authority and the respondents be released the full pensionary benefits without any deduction and also release the remaining arrears including increments for which the appellant is entitled and also against the non-action of the appellate authority on the departmental appeal meaning thereby rejection qua the departmental appeal within stipulated period.**



The leave on average pay under the ordinary leave rules on the date will be noted in column 7 up to the maximum limits of 4/2 months and the balance in column 8. The maximum amount of leave on average pay against column 7 to 9 each or altogether. Combined with leave on half average pay against column 9 that can be taken it one time will be one year i.e. (4th months on average pay and 8 months on 12 average pay). But supported any medical certificate it can be extended to two years i.e. (6th months on average pay and 11 year of half average pay).

(III) When a Government servant returns from leave column 10 to 20 should be filled in the period of leave on average pay taken against the maximum limit of 4/2 months should be entered in column 11 and that taken on Medical certificate or for pilgrimage, Education, Rest and recreation on side Pakistan, Ceylon, Burma and India should be entered in column 12. The leave on average pay taken on Medical certificate by conversion of leave on half average pay should be entered in column 13 (a) and its double in column 13 (b) will maximum of 12/6 months worked up to in terms of average pay leave on half average pay should be entered in column 15 and total column 13 (b) plus 15-16 noted in column 17.

(IV) If the leave taken on half average pay exceed. The amount of such leave at credit the excess should be shown in red ink column 17 and 20. When a Government servant returns from leave which was not due to leave shall become due to him until he earns leave equal to the period of leave which he took before he was due leave not due can be taken up to maximum of 12/3 months as the case may be in the whole service under rules 5 of the Leave Rules 1955.

(V) Sick leave, maternity leave, hospital leave, extraordinary leave and quarantine leave should be noted in column 21.

**RESPECTFULLY SHEWETH:**

1. That the appeal is not maintainable and incompetent in the eye of law.
2. That the appellant is estopped due to his own conduct to file this appeal.
3. That the appellant has got no cause of action and locus standi to file instant appeal.
4. That the appellant does not come to this Tribunal with clean hands and has suppressed all relevant facts.
5. That the appeal is bad for misjoinder/non-joinder of necessary parties.
6. That the appeal is badly time barred and the appellant has concealed the material facts from Honorable Tribunal.
7. That the Honorable Service Tribunal has no jurisdiction to entertain the instant appeal in its present form.
8. That the appeal has been mis-oriented, mis-constructed and mistakenly drawn and is incompetent in its present form and context, and is liable to reject.
9. That the appeal is weak having no force, fabricated, fictitious, based on ill, will, malafide and having no footings in the eye of law.
10. That the proceeding with instant appeal would be a futile exercise and just wastage of the precious time of this Honorable Tribunal.

11. That as stated in the objection supra, the appeal is bereft of cause of action and is liable to dismissal.

**ON FACTS:**


1. This Para pertains to record but it is pertinent to mentioned here that the appellant was actually retired from Govt. service on 06.09.2017 according to calculated figures of District Accounts Officer, Tank according to Service Book. Copy of which is attached herewith.
2. Incorrect. The appellant actually retired from Govt. Service on 06.09.2017 as stated above but the date of retirement i.e 12.12.2018 as written by the appellant is just issue date of Office Order of retirement of appellant and not the date of retirement.
3. Incorrect. Denied. According to Service Book at the time of appointment of appellant the actual age figured as 24 years on 05.09.1981 reflects from the first page of copy of service book while 36 yeas total qualifying service on his back, hence the actual date of retirement is 06.09.2017 and not 12.12.2018. The deduction of pensionery benefits does not relate to the answering respondents No.1 to 3.
4. That this Tribunal has no jurisdiction to entertain the present appeal in the present form.

**ON GROUNDS**

- a. This Para does not relates with the matter of answering respondents No.1 to 3.
- b. This Para is incorrect. The appellant willfully presented himself without any permission or office order of superiors to perform duty after retirement till 12.12.2018, hence denied.
- c. This Para pertains to record, hence, no reply.

- d. Incorrect. The Counsel for the respondents may be allowed to raise further grounds at the time of arguments.


