SERVICE APPEAL UNDER SECTION 4 OF KPK SERVICE TRIBUNAL ACT 1974

Prayer:-

On acceptance of instant Service appeal this honorable Tribunal may be pleased to pass Judgment by declaring that seniority list of Drawing Master issued on 13-11-2020 being wrong, void and incorrect and is to be rectified by correcting the date of appointments of respondents 4 to 18 and appellant is to be promoted on the post of senior Drawing Master (BPS-16) like respondents 4 to 13 in the interest of justice.

Respectfully Sir,

- 1. That appellant had filed writ Petition No. 133/2005 in Peshawar High Court Bench Dera Ismail Khan titled Muhammad Saleem and Qamar Gul V/S Govt of Khyber Pakhtunkhwa and other against illegal and unlawful appointments of Drawing Masters in NOV 2003 without conducting test and interview and without completion of Codal formalities mentioned in advertisement of NOV 2003 published in Daily KHABRAIN (روزنامہ خبریں). Copy of writ Petition is enclosed and marked as **Annexure A**.
- 2. That Honourable High Court D.I.Khan/ dispose of the ibid writ petition on 16-12-2005 in the following manner:-

"We therefore, direct the official respondents to retain the candidates appointed against the merit quota and fix their seniority at serial No. 4 and 8 on the roster and appoint the eligible candidates on the basis of their seniority in batch/year of obtaining certificates of Drawing Masters and then inter se seniority within the batch/year according to their merit after the result of written test and interview and the services of those who are not falling within the above mentioned formula be terminated with immediate effect from today. We further direct that writ petition of such petitioners, who do not have right to a vacancy/ post according to the above mentioned formula, shall stand dismissed, it is however observed that any appointee, whether he is or is not a party /respondents in this case and who has been appointed against the post of drawing Master on or after 27-12-2003 under the directions of this court or any other court of competent Jurisdiction shall be retained in services and the junior most on the list according to the above formula shall not be appointed or as the case may be retained in service".

Copy of Judgment dated 16-12-2005 is enclosed and marked as **Annexure B.**

3. That there after Honourable High Court constituted legal committee on 07-07-2006 comprising on some senior Advocates and the then EDO Mr. Abdul Rahim Khan to examine and scrutinize the relevant documents as well as illegal/ unlawful appointments of Drawing Masters made by respondents No. 3.
4. That after scrutinization of all unlawful appointments of Drawing Master report was submitted by legal committee and 25 person were appointed by respondents No. 3 vide endorsement No 20976-79 dated 01-08-2006 in which name of appellants is available at serial No. 2. Copy of appointment letter Dated 01-08-2006 is enclosed and marked as **Annexure "C"**.
5. That while preparing and displaying seniority list issued vide endorsement No. 23488-96 dated 13-11-2020 by respondents No. 3 it was observed with great concern that date of appointment of respondents 4 to 18 were wrongly shown in the alleged seniority list with malafide intentions to show them senior which is reproduced as under:-

It thus reveals that date of appointment of respondents No. 4 to 18 are not actual in the alleged seniority list. So due to malafide and fraud they were declared senior from appellant by respondents No. 3 where as apparently they are at par with him. Copy of Seniority list issued on 13-11-2020 is enclosed and marked as Annexure D.

6. That thereafter some respondents 4 to 13 were promoted to the post of senior Drawing Master (BPS-16) vide endorsement No. 7058-75/AE-II/Promotion dated 13-03-2019 and 342-47/AE-II/SEM/promotion dated 07-01-2021 on the basis of wrong date of appointments, mentioned in the alleged seniority list. "it is necessary to mention that their services were terminatable in the light of decision given by Honourable High Court in his Judgment dated 16-12-2005 as they has misconceived the facts and wrong baseless information were provided at the time of their selection without test and interview." However it can easily be assessed from supra 5 of the instant appeal that appellant's date of appointment of appellant is the same (01-08-2006) as that of respondents 4 to 8 but the same were changed altered with malafide intention by respondents No. 3 for illegal gain.

Copy of promotion letters dated 13-03-2019 and 07-01-2021 are enclosed and marked as Annexure E and F.

7. That being aggrieved from the alleged seniority list dated 13-11-2020 in respect of Drawing Masters and promoting respondents No. 4 to 13 on 13-03-2019 and 07-01-2021 on the basis of alleged seniority list, appellant filed department Appeal dated 30-12-2020 as and when it came into the knowledge of Petitioner about the irregularity and blunder committed by respondent No. 3 in the alleged seniority list and then promoting them illegally and without lawful authority.

Copy of departmental appeal is enclosed and marked as Annexure G.

8. That while not responding to departmental appeal of appellant and also not rectifying/ correcting the allegation in the alleged ibid seniority list within stipulated period of 90 days appellant now approaches this Honourable tribunal through instant service appeal for redressal of his legitimate and illegal rights inter alia in the following Grounds.

GROUND

1. That alleged seniority list dated 30-11-2020 issued by respondents No. 3 is wrong, void and incorrect and appellant has wrongly been shown Junior from respondents 4 to 18, While mentioning incorrect date of appointments of ibid respondents and Official respondents are liable to correct the date of appointments of ibid respondents in the alleged seniority list and appellant is required to be declared at Par.
2. That official respondents to No. 1 to 3 committed further mistake/ blunder when some of the respondents 4 to 13 were promoted to the post of senior Drawing Master BPS-16 on the basis of alleged void seniority list dated 13-11-2021. But appellant being at par with them was dropped for the reasons not known to him.
3. That as per verdict of the judgement dated 16-12-2005 on writ petition No. 138-D/2005 services of the respondents 4 to 18 were terminatable as they were not eligible for appointment on post of Drawing Master as they had not fulfilled the required codal formalities mentioned in the advertisement published on November 2003 in Daily KHABRAIN. The official respondents not only saved their services in malafide manner but their actual date of appointment i.e. 01-08-2006 was altered in the alleged seniority


list dated 13-11-2020 which clearly reveals that respondents 4 to 19 have wrongly and unlawfully declared them senior from appellant by official respondents So as such legal and legitimate rights of appellant have been usurped and he has been deprived with malafide intentions.

4. That petitioner is noble and peace-full citizen of Pakistan and his fundamental rights are secured and guaranteed under the constitution of Islamic Republic of Pakistan 1973 and official respondents are not liable to deprive him from his constitutional and legal rights.
5. That appellant's counsel may be allowed to raise additional grounds during the course of arguments.

In view of submissions made above it is humbly prayed that instant service appeal of the appellant may be accepted as prayed for in the heading of the appeal in the interest of justice.

2. That the respondent No.3, then issued appointment orders of Six candidates in total on 27.12.2003 in which two persons were selected on open merits four candidates on batch-wise. Copy of appointment order dated 27.12.2003 is enclosed as Annexure B.

3. That according to notification dated 15.1.1999 issued by respondent No.11 criteria for the appointments for SET, CT, PET, DM, AT, TT, QARI, Junior Clerk, Lab. Assst. and Learning Co-ordinator. Copy of the same is enclosed as Annexure C.

4. That according to Annexure A, the advertisement and notifications Annexure C, the appointments have to be made on open merit 25 %, while 75 % were announced to be made batch-wise merit.

5. That the respondent No.3 issued appointment letters of respondents No.4 to 9 in different dates completely ignoring the criteria given by the respondent No.1. Copies of the appointment letters are enclosed as Annexures D, D-1 to D-3 respectively.

6. That some of the appointments were made even up to date of filing of the petition.

7. That the petitioner No.1 has passed his D.M in the year 1995-96 whereas his qualifications is M.A. and D.M while Petitioner No.2 has passed his D.M in the year 2000-01 whose qualification is M.A. Copies of their Educational Qualifications are enclosed herewith as Annexure E1 to E-4

8. That the petitioners applied for attested copies of merit's list appointment orders made on different dates of D.M, but respondent No.3 plainly refused to provide attested copies rather

9. That feeling aggrieved and having no other remedy the petitioner seeks the indulgence of this Honourable Court in the matter in its extra ordinary jurisdiction on inter alia the following grounds.

GROUNDS.

1. That the respondents Nos. 1 to 3 are clearly violating the criteria provided for the appointment of D.M. rather their mala fide intentions are evident from the orders made subsequent to 27.12.2003 in which originally 6 persons were appointed, which according to the knowledge of the petitioners, were made on merits but subsequent orders are based on no merit and even the respondent did not care about the passing of D.M. of the respondent NO 4 to 9 and the rest of the appointee, in which respect the petitioners have not been provided any copies, particularly respondent:

2. That the malafide and discrimination on the part of respondent No.3 is much evident as per knowledge of the petitioners that almost 10 appointment have been made after 27.12.2003 in different dates completely ignoring and violating the criteria provided for the appointments. As mentioned above, rest of the appointment made by respondent No.3 have been kept secret and the order so made have not been public and the petitioners have been refused to provide the copies of the same. Not even this the appointment of respondent No.4 to 9 have been obtained by the petitioners through their own sources as the respondent No.3 refused to provide attested copies of the same.

3. The malafide on the part of respondent No.3 is much evident from the advertisement Annex-A wherein no number of the vacancies have been mentioned and he is obliging and accommodating the person of his own choice as well as

nominated by the political figures of D.I.Khan. Whereas according to the rules and regulations, the respondent No.3 should have pointed out the vacancies in the advertisement because the public service commission (N.W.F.P) used to specify the number of vacancies wherever required.

4. That the respondent NO.1 to 3 have violated the rules and regulation for the appointments of D.M and therefore, they have misused their official capacity which according to law they were not supposed to do. Moreover, the petitioners have been discriminated despite the fact that they are on merit as well as batch-wise/Year-wise much superior from that of respondents No 4 to 9 and others in respect of whom the petitioners have not been provided information by the respondent No.1 to 3.

5. That according to the policy of the Govt. after the test and interview the vacancies lying vacant should be fill within six months in the available suitable candidates and thereafter fresh test and interview for any vacant post is required under the rules, but the official respondents in clear violation of the above mentioned policy made appointments even till date i.e. after expiry of one year.

6. That Petitioner No.1 applied for the same post in the year 2002 and he was placed at serial No.11 in the merit list when 10 candidates were appointed vide order dated 8.11.2002. Copy of the order dated 8.11.2002 is enclosed as Annexure-G.

7. That according to letter dated 4.3.2003 from respondent No.3 addressed to respondent No.2, it is evident that appointments made on 8.11.2002 in respect of 10 candidates, wherein petitioner No.1 was placed on serial No.11 in the merit list and appointee at serial No.10 namely ~~Farooq Khalid~~ ^{Azizur Rahman} did not join the service and request was made to appoint petitioner No.1 being next to the said Farooq Khalid, but no positive reply was intimated. Copy of letter dated 4.3.2003 is enclosed as Annexure-H.

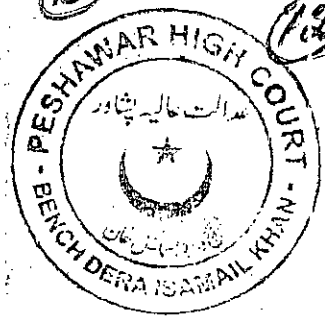

SALIM KHAN, J.- The writ petitions pertaining to the posts of Drawing Masters in District D.I.Khan, pending for disposal today, have common facts and legal issues. These petitions are taken up together for arguments, consideration and decision together. These are as under:-

2. We heard the arguments and perused the available record as well as the related record of the office of Executive District Officer, Schools and literacy, D.I.Khan, respondent No.2. The advertisement was published on 5-11-2003 and applications were submitted within

prescribed period upto 20-11-2003. The number of vacancies was not shown in the advertisement dated 5-11-2003, published in the daily 'Khabrain', Peshawar. Seventy five per cent vacancies of Drawing Masters were to be filled on batch-wise/year-wise basis while twenty five per cent vacancies were to be filled on general open merit basis and two per cent vacancies were to be reserved for disabled candidates. Six candidates were appointed vide order dated 27-12-2003 while further four candidates were appointed vide order dated 31-1-2004. Initially eight vacancies were available, and two further vacancies became available, thus making the total number of available vacancies as ten.

3. In the light of the record, only those candidates could be appointed who had submitted applications upto 20-11-2003 and the candidates who had submitted application after the said date were not entitled to be called for test and interview and were not eligible to be appointed against the said vacancies. Making the cycle of four vacancies each, three candidates, who had applied within the prescribed period and who were qualified and eligible, were to be appointed on the basis of their seniority of batch/year of obtaining certificates, and the fourth vacancy was to be given to the merit quota. Three cycles were to be made for ten vacancies and candidates selected against the merit quota were to be placed at serial Nos.4 and 8 of the roster of vacancies. All the other candidates, who had applied in time, and were eligible, had passed the screening test, and had appeared for written test and interview, were to be appointed on the basis of their seniority in batch/year of obtaining certificates, and on their merits within the same batch/year on the basis of marks obtained

them. The respondents committed that the whole list of the petitioners, respondents, and all other candidates who had applied in time, shall be re-checked and the candidates shall be appointed on merits and in accordance with formula as detailed above.

4. All the other candidates who had either not applied for the vacancies in time, or were not entitled to be appointed in accordance with the mentioned formula, had to lose the said vacancies/posts. The respondents amongst such candidates who had not applied, or were not entitled, as above, shall have no right to the appointment in contravention of the above mentioned formula/rules and shall have to lose their services.

5. We, therefore, direct the official respondents to retain the candidates appointed against the merit quota and fix their seniority at serial Nos.4 and 8 on the roster, and appoint the eligible candidates on the basis of their seniority in batch/ year of obtaining certificates of Drawing Masters and their inter se seniority with the batch/year according to their merit after the result of written test and interview, and the services of those who are not falling within the above mentioned formula be terminated with immediate effect from today. We further direct that the writ petitions of such petitioners, who do not have a right to a vacancy/post according to the above mentioned formula shall stand dismissed. It is, however, observed that any appointee, whether he is or is not a party/respondent in this case, and who has been appointed against the post of Drawing Master on or after 27-12-2003 under the directions of this Court or any other Court of competent jurisdiction shall be retained in service and the junior
