Mr. Muhammad Anwar Awan, Advocate, for the appellant present. Preliminary arguments heard.

Learned counsel for the appellant has contended that the appellant being Subject Specialist is working as Headmaster in the same cadre but vide notification dated 24.08.2021, the respondents are treating Subject Specialist and Headmaster as different cadres. He further contended that on the strength of the impugned notification dated 24.08.2021, the appellant has been directed to apply for E-Posting being posted at wrong cadre, which stance of the respondents is not in accordance with law and is based on malafide. He further contended that vide impugned notification dated 24.08.2021, Senior Subject Specialists as well as Principals/Vice Principals have been excluded from E-Posting, which is discriminatory.

Points raised need consideration, hence the appeal is admitted to regular hearing subject to all legal and valid objections. The appellant is directed to deposit security and process fee within 10 days, where-after notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, the office shall submit the file with a report of non-compliance. File to come up for arguments before the D.B on 27.10.2021 at Camp Court D.I.Khan.

The appeal is also accompanied by an application for suspension of the impugned notification dated 24.08.2021. Notice of the same also be issued to the respondents for the date fixed.



TEACHING CADRE AT WRONG POSTS.**

That the brief facts of the case are as under:

1. That the Appellant is appointed as SST and thereafter promoted at the post of Subject Specialist (BS-17) by promotion order Dated; 17-03-2016. Copy of order Dated; 17-03-2016 is Annexure A.
2. That the petitioner was posted as Head Master (BS-17) at Government High School Launda Sharif D.I.Khan vide order Dated; 12-02-2019. The Appellant is still performing his duties as Head Master. Copy of Office Order Dated; 12-02-2019 is Annexure B.
3. That Respondent No. 1 vide notification Dated; 24-08-2021 regarding E-Transfer of Teaching Cadre posted at wrong cadres. The Appellant being Subject Specialist working as Head Master in same cadre, but respondents treating subject Specialist and Head Master at different cadres, directing the Appellant to apply for E-Posting being posted at wrong cadre. Copy of Notification Dated; 24-08-2021 is Annexure C.
4. That feeling aggrieved from notification Dated; 24-08-2021, the appellant file departmental Appeal Dated; 01-09-2021 which was refused by directing the appellant

to apply for E-Posting on 14-09-2021. Copy of Departmental Appeal and postal receipts is annexure D.

5. That feeling aggrieved from above said office orders, petitioner is constrained to approaches this honorable court on the following amongst other:

GROUND:


1. That the appellants are not treated in accordance with law and notification Dated; 24-08-2021 of the respondents are malafide besides being discriminatory and harsh.
2. That the Subject Specialist and Head Master have same cadre and there is seniority list prepared by the Department is one and the same. The Subject Specialist and Head Master are promoted as principal with same seniority list but through impugned notification dated; 24-08-2021 they are treating Subject Specialist and Head Master being different cadres which is totally against the law and rules. Copy of Seniority List is Annexure E.
3. That it is also worth mentioning that through impugned notification, the secretary Elementary and secondary Education has exempted the Principal/vice Principal and senior Subject Specialist from E- Posting which also affirm the Plea of Appellant so the Department is saying cold and hot from the same breath.
4. It is also astonishing fact that in near past the Department itself some of Subject Specialist were permanently posted against the post Head Master.

In view of the above, It is, therefore, most respectfully prayed that on acceptance this appeal this honorable court may pleased to declare that



- 2- That Appellant has good prima facie case and balance of convenience also tilts in favor of Appellant.

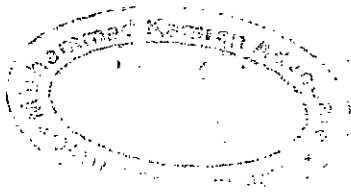

The Subject specialist and Head master have same cadre and their seniority list prepared by the department is same. It is also worth mentioning that Subject specialist and head master are promoted with same seniority list to the post of Principal. Now the department in the light of order dated: 24.08.2021 disturb/posting the appellant against any other post treating the appellant posted at wrong cadre which is totally illegal. It is also worth mentioning that secretary Elementary and Secondary Education has exempted the Principal/ Vice- Principal and Senior Subject Specialist from E-posting which also affirm the plea of Appellant that principal and Senior Subject Specialist are one and the same cadre so the Department is saying cold and hot from same breath.

It is, therefore, requested that may kindly accept the appeal plaintiff the appellant and the posting of appellant may not be disturbed due to office order dated: 24.08.2021





