That the brief facts of the case are as under:

1. That the Appellant is appointed as Subject Specialist (BS-17) vide order Dated; 02-02-2020. Copy of order Dated; 02-02-2020 is Annexure A.
2. That the petitioner was posted as Head Master (BS-17) at Government High School Moosa Khel Jani Khel Bannu vide order Dated; 04-09-2020. The Appellant is still performing his duties as Head Master. Copy of Office Order Dated; 04-09-2020 is Annexure B.
3. That Respondent No. 1 vide notification Dated; 24-08-2021 regarding E-Transfer of Teaching Cadre posted at wrong cadres. The Appellant being Subject Specialist working as Head Master in same cadre, but respondents treating subject Specialist and Head Master at different cadres, directing the Appellant to apply for E-Posting being posted at wrong cadre. Copy of Notification Dated; 24-08-2021 is Annexure C.
4. That feeling aggrieved from notification Dated; 24-08-2021, the appellant file departmental Appeal Dated; 01-09-2021 which was refused by directing the appellant

to apply for E-Posting on 14-09-2021. Copy of Departmental Appeal and postal receipts is annexure D.

- 5. That feeling aggrieved from above said office orders, petitioner is constrained to approaches this honorable court on the following amongst other:

GROUNDS;

1. That the appellants are not treated in accordance with law and notification Dated; 24-08-2021 of the respondents are malafide besides being discriminatory and harsh.
2. That the Subject Specialist and Head Master have same cadre and there is seniority list prepared by the Department is one and the same. The Subject Specialist and Head Master are promoted as principal with same seniority list but through impugned notification dated; 24-08- 2021 they are treating Subject Specialist and Head Master being different cadres which is totally against the law and rules. Copy of Seniority List is Annexure E.
3. That it is also worth mentioning that trough impugn notification, the secretary Elementary and secondary Education has exempted the Principal/vice Principal and senior Subject Specialist from E- Posting which also affirm the Plea of Appellant so the Department is saying cold and hot from the same breath.
4. It is also astonishing fact that in near past the Department itself some of Subject Specialist were permanently posted against the post Head Master.

Annexure

In view of the above, It is, therefore, most respectfully prayed that on acceptance this appeal this honorable court may pleased to declare that the Notification Dated ;24-08-2021 to the extent of Subject Specialist and Head Master being void, illegal, without lawful authority and of no legal effect. It is further prayed that alternately the post of Appellant being permanently treated/Posted as Head Master as per rules.
